## **PROGRAM OVERVIEW**

- Program will allow Divisions I, II and III conferences to access the background check reports of officials who granted the NCAA permission to conduct the background check through the ArbiterSports Central Hub.
- Program is in addition to the Division I regular season officials background check program for FBS football and men's and women's basketball that includes a credit check (managed by Sterling Volunteers).

- Program will include all sports with a Central Hub on ArbiterSports.
  - Baseball
  - Men's Basketball
  - Women's Basketball
  - Bowling
  - Field Hockey
  - Football
  - Ice Hockey (m/w)

- Men's Lacrosse
- Women's Lacrosse
- Soccer (m/w)
- Softball
- Women's Volleyball
- Water Polo (m/w)
- Wrestling

- Program will NOT include sports that do not have a Central Hub on ArbiterSports.
  - Cross Country (m/w)
  - Fencing
  - Gymnastics (m/w)
  - Rifle
  - Skiing
  - Swimming and Diving (m/w)
  - Indoor Track and Field (m/w)

- Golf (m/w)
- Rowing
- Tennis (m/w)
- Outdoor Track and Field (m/w)
- Beach Volleyball
- Men's Volleyball

• Long-term plan is to include these sports, but not in 2019-20.

- Background check reports will include all criminal offenses (e.g. misdemeanors, felonies) reportable by the jurisdiction.
- Officials will be asked to designate a conference(s) that NCAA has permission to share report with.
- NCAA will use the results of the background check report to assist in the selection of officials for NCAA championships.

- An official will be automatically eliminated from working NCAA championships if:
  - The official does not grant permission for the NCAA to conduct a background check.
  - The official has been convicted of a felony within the past seven (7) years,
  - The official is listed on a national or state sex offender registry, and
- At the NCAA's discretion, background checks with a record outside of the criteria above will be reviewed.



- It is suggested that conferences develop their own policy for reviewing and handling background check reports.
- NCAA will have no role in deciding whether or how a conference chooses to use the reports.
- Cost of the background check is included in the official's registration.

## **ARBITER ACCOUNT ACCESS**

- Conferences must designate the specific user(s) who will have access to the background check reports for each sport.
- Contact Dave Yeast at ArbiterSports to designate conference users.

## **ARBITERSPORTS FUNCTIONALITY**

- Access to background check reports is currently available for individuals designated on the conference account(s).
- Background checks will be processed daily following the Central Hub's opening date.
- Conferences should create filters to review background reports with issues.
- The Fair Credit Reporting Act (FCRA) is the federal law that covers the background check process.
- Conferences will need to provide pre-adverse letter to officials they determine ineligible to officiate based on the results of the background check.
