2. Division I Notification of Transfer Window. The oversight committee reviewed and discussed a draft notification of transfer window concept developed by the American Baseball Coaches Association (ABCA) and requested an update from staff on the 2026 baseball notification of transfer window data at a future meeting. The ABCA will solicit greater stakeholder feedback from Division I head baseball coaches.

3. Election of chair and vice chair of the Division I Baseball Oversight Committee and Baseball Oversight Committee, Championship Subcommittee.
