



2026 NCAA Division III Baseball Championship Preliminary Round Information and Bid Checklist

Selections

Selections for the 2026 NCAA Division III Baseball Championship will be announced at Noon Eastern time, Monday, May 11 via web stream on ncaa.com.

Preliminary-Round Schedule

Regionals: *Friday, May 15-Sunday, May 17
Super Regionals: Friday, May 22-Saturday, May 23

*Thursday, May 14-Saturday, May 16 for regional sites that include a team with a no-Sunday play policy. All other regional sites must follow a Friday-Sunday format.

Bid Checklist

The following materials must be submitted by institutions that wish to be considered as hosts for preliminary-round competition. All materials are due by **5 p.m. Eastern time, Wednesday, May 6.** **NOTE:** It is not a requirement that sites be selected to compete in the championship in order to host. Institutions that do not qualify for the regional and super regional rounds will not be responsible to host.

***NOTE: The DIII Baseball Committee reserves the right to select an alternate host site if any prospective facility prohibits metal spikes on the turf field or pitching mound.**

In addition to the submission of your institution's certificate of insurance, each of the online forms listed below may be accessed and submitted through the championships host portal at <https://championships.ncaa.org>.

To begin the process of submitting a bid, you will need to locate the specific divisional sport and round in the Championships Available for Bidding section and click on Start Bid.

_____ **Proposed Budget(s)**. An online proposed budget must be completed for **each** round of competition you wish to host. For those institutions submitting bids for multiple rounds, a 'copy' function is available in the system and will allow you to copy the budget for another round. The appropriate round and date of competition must be indicated on each budget. Please be sure to include projected ticket sales in the Receipts section.

_____ Please carefully review the [NCAA Division III Baseball Pre-Championship Manual](#) prior to submitting a proposed budget and make note of the following for all preliminary-round competition:

- Hosts of non-predetermined preliminary-round sites will not receive an honorarium. NCAA staff will override the honorarium listed on the financial report.

- **Per diem for hosts of non-predetermined preliminary-round sites will be reinstated at a rate of \$50; consult the [2025-26 travel policies](#) for further detail.**
- All lodging expenses for officials and site representatives (if needed) must be included in your proposed budget. Do not include fees, per diem and travel expenses for umpires. These expenses will be paid by the NCAA through RefQuest+. The NCAA will pay per diem and travel expenses for site representatives directly.
- Do not budget for baseballs. The NCAA will ship Rawlings baseballs to each regional and super regional site.

Facility Profile. An online facility profile must be completed and/or maintained as necessary by each institution interested in hosting preliminary-round competition. Information regarding video board, LED board and/or ribbon boards should be entered via the “Boards/Control Room” tab of the applicable venue profile. Lighting above the playing surface (for Night Play) is preferred. See schedule in pre-championship manual for adjusted times.

A facility profile can be maintained and updated on a regular basis. If a facility can host multiple sports, check the appropriate box(es) under the “Sports” tab of the facility profile to provide the information for that facility. Refer to the 2025-26 NCAA Division III Baseball Pre-Championship Manual for facility requirements and site selection procedures.

Key Contacts. The key contacts for your institution should be entered and/or maintained as necessary within your profile. Please enter the information for the key personnel associated with running a championship at your site.

When starting a bid, you will be prompted to enter new key personnel, or edit or confirm your existing key personnel. In addition, you will be asked to designate individuals who should receive the various host shipments (e.g., sport equipment, merchandise, awards, etc.). Please include the proper mailing address for overnight deliveries. P.O. box addresses will not be accepted.

Personnel who will administer the competition also will be listed and can be edited within the Profile section of the Championships Bid and Host portal. When entering individuals in this manner, information must be entered on both the General tab and the Role/Titles by Sport or Facility tab.

Safety and Security Plan. Based on a review of current and future championships competition venues, discussions with safety and security experts, and their own expertise and knowledge, the NCAA has established a Safety and Security Advisory Group (SSAG) to develop a compilation of *Best Practices* for NCAA Championships,

which can be found [here](#). We urge each competition venue to take these *Best Practices* into account when developing its safety and security program.

As part of your bid, **please submit a safety and security plan** for your venue. You must **also submit the NCAA Championships Safety and Security Team contact information form**, located in Appendix A of the *Best Practices* document. These documents should be uploaded in the document section of the facility profile. Both documents can be uploaded under the Safety and Security tab.

Lodging. The host institution/agency shall negotiate a courtesy hold for the participating institutions/student-athlete(s). The selected hotel properties shall be within no more than 30 miles of the competition site and be priced at a fair and reasonable market room rate while remaining sensitive to daily divisional per diem allowances. The selection of a competition site may be dependent on availability and quality of rooms for participating institutions/student-athletes. Negotiating a complimentary meeting room and a complimentary hot breakfast is preferred. A letter of intent template is provided by the NCAA for the host to use to confirm the hold with the hotel(s). Please upload a signed letter of intent into the bid portal.

REGIONAL: The host institution shall hold 16 non-smoking hotel rooms (14 doubles and 2 singles), May 14-17 (May 13-16 for Thursday-Saturday regional sites), for each team that travels to the regional site.

SUPER REGIONAL: The host institution shall hold 16 non-smoking hotel rooms (14 doubles and 2 singles), Thursday and Friday nights, May 21-22, for the team that travels to the super regional site. The selected hotel property shall be within 30 miles of the competition site. If multiple team hotels are used, they shall offer comparable room rates and amenities. The host institution should make every effort to negotiate a room rate that includes complimentary breakfasts, Internet access and parking for participating institutions/student-athletes. The selection of a host site may be dependent on the availability and quality of lodging in the locale and the room rate.

Liability Insurance. Host institutions must maintain and provide proof of at least \$1 million of general liability insurance on an occurrence form for Bodily Injury and Property Damage, including Products Liability (including completed-operations coverage), coverage for contractual liability, independent contractors, and personal and advertising injury. Coverage cannot exclude liability arising from athletic participation, spectators, alcohol, or food-borne illness. The certificate must be submitted to NCAA prior to competition. State institutions subject to state governing tort laws are permitted to provide proof of limited liability under state laws instead of general liability coverage. (This is the minimum requirement per NCAA bylaws).

If applicable, off-campus venues must also maintain and provide a minimum of \$1 million in general liability insurance on an occurrence form for Bodily Injury and Property Damage, including Products Liability (including completed-operations coverage), coverage for contractual liability, independent contractors, and personal and

advertising injury. Coverage cannot exclude liability arising from athletic participation, spectators, alcohol, or food-borne illness. The NCAA must be named as an additional insured.

All insurance must be provided by an insurance company with an A.M. Best Rating of A-, VII or higher.

Host institutions must provide the national office with the appropriate certificates of insurance or documentation of self-insurance. This information must be provided via the Certificate of Insurance link in the bid portal. As this is a new feature in the portal, all prospective hosts must upload their documentation once. Depending on the coverage, users must subsequently verify their documentation is still valid, or upload a new certificate once the previous version has expired.

Additional Host Information/Resources

Host Operations Manual. The 2025-26 NCAA Division III Baseball Championship Host Operations Manual will assist your institution in all stages of the bidding and hosting process.

Drug Testing. Drug testing may occur at any round of the championship and the assistance of the host institution will be a vital part of the testing. You will be notified in advance if the round you are hosting has been selected for drug testing. Please review the [drug testing site coordinator manual](#) and note that Drug Free Sport, LLC will provide materials to assist in the program.

Americans with Disabilities Act. The Americans with Disabilities Act requires that public establishments offer equal access and services to people who are physically and mentally challenged. The host institution/conference is required to confirm that each facility in which an NCAA championship or ancillary event occurs is in compliance with the Act by the various facilities hosting NCAA championship events. The host institution/conference is responsible for determining if the competition site will be in compliance as of the dates of the championship. If the host institution/conference becomes aware that a competition site hosting an NCAA championship event will not be in compliance, it shall immediately notify the NCAA national office staff member with responsibility for the event in order to discuss the issue.

NCAA Bylaw 31. Please review Bylaw 31 of the NCAA Division III Manual as it contains policies regarding the administration of an NCAA event.
