



**REPORT OF THE
NCAA DIVISION I BASEBALL RULES SUBCOMMITTEE
NOVEMBER 3, 2025, VIDEOCONFERENCE**

ACTION ITEMS.

1. **Legislative items.**
 - **None.**
2. **Nonlegislative items.** The NCAA Division I Baseball Rules Subcommittee approved the following experimental rule request for the 2026 season. The subcommittee requests approval from the Division I Baseball Oversight Committee for the following item:
 - a. **Use of in-game data/technology in the dugout during a game, including preloaded or non-live recorded video.**
 - (1) **Recommendation.** To permit the use of electronic equipment (tablets) to access scouting and analytic information (Note: Access to pitch location [e.g., balls/strikes] will not be accessible during the game). Preloaded or recorded video will not be live and managed by a controlled device management program.
 - (2) **Effective date.** Immediately for conference play only.
 - (3) **Rationale.** The use of detailed stats and analytics to inform in-game decision-making has become prevalent in college baseball. At the same time, advancements in technology have made immediate and ready access to such real-time information much more accessible. Other sports have recently adjusted playing rules to permit members of the coaching staff to utilize approved electronic devices to acquire real-time information for use in in-game decision-making, and the use of preloaded or non-live recorded video for educational and scouting purposes.
 - (4) **Estimated budget impact.** Varies depending on type of equipment used.
 - (5) **Student-athlete impact.** None.

INFORMATIONAL ITEMS.

- 1. Welcome and announcements.** The members in attendance were welcomed and thanked for their time.
- 2. Approval of October 6, 2025, videoconference report.** The subcommittee approved the videoconference report as written.
- 3. Secretary-rules editor report.** The subcommittee received a report from the secretary-rules editor. The report included an update regarding items for the 2026 season which included a discussion on updated rules clarifications and interpretations.
- 4. National coordinators of umpires' reports.** The subcommittee received a report from the national coordinators of umpires. The report included updates regarding the registration progress on RefQuest+, preparation of umpire watchlist and additional updates on national umpire initiatives.
- 5. Experimental rules for 2026 season.** The subcommittee reviewed and considered an additional experimental rule as noted above in the Action Items section of this report for the 2026 season.
- 6. Other business.** The other business included a review of referrals by the Division I Cabinet to modify legislation regarding the use of commercial or nonprofit trademarks or logos on student-athlete uniforms, apparel and equipment; use of commercial or nonprofit logos on playing surfaces; and use of commercial or nonprofit logos on officials' uniforms.
- 7. 2025-26 videoconference timeline.** The next videoconference is scheduled for December 1 at 11 a.m. Eastern time.
- 8. Adjournment.** The subcommittee adjourned at 12:00 p.m. Eastern time.
