INFORMATIONAL ITEMS.

1. **NCAA Division I Women's Basketball Oversight Committee July 13 and August 4 meetings update.** The chair of the Women's Basketball Oversight Committee (WBOC) provided an update on key items from their July 13 and August 4 meetings. Specifically, WBOC updated the timeline for the WBOC's membership survey on the outside of the playing season concept and discussed the timeline for the potential introduction of a legislative proposal that would change the period of time outside the playing season in women's basketball. The WBOC will review membership feedback at its August 24 meeting and determine if additional feedback is necessary.
2. **Out-of-season activities discussion.** The oversight committee continued its discussion on the period of time outside the playing season in Division I men's basketball and reviewed feedback from key stakeholders. The oversight committee will receive an update from WBOC's August 24 meeting, discuss several application questions and consider making modifications to the concept during its August 28 meeting.
3. **NCAA Division I Cabinet update.** The oversight committee received an update on the DI Cabinet's August 3 meeting regarding the introduction of a legislative proposal that would prohibit midyear initial enrollees from competing until the next season.
4. **NCAA Division I Men's Basketball Committee summer meeting report.** The oversight committee received an update from the NCAA Division I Men's Basketball Committee's summer meeting.
5. **NCAA Division I MBOC nominations for September 1 student-athlete vacancies.** The oversight committee appointed two student-athlete members to the committee. Notification to the appointees will follow the established process and rosters will be updated in accordance with the start date for service.
6. **NCAA legal update.** The oversight committee received a legal update on several items impacting Division I men's basketball.
7. **Identification of discussion topics for the upcoming NCAA Division I Men's and Women's Basketball Oversight Committees' joint meeting.** The oversight committee identified topics to be discussed during its next joint meeting.
