



**REPORT OF THE NCAA DIVISION I
WOMEN'S BASKETBALL OVERSIGHT COMMITTEE
AUGUST 4, 2026, VIDEOCONFERENCE**

INFORMATIONAL ITEMS.

1. **Out-Of-Season Activities for Women's Basketball – Summer Access, Foreign Tour, Noninstitutional Outside Competition and Institutional Outside Competition.** The NCAA Division I Women's Basketball Oversight Committee continued its discussion on the out-of-season concepts previously reviewed at its July 13 meeting. Specifically, the oversight committee received an update on the updated timeline for the survey and the development of a potential concept for legislative introduction. The oversight committee will conduct an initial review of the feedback received at its August 24 meeting and determine if additional feedback is necessary. Further, the oversight committee received an update on the ongoing work of the NCAA Division I Men's Basketball Oversight Committee.
2. **NCAA Division I Legislative Update.** The oversight committee received an update on three proposals introduced by the WBOC. Two concepts were approved as expedited legislation at the NCAA Division I Cabinet August 3 meeting. The oversight committee also approved the basketball-specific previously approved waivers and guidelines.
3. **NCAA Division I Women's Basketball Committee Update.** The oversight committee received an update and approved the team replacement policy and the automatic qualifiers for the 2027 Division I championship. The oversight committee will receive an update on the committee's summer meeting on August 24.
4. **Officiating Mechanics Committee Update.** The oversight committee received an update and supported several modifications to the composition of the Mechanics Committee. The oversight committee charged the staff with developing a final draft for its consideration and adoption at its next meeting. Further, the oversight committee at its next meeting will receive nominations for open Division I represented positions on the committee.
5. **Legal Update.** The oversight committee received an update from the NCAA office of legal affairs on current and ongoing legal issues and topics. The oversight committee also received an update on eligibility matters and potential impact on women's basketball.
6. **Women's Basketball Oversight Committee July Meeting Report.** The oversight committee reviewed and approved its July 13 meeting report.
