1. **Development of an Out-of-Season Activities Model for Women's Basketball.** The NCAA Division I Women's Basketball Oversight Committee continued its discussion on the out-of-season activities model for women's basketball. The full WBOC reviewed the proposed model developed by the NCAA Division I Women's Basketball Oversight Committee Administrative Committee, which was tasked to draft concepts for consideration. The WBOC will update the NCAA Division I Men's Basketball Oversight Committee on the proposed model during the joint men's and women's oversight committee on October 5 and will determine if additional vetting is necessary prior to formal legislative introduction.
