



2023-24 Women's Basketball Rules - Survey Results

Methods

- This was a survey of head coaches, directors of athletics, senior woman administrators, conference commissioners, conference coordinator of officials, DI WBB conference administrators and officials. The purpose was to assess the impact of current rules changes, officiating enforcement and future rules considerations.
- The survey was designed to take no more than 10-minutes and was administered online through the QuestionPro
- The survey was open from March 25 to April 14, 2024.
- The survey was distributed via email to coaches, officials, DI WBB administrators and conference coordinators of officials. The survey link was posted to an online survey dashboard webpage designed for athletics directors, senior woman administrators and conference commissioners to provide rules survey feedback during the 2023-24 academic year. A notice about the use of the survey dashboard was included in the NCAA Weekly to all athletics directors and conference commissioners prior to the survey launch. Of the 6,116 possible participants, there were 1201 completed surveys (20 percent response rate).
