**INFORMATIONAL ITEMS.**

1. **Score reporting update.** Eric Breece provided an update to the NCAA Women's Bowling Committee that results are being reported in the schedule and results reporting system. Committee members noted that coaches continue to find the new process user-friendly and will assist in the continued monitoring of submissions. The anticipated software update to score reporting should be available soon.
2. **Protest review.** The committee discussed a recent protest involving the listing of United States Bowling Congress approved bowling balls for use in competition as informational. The committee discussed educational opportunities for coaches on the process of filing a protest, as well as if improvements can be made in the future.
3. **Officials' protocols.** The committee discussed Rule 9, which addresses officials and their duties. The committee noted the importance of having the correct number of officials when conducting a match. The committee will continue discussion on officials' staffing, education and protocols during their April 2026 annual meeting.
4. **Future championships bracket review.** The committee had an initial discussion about future championship formats, given all teams that make the championship will be in one location starting in 2027. They asked staff to provide additional information for review during their annual meeting.
5. **Annual meeting dates.** The committee moved the annual meeting to April 27-28, 2026.
