

## REPORT OF THE NCAA WOMEN'S BOWLING COMMITTEE FEBRUARY 6, 2025, VIDEOCONFERENCE

## KEY ITEMS.

- **1. Committee nominee feedback**. The committee reviewed information related to nominees for committee service and provided feedback on their qualifications.
- **2. C-USA RPI request.** The committee approved a request from Conference USA to receive the RPI report on Monday, March 17, 2025, for the purpose of seeding its women's bowling championship. (See Informational Item 3.)

## INFORMATIONAL ITEMS.

- **1. January 9, 2025, committee report**. The committee approved the report from its meeting on January 9, 2025.
- **2. Committee nominee feedback**. The committee reviewed information related to two nominees for committee service beginning in September of 2025 and provided feedback on their qualifications for committee service.
- 3. C-USA RPI request. The committee discussed and approved a request from Conference USA to receive the RPI report on Monday, March 17, 2025, instead of receiving it on its normal publication date for the week (Tuesday, March 18, 2025), for the purpose of seeding its conference women's bowling championship. The committee requested that the topic of RPI report release timing be an agenda item during its annual meeting.
- **4. Secondary selection criterion.** The committee received an update on its request to the Division I Sports Oversight Committee to add match scores as a secondary selection criterion for at-large selection to the women's bowling championship and for seeding the championship bracket beginning with the 2025-26 academic year.
- **5. Misconduct/late score reporting.** The committee received an update regarding any late score reporting issues from each region.
- **6. Practice ranking.** The committee discussed conducting a practice ranking during the regional advisory committee orientation scheduled for March 5, 2025.

- 7. **Regional site representatives.** The committee discussed previous site representatives at each regional and instructed the championship manager to communicate with those individuals regarding their availability and interest in serving in that role again in 2025.
- **8. Regional advisory committee orientation.** The committee received a reminder about the Regional Advisory Committee orientation scheduled for March 5, 2025, and received an update on the creation of the PowerPoint presentation for the orientation.
- **9. Regionals update.** The committee received information about and discussed various topics related to planning for the 2025 regional championships (e.g., host videoconferences, signage, credentials, participant manuals, budgets, bracket templates, and hotels).
- **10. Finals update.** The committee received information about and discussed various topics related to planning for the 2025 finals in Las Vegas, NV (e.g., community outreach, lighting/videoboard, signage, scorer's table personnel, Van Wagner involvement, RQ+, commemorative bowling pins, credentials, participant manual, banquet and committee travel).
- **11. Future meetings.** The committee reviewed the schedule for future meetings noting specifically the Regional Advisory Committee orientation videoconference on March 5, 2025.
