NCAA DIVISION I MEN'S AND WOMEN'S GOLF OVERSIGHT COMMITTEE  
JANUARY 22, 2026, VIDEOCONFERENCE

**ACTION ITEMS.**

**INFORMATIONAL ITEMS.**

1. **Welcome and roll call.** The committee welcomed all attendees and introduced Rebekah Parkhill, a member of the women's golf championships subcommittee from University of Tulsa, to her first meeting.
2. **Report approval.** The committee approved the Nov. 5 meeting report with no changes.
3. **NCAA Convention update.** The committee received a brief update from the NCAA convention from NCAA staff.
4. **Legislative concepts.** The committee discussed in-season foreign competition legislation and there was general support to eliminate all restrictions moving forward. Committee members will gather additional feedback from additional coaches in advance of the next meeting, at which time a legislative change may be proposed.

In addition, the committee discussed a potential amendment to legislation regarding the first preseason practice date to the third Thursday in August. The committee also discussed a potential amendment to legislation regarding the first competition date to the fourth Thursday in August. The current policy for both first practice and first date of competition is five days before the start of classes or Sept. 1, whichever is earlier.

Both topics will be discussed in-depth prior to the next meeting with potential to propose both for legislation during the committee's next meeting.

The committee also discussed out-of-season foreign tours, but decided more conversation needed to be had before making any recommendations.

5. **Regional awards.** The committee discussed and voiced support to allow regional champion teams to purchase regional championship trophies from the NCAA's awards provider, which were previously provided by the NCAA. NCAA staff was directed to determine feasibility and next steps for possible implementation.
6. **Men's and Women's Golf Oversight Committee 2026 annual meeting dates.** The women's championships subcommittee determined it will hold its annual subcommittee meeting on June 11-12. The men's subcommittee has not confirmed its meeting dates at this point. The committee determined it would like oversight committee meetings prior to and immediately following the subcommittee annual meetings in June to discuss and vote in topics.

7. **Review of GCAA/WGCA National Conventions.** Dustin Roberts gave a review of the Golf Coaches Association of America (GCAA) Convention, and Kari Williams gave a report on happenings at the Women's Golf Coaches Association (WGCA) Convention.
8. **Regular season best practices.** Emily Marron gave an update on the WGCA regular season best practices document and noted that a final document should be coming out shortly.
9. **Men's subcommittee updates.** John Hauscarriague, chair of the men's subcommittee, provided a brief update on current men's subcommittee topics.
10. **Women's subcommittee updates.** Kari Williams, chair of the women's subcommittee, provided a brief update on current women's subcommittee topics.
