



**REPORT OF THE
NCAA DIVISION I MEN'S AND WOMEN'S GOLF OVERSIGHT COMMITTEE
NOVEMBER 5, 2025, VIDEOCONFERENCE**

INFORMATIONAL ITEMS.

1. **Welcome and announcements.** The committee welcomed the student-athletes to their first oversight committee call.
2. **Governance/legislative cycle updates.** The committee received an update on the new legislative cycle and process and was reminded that there are a number of legislative areas that are currently under a separate review, which is anticipated to conclude in early 2026. The committee discussed priorities following the completion of the audit including season start date, foreign tours, and transfer portal window.
3. **Logo placement on uniform.** The committee discussed the potential allowance for commercial logos on team equipment and uniforms. Committee members noted that they are in favor of allowing maximum flexibility within the specified guidelines for logo placement in golf.
4. **GCAA/WGCA National Conventions.** Dustin Roberts and Courtney Trimble provided updates on the upcoming Golf Coaches Association of America (GCAA) and Women's Golf Coaches Association (WGCA) Conventions.
5. **Regular season best practices.** The committee discussed the possible formation of a subcommittee through the GCAA and WGCA to develop a set of guidelines outlining the minimum expectations and best practices for regular season competition. The committee felt there should also be a member from each of the subcommittees on the group.
6. **Oversight Committee 2026 annual meeting dates.** The committee was notified that the 2026 annual meeting will be conducted virtually. Staff and committee members discussed potential dates for the meeting, which will be finalized at a later time.
7. **Request form for accommodations for student-athletes with disabilities.** The committee received an update on the new official process for golf student-athletes with disabilities to request accommodations.
8. **Men's subcommittee updates.** John Hauscarriague, chair of the men's subcommittee, provided a brief update on current men's subcommittee topics.
9. **Women's subcommittee updates.** Kari Williams, chair of the women's subcommittee, provided a brief update on current women's subcommittee topics.
