NCAA DIVISION I MEN'S AND WOMEN'S GOLF OVERSIGHT COMMITTEE
SEPTEMBER 24, 2025, VIDEOCONFERENCE

ACTION ITEMS.

INFORMATIONAL ITEMS.

1. **Men's subcommittee member appointment.** The committee appointed Andrew Danna, head men's golf coach at Florida Gulf Coast University, to the men's subcommittee.
2. **Women's subcommittee member appointment.** The committee appointed Halley Morell, head women's golf coach at Bradley University, to the women's subcommittee.
3. **Oversight committee member chair.** The committee was notified that John Hauscarriague will serve as chair of the oversight committee, given recent direction from the NCAA Division I Transformation Committee regarding incumbent chairs continuing in their role.
4. **Women's regional site.** The committee selected the University of Louisville Golf Club in Simpsonville, Kentucky, and the University of Louisville, to host a 2026 Division I Women's Golf Regional.
5. **Women's selection criteria.** The committee approved the following changes to the women's selection criteria that are listed in priority order: (a) Prioritize adjusted scoring average to the third criterion, behind National Collegiate Golf Ranking and head-to-head results/head-to-head stroke differential; and (b) Add spring trending as a criterion.
6. **Governance update.** The committee received an update from national office staff about the new governance structure and process. The committee reiterated that it had interest in discussing possible legislative changes regarding the one-in-four foreign competition rule, adopting a universal start date and the current rules regarding the number of participants that can compete in an event relative to sport sponsorship and allowable team dates of competition.
7. **Conflict of interest statements.** The committee was reminded to submit their conflict of interest forms and to notify NCAA staff if they had not yet been received.
8. **Men's subcommittee updates.** Staff updated the committee on current men's subcommittee topics.
9. **Women's subcommittee updates.** Staff updated the committee on current women's subcommittee topics.
10. **Other.** Committee members and staff also briefly discussed prospective student-athletes competing in regular-season events, either as individuals or as a member of a national team.
