DECEMBER 2, 2025, VIDEOCONFERENCE

INFORMATIONAL ITEMS.

1. **Welcome and announcements.** NCAA staff welcomed members to the videoconference and previewed key agenda items.
2. **NQS updates/feedback.** The committee discussed at length the recent adjustments to the National Qualifying Score (NQS) calculation, including feedback received from the coaching membership, and inquiries received since announcing the change, which is effective for the 2025-26 season.

The committee also discussed waiver requests received to date but did not take action on those requests during this meeting. Another meeting will be scheduled to further discuss waiver requests received.

3. **Schedule of meets forms.** The committee received an update on the number of schedule of meet forms submitted to date. The deadline for teams to submit the form was formally extended to December 10.
4. **Championship finals site subcommittee reports.** Subcommittee members reported out to the full group with updates on their work surrounding student-athlete experience, fan enhancements and marketing, and officiating.
5. **Regional host videoconferences.** The committee received updates from the NCAA staff as individual regional site meetings began the first week of December. Two meetings have occurred with all regional site reps and host staffs. Individual regional host calls and detailed planning efforts will continue throughout the lead-up to the championships.
6. **Future meetings.** Committee and staff confirmed the schedule for upcoming meetings and discussed future agenda items.
