NCAA DIVISION I MEN'S ICE HOCKEY OVERSIGHT COMMITTEE
NOVEMBER 12, 2025, VIDEOCONFERENCE**

INFORMATIONAL ITEMS.

1. **Update on the NCAA Division I Men's Ice Hockey Oversight Committee weighted voting.** The Men's Ice Hockey Oversight Committee received an update from Division I governance and member services staff regarding weighted voting. Specifically, NCAA staff confirmed the one representative of the autonomy conference and the three whose representation is based on success shall have 1.25 votes each, with all other voting representatives receiving one (1) vote each.
2. **Review of NCAA Division I Cabinet referral.** The oversight committee discussed the Division I Cabinet referral to review championship squad-size limitations in consideration of newly adopted roster limitations (Bylaw 17.2). The committee voted to maintain the current men's ice hockey championship squad size of 27. The committee noted the variances in roster sizes among institutions who have opted-in to the *House* settlement and those who have not, and the importance of preserving the student-athlete experience during the on-going championship segment as rationale for maintaining the current championship squad size.
3. **Review of Division I men's ice hockey notification of transfer legislation.** The oversight committee reviewed guidance from the cabinet on changes to sport specific notification of transfer legislation and discussed potential changes to the timing and duration of the men's ice hockey notification of transfer window. The committee will continue discussions on this issue at a future meeting.
4. **NCAA Division I Men's Ice Hockey Rules Subcommittee.** The oversight committee will receive an update on the work of the rules subcommittee at their next meeting.
