**INFORMATIONAL ITEMS.**

**1. Legislative Items.**

- **NCAA Division I Proposal No. 2026-15 – Recruiting – Men’s Lacrosse -- First Opportunity for Recruiting Activities.** The NCAA Division I Men’s Lacrosse Oversight Committee adopted Proposal 2026-15. The proposal establishes Wednesday (7 a.m.) immediately following Labor Day of a prospective student-athlete’s junior year of high school as the first permissible date for all recruiting activities. The adopted proposal is subject to review by the NCAA Division I Cabinet during its June 23-24, 2026, meeting.

**2. Bylaw 17 Decentralization Review Playing and Practice Seasons – Foreign Tours – Time Lapse Between Tours – Men’s Lacrosse.** The oversight committee received an update specific to the Division I Cabinet’s review of Bylaw 17 decentralization and deregulation efforts. The oversight committee will be asked to provide feedback to the Cabinet regarding the men’s lacrosse playing season prior to the Cabinet’s June 23-24 meeting.

**3. Update on Playing Rules Subcommittee review of commercial or nonprofit trademarks/logos on the playing surface.** The oversight committee received an update on the playing rules subcommittee’s review of placement of logos during the regular season on the playing surface and adopted the subcommittee’s recommendation to permit:

- The logo(s) shall fit into a box that is 15 feet by 15 feet square;
- The boxes shall be located 10 yards from the sideline or outside both endlines; and
- May not interfere with required field markings.
