1. **Oversight committee chair vacancy.** The NCAA Division I Men’s Soccer Oversight Committee voted to appoint Chris Schneider, executive associate commissioner, sport administration and championships at the Big East Conference, as the new oversight committee chair.
2. **NCAA Division I Bylaw 17 Decentralization Feedback – Phase I.** The oversight committee discussed the decentralization of Division I Bylaw 17 (Playing and Practice Seasons). The committee provided feedback to the NCAA Division I Cabinet on the first practice date, first competition date, end of the playing season, maximum competition dates, summer athletics activities and health and safety for men’s soccer.
3. **NCAA Division I Proposal No. 2026-27 -- PLAYING AND PRACTICE SEASON -- MEN'S SOCCER -- REDISTRIBUTION OF MEN’S SOCCER PLAYING SEASON MODEL.** The oversight committee reviewed membership feedback provided during the additional comment period on Proposal No. 2026-27. The oversight committee also discussed conference outreach measures they may want to explore prior to the Division I Cabinet’s June 23-24 meeting.
