

## REPORT OF THE NCAA DIVISION I WOMEN'S SOCCER OVERSIGHT COMMITTEE SEPTEMBER 29, 2025, VIRTUAL MEETING

## INFORMATIONAL ITEMS.

- **1. Review committee roster.** NCAA staff reviewed the current WSOC roster with the committee and provided an overview of voting procedures under the new governance structure.
- **2. Committee vacancies**. The Division I Women's Soccer Oversight Committee (WSOC) voted to appoint the following indivduals to the fill the remaining vacancies on the committee:
  - **a.** At-large vacancies. The committee voted to appoint Todd Plourde of Iona University and Janet Oberle of Saint Louis University to the remaining at-large seats on the WSOC.
  - **b. Student-athlete vacancies.** The committee voted to appoint Sara Bower of the University of Akron, Isabella Gutierrez of East Carolina University and Saige Wimes of the University of Kansas to fill the student-athlete seats on the WSOC.
  - c. Playing rules subcommittee vacancies. The committee voted to appoint Todd Bramble of George Mason University, Jason Burr of Purdue University Fort Wayne, Keidane McAlpine of the University of Georgia and Katie Zingg of Lindenwood University to the remaining seats on the Women's Soccer Playing Rules Subcommittee.
  - **d.** Playing rules subcommittee liaisons. The committee voted to appoint Ryan Higginbotham of Texas Christian University and Elizabeth Galvin of Eastern Illinois University as nonvoting members on the Women's Soccer Playing Rules Subcommittee.
- **3. Future meetings.** The committee was informed that a committee orientation for the full WSOC would be scheduled in the coming weeks to provide an overview of policies and procedures in addition to expectations of committee members.
- **4. Adjournment.** The committee adjourned at 12:50 p.m. Eastern time.
