



**REPORT OF THE
NCAA DIVISION II MEN'S SOCCER COMMITTEE
JANUARY 23, 2023, MEETING**

KEY ITEMS.

- **Misconduct.** The committee reviewed misconduct inquiry responses for two institutions regarding incidents at the Division II championships festival. (See Informational Item 5).

ACTION ITEMS.

INFORMATIONAL ITEMS.

1. **2022-23 Division II Championships Committee update.** The committee reviewed relevant actions and information items from 2022-23.
2. **Rankings and selections.** The committee reviewed the current selection criteria and ranking process and agreed the current criteria is the best available for their use. The committee continues to be supportive of the first published ranking of the year to be an alphabetical list of teams under consideration.

The committee finalized their review of minimum requirements to be considered for selections and determined that the current requirements are appropriate for the committee's ability to rank and select teams for the championship. This feedback was also provided separately as part of the overall division II review of these requirements.

The committee also reviewed the KPI metric and showed an interest in exploring this further if they had the ability to see specific data for DII men's soccer.

3. **2023 championship preliminary rounds review.** The committee reviewed preliminary-round competition and were pleased overall. Members discussed improvements that can be made for host and site representative preparation, such as communication tools that may assist in their preparation. Staff has noted these items and will work to adjust for the future.
4. **Finals site review.** The committee briefly discussed the championships in Seattle and reserved further discussion for the joint meeting with the women's committee. Further detail is provided in the joint meeting report.
5. **Officials.** The committee reviewed the 2023 preliminary round and championship officials and provided suggestions on how we can continue to improve consistency. Specifically, the committee provided input on the semi-finals and final assignments, where they were on site to observe performance. Staff will discuss suggestions with the national coordinator of officials and regional assignors prior to next year.

6. **Misconduct.** The committee reviewed misconduct inquiry responses from two institutions regarding incidents at the Division II championships festival. The committee has provided both institutions their response and the penalties they feel are appropriate for their actions.
7. **Committee composition.** The committee reviewed the current committee composition and noted that terms expiring at the end of this coming August.
8. **Manual review.** The committee reviewed the 2022-23 championship manuals and noted edits for the upcoming season.
