

REPORT OF THE NCAA DIVISION III SOFTBALL COMMITTEE SEPT. 23, 2025, VIDEOCONFERENCE

ACTION ITEMS.

INFORMATIONAL ITEMS.

- **1. Welcome and introductions.** The videoconference participants introduced themselves for the benefit of new members of the committee and NCAA staff.
- **2. 2024-25 annual report.** The committee reviewed and approved the report from the 2024-25 annual meeting.
- **3. Committee calendar.** The committee reviewed the 2025-26 committee calendar without making any changes.
- **4. 2028-31 championships bid cycle.** The committee received an update on the 2028-31 championships bid cycle.
- **5. Officials misconduct policy and procedure.** The committee received an update on efforts the national office is making to create a misconduct policy and procedure for officials.
- **6. 2025-26 playing rules changes.** The committee received an update on playing rule changes taking effect in 2025-26. The committee discussed methods to inform the membership that the double first base will not be used in the 2026 Division III softball championship.
- 7. Manuals. The committee received an update on the process to finalize the 2025-26 manuals.
- **8. 2026 championship site visit.** The committee received an update on the plan for conducting the 2026 finals site visit. The committee noted areas of emphasis for the site visit.
- **9. Bench size limit.** The committee was notified that its request to increase the 2026 bench size limit to 38 was approved. The committee discussed an unlimited bench size and an unlimited student-athlete bench size with a cap on individuals other than student-athletes. The committee will provide its feedback on those topics to the Division III Championships Committee as requested through the form provided.
- **10. Home team determination.** The committee discussed possible changes to the home team determination policy but took no action.
- **11. Finals inclement weather policy.** The committee approved changes to the finals round inclement weather policy that provide the committee with additional flexibility to schedule
