1. **Committee vacancy.** The oversight committee approved Caitlin Hughes, associate commissioner for sport services at the Northeast Conference, to fill the vacant at-large seat for a term ending Aug. 31, 2030, with eligibility for reappointment.
2. **Playing rules – Commercial Logos.** The oversight committee approved a playing rules change proposal from the NCAA Division I Swimming and Diving Rules Subcommittee to permit commercial or nonprofit logos on the pool bottom with lane markers clearly visible.
