

# REPORT OF THE NCAA DIVISION I MEN'S AND WOMEN'S SWIMMING AND DIVING COMMITTEE DECEMBER 11, 2024, VIDEOCONFERENCE

#### <u>INFORMATIONAL ITEMS</u>.

- 1. Competition Oversight Committee update. NCAA staff provided an update on the new Sports Oversight Committee, the merged committee of the former Competition Oversight Committee and Student-Athlete Experience Committee.
- 2. Championships updates.
  - **a. Committee travel and hotel for championships.** Staff updated the committee on travel plans for the 2025 championships.
  - **b.** Massage table feedback. Staff shared the proposed massage table location and layout in Federal Way, Washington with the committee for the 2025 championships. The committee supported the proposed layout in the adjacent banquet hall, which provides more space for all massage tables and better temperature control. The rec pool space will be available with 12 ice baths.
- 3. CSCAA feedback. Staff reviewed feedback provided by the CSCAA requesting the committee to further investigate a potential date formula change and format change for the championships with a goal for linear television coverage. Staff reviewed the work done to date including a conference survey and feedback from ESPN on date options, neither of which favored a change. The committee agreed to discuss collaboration opportunities with the CSCAA and to seek additional feedback from ESPN.
- **4. Team diving survey feedback.** NCAA staff distributed the team diving survey feedback with comments for the committee's review over the next month before its next meeting.
- 5. Diving updates.
  - **a. Diving subcommittee meeting.** The diving subcommittee will meet at 11 a.m. Eastern time, Jan. 27.
  - **b. Zone host call.** The five zone hosts will meet with NCAA staff and committee members at 1 p.m. Eastern time, Jan. 27.
