**INFORMATIONAL ITEMS.**

1. **Rules update.** The rules committee is finalizing the rules survey for possible rules changes to be distributed to the membership in the coming weeks.
2. **Championship travel and annual meeting dates.** The committee and staff discussed travel plans for Federal Way. Staff reminded the committee of the new annual meeting dates of June 16 and 17.
3. **Committee responsibilities at championship.** The committee chair reviewed committee assignments for the championships in Federal Way.
4. **Championships updates.**
  - a. **Upcoming deadlines.** The committee reviewed the upcoming championships deadlines for entries and selections.
  - b. **Manuals – zones/finals.** NCAA staff provided an update on the participant manuals for the zone diving championships and the final site. All participant manuals are published on [ncaa.org](http://ncaa.org).
  - c. **Community engagement.** The host will execute a book drive with the 2025 championships participants to support school-aged youth in Federal Way and Pullman, Washington. Participants will be encouraged to bring new/unused books to the championship.
  - d. **Host update.** Staff updated the committee on recent host planning for the 2025 championships.
5. **Nominating committee feedback.** The committee provided feedback on the nominees to replace outgoing committee members Matt Barany and Ryan Rougeux.
6. **Diving updates.** The committee discussed the potential for a proposed alternative format from specific zones due to the number of entered divers. The committee will reconvene to vote on any proposals once received.
7. **Future calls.** The committee will meet Tuesday, March 4 for the women's selections and on Tuesday, March 11 for the men's selections.
