INFORMATIONAL ITEMS.

1. Diving updates.

- a. **Zone B site change.** The oversight committee approved the University of Georgia to host the 2026 Zone B championship in place of Georgia Institute of Technology as recommended by the championship subcommittee.
- b. **Diving tiebreaker for eighth and 16th place.** The oversight committee approved the recommendations from the championship subcommittee regarding the diving tiebreakers for eighth and 16th place due to the new championship format change that removed consolation finals from all events as follows.
 - There is no change proposed for an eighth-place tie in the preliminary session. All divers tied for eighth will advance to finals as was the previous policy.
 - For the tie for 16th place, since that is the last scored position, those tied for 16th place in the preliminary session will split the points for 16th place (e.g. if two divers tied for 16th place, they each get 0.5 points).

2. Future meetings. The oversight committee will meet at 11 a.m. Eastern time, Wednesday, Feb. 11. The championship subcommittee will meet next at 4 p.m., March 3 for the women's championships selection and on March 10 for the men's championships selection.
