NCAA DIVISION I MEN'S AND WOMEN'S  
SWIMMING AND DIVING COMMITTEE  
JUNE 16-17, 2025, ANNUAL MEETING

**Action Items:** The NCAA Division I Sports Oversight Committee will be asked to approve a new individual event selection process and qualifying standards (see Action Item 2-a), a new schedule of events and format for the championships (see Action Item 2-b) and the 2026 zone diving sites (see Action Item 2-c).

**KEY ITEMS.**

1. **Individual event selection process and qualifying standards.** The committee is recommending a new individual event selection process and qualifying standards to increase institutional and conference representation at the championships.
2. **Championships schedule of events and format.** The committee is recommending an update to the schedule of events and championships format to position the championship for future linear broadcast opportunities and improve the spectator and viewer experience.
3. **2026 zone diving host sites.** The committee is recommending the five zone diving host sites for the 2026 championships.

**ACTION ITEMS.**

1. **Legislative items.**

- None.

2. **Nonlegislative items.**

a. **Individual event selection process and qualifying standards.**

(1) **Recommendation.** Change the championship qualification process for individual swimming events as follows:

- (a) Establish one NCAA championship qualifying standard to be set as the three-year average of the 72<sup>nd</sup> best time on the performance list for the individual swimming events. There are no changes to the diving or relay qualifying processes.
- (b) Institute a conference qualifier spot for a swimmer who wins their conference championship meet AND meets or exceeds the NCAA championship qualifying standard. Conferences are eligible for this opportunity with at least five members sponsoring the sport and hosting a conference championship meet. The committee will review the sport sponsorship list each fall to determine the eligible conferences. Based on currently available information, the following conferences will be eligible:

America East Conference; American Athletic Conference (women's only); Atlantic Coast Conference; Atlantic Sun Conference; Atlantic 10 Conference; Big East Conference; Big Ten Conference; Big 12 Conference; Big West Conference; Coastal Athletic Association; Horizon League; The Ivy League; Metro Atlantic Athletic Conference; Mid-American Conference (women's only); Missouri Valley Conference; Mountain Pacific Sports Federation; Mountain West Conference (women's only); Northeast Conference (women's only); Patriot League; Southeastern Conference; and The Summit League.

(c) The remainder of the championship field will be filled with those who meet or exceed the NCAA championship qualifying standard following the same process that is currently in place:

- One entry will be added to each individual swimming event in event order to keep the events at the same number. No entrants will be added to an event that exceeds this number of places because of conference qualifiers until all individual events even out. This process will be repeated as long as each individual event in the entire order of events can receive an additional entry and the number of total competitors will remain below the cap (270 swimmers and divers for the men's meet and 322 swimmers and divers for the women's meet).
- At some point, the addition of one competitor per event to the entire order of individual events will put the field over the total number of competitors cap. At this point, the remaining spaces will be allocated by comparing the NCAA championship qualifying standard for each individual event divided by the next entry time on the list. The competitor who has the highest percentage (closest to the NCAA championship qualifying standard) will be taken first, and so on until the cap has been reached. \*Ties will be broken following the same procedure as always for the final selection spot.
- An alternate list for individual events will be created. This list will be used in case a swimmer who has been invited to the championships has become ineligible or unavailable. Alternates will be listed in the order in which they would be selected to the meet.

(2) Effective date. For the 2025-26 academic year.

(3) Rationale. The recommended changes are a product of a collaborative effort with many stakeholders and industry leaders in the swimming and diving community, led by the coaches association. The overarching goal of this recommendation is to increase institutional representation to expand championship access for institutions and conferences without compromising the integrity of the championship or increasing the field size of the championships. A historical analysis of the recommended change shows minimal impact to team representation and athletes who score at the NCAA

championships. The increase in institutional and conference representation will provide value back to campus during a time when the sports of swimming and diving are attempting to make the necessary changes to best position the sports for success in this new era of college athletics. This new qualification model is also easier to understand than the previous A and B standard in addition to providing greater import to conference championships with another opportunity for institutions and conferences to spotlight their qualifiers. This new selection procedure has similar goals as the team automatic qualification system used in many NCAA championships to provide representation opportunities for conferences.

- (4) Estimated budget impact. There is an expected one-time service fee to revise the selection system with USA Swimming that will be absorbed within the current budget. The committee will work within its current budget and will recognize some savings from a single host site for both the men's and women's championships. Increased institutional representation may also provide for a marginal increase in non-athlete official travel party expenses.
- (5) Student-athlete impact. The recommendation will provide an increase in institutional and conference representation at the championships, which in turn provides value back to campus in a time when individual teams must prove their worth in this new era of college athletics.

**b. Championship schedule of events and format.**

- (1) Recommendation. Revise the championship format and schedule of events as follows:
  - (a) Remove the consolation final from the evening finals session and score ninth through 16<sup>th</sup> place directly from the preliminaries. The top eight swimmers, divers and relays will compete during the evening finals session to score places one through eight. All relays remain timed finals.
  - (b) Reposition the awards ceremonies in coordination with broadcast partners to improve event flow and allow for each evening finals session to fit within a two-hour window.
  - (c) Split the diving finals competition into two segments of three dives each during each finals session.
  - (d) Reordering the schedule of events to maximize broadcast and spectator interest in consultation with broadcast partners. This adds a preliminary session to Wednesday morning but will not add further practice time. See Attachment A for the proposed schedule of events.

(2) Effective date. 2025-26 academic year.

(3) Rationale. The recommended changes are a product of a collaborative effort with many stakeholders and industry leaders in the swimming and diving community, led by the coaches association with consultation from the national governing bodies, World Aquatics and broadcast partners. The overarching goal is to provide a schedule that positions the championships for linear broadcast in the future and provides a more fan-friendly and broadcast-friendly championship experience. The changes to the schedule of events place the marquee events during the final days of competition to enhance excitement and visibility. The changes to the format and schedule of events are intended to create a two-hour linear broadcast event that is compelling for the audience, easy to follow and with minimal to no budget impact. It will also provide more opportunity to increase storytelling during the championships. While the championships will still be on ESPN+ this year, the broadcast partner will use this year as a proof of concept for a linear window in the near future. Further adjustments to the schedule, format, events and date formula could come if these initial adjustments prove successful. The swimming and diving community is united in its effort to make the necessary changes to best position the sports for success in this new era of college athletics.

(4) Estimated budget impact. Minimal increase to staffing for the additional preliminary session to be handled within the host budget.

(5) Student-athlete impact. These changes are intended to provide a schedule that is broadcast-friendly and provides more weight to the preliminary sessions in the morning. An opportunity for more broadcast exposure and improved storytelling is an enhancement to the student-athlete experience.

**c. 2026 zone diving host sites.**

(1) Recommendation. Approve the following institutions and sites to host the 2026 NCAA Division I Men's and Women's Zone Diving Championships March 9-14, 2026:

(2) Effective date. 2025-26 academic year.

(3) Rationale. These recommended sites were the only bids submitted for their respective

zone competitions. They were also recommended by the coaches in each zone.

- (4) Estimated budget impact. The NCAA does not reimburse for travel or per diem expenses for the zone diving meets. The estimated expenses for the recommended sites range from \$10,000 to \$20,000 depending on the facility rental fee (which is the primary expense). Zone diving hosts do not charge admission to the event.
- (5) Student-athlete impact. Student-athletes are given the opportunity to compete at the best diving facilities in the country with staff that is experienced in hosting NCAA zone diving meets.

### **INFORMATIONAL ITEMS.**

1. **Review of agenda and schedule.** The committee reviewed the agenda and meeting schedule and made no adjustments.
2. **Annual meeting report.** The committee reviewed and approved the report from last year's annual meeting as submitted.
3. **Championship strategic plan.** The committee reviewed and approved the Division I Men's and Women's Swimming and Diving Championships strategic plan for 2025-26 season with no changes from the previous year. Should the new Division I governance structure be approved, the new oversight committee will revise the strategic plan accordingly based on its new responsibilities.
4. **Playing rules discussion.** Greg Lockard, NCAA swimming and diving secretary-rules editor, and Jay Fitzwater, NCAA assistant director of championships and alliances, joined the meeting to discuss the proposed playing rules changes survey results for the new playing rules cycle for the 2025-26 and 2026-27 seasons. Mr. Lockard will also develop the new playing rules test for championships officials ahead of the 2026 application process this fall.

The committee will annually address the language related to bona fide competition criteria that further clarifies which USA Swimming and USA Diving meets may be part of a team's schedule and be counted for qualifying for NCAA swimming and diving championships:

*Select USA Swimming and USA Diving meets that are acceptable for achievement of time standards, consideration standards and optional-entry standards may be designated each year by the NCAA Men's and Women's Swimming and Diving Committees in all three divisions.*

Thus, the committee approved the following meets at which such standards may be achieved for the 2026 championships: the USA Swimming National Championships (Toyota U.S. Open), World Aquatics World Swimming Championships, USA Diving National Championships and the SPEEDO Winter Junior Championships East and West. The committee will consider

requests from the membership for another country's diving national championship/trial meets on a case-by-case basis. The committee did not support including USA Swimming Pro Series meets on the approved list.

5. **CSCAA report.** Samantha Barany, executive director of the College Swimming and Diving Coaches of America Association, and Maureen Palchak, chief operations officer, joined the committee to review and discuss the coaches association-led proposal to modify the championships schedule of events and selection process for the 2026 championships with the stated goals of expanding the reach and increasing the value of collegiate swimming and diving without increasing costs. The coaches association also expressed support for a permanent host site for both championships in the future.

## 6. Officials.

- a. **Review of officials application.** The committee reviewed the application and made no changes.
- b. **Selection timeline and process.** The committee discussed the process and reviewed the timeline for applications and the selection of officials and recommended no changes for the 2026 championships.
- c. **Minimum qualifications for championships officials.** The committee will implement minimum qualifications for selection as a championship official for the 2026 championships. The committee solicited a recommendation from the head swimming and head diving referees from the 2024 championships one year ago. The committee approved the recommendations and will add the new minimum qualifications to the officials application process. This will provide more clarity on the expectations of championships officials and more transparency in the selection process.

Swimming officials must register as an NCAA official, pass the current NCAA rules test with a score of 85% or better, submit an NCAA application by the submission deadline, pass the background check and watch the required sports wagering video. The official must be an active, certified USA Swimming officials with a minimum of five years' experience participating in local meets. The official must be a current college swimming official, having officiated at least three college meets in no fewer than each of the last five seasons. The officials must have a background check, athlete protection certifications and concussion protocol certification. Preference will be given to those who have extensive prior officiating experience and have served at a conference and/or national championship meet.

Diving officials must register as an NCAA official, submit an NCAA application by the submission deadline, pass the background check and watch the required sports wagering video. Diving officials have five pathways of experience to be eligible for consideration for the NCAA championships: (1) judge or referee at an Autonomy Four conference

championship three times within the last five years; (2) International experience – completing at least one of the following: judge or referee at one of the last three Olympic games, at a World Championships within the last five years, at a World Cup (leg or superfinal) within the last five years or at a Continental Championships within the last five years; (3) judge or referee at a USA Diving Senior National meet at least three times within the last five years; (4) judge or referee at one of the last two US Olympic Team Trials for diving; (5) finish as one of the top three judges (from evaluations) at an NCAA Division I Championship within the last two years.

- d. **Review of officials.** The committee reviewed feedback on the swimming and diving officials at the championship and noted good overall performance. The committee agreed with a recommendation to repurpose the second starter role into a chief judge at the turn end and assistant officials coordinator for improved on-deck management as long as at least one assigned official can serve as a back-up starter, if needed.

## 7. Coordinators.

- a. **Administrative referee responsibilities.** The committee reviewed the responsibilities of the administrative referee and made no changes. Additionally, the committee voted to extend an offer to Brad Erickson to serve as the administrative referee for the 2026 men's and women's championships.
- b. **Officials coordinator responsibilities.** The committee reviewed the officials coordinator responsibilities and made no adjustments for the 2026 championships.
- c. **Swimming and diving data specialist responsibilities.** The committee reviewed the swimming and diving data specialist responsibilities and made no adjustments for the 2026 championships.
- d. **Selection of data specialists for 2026 championships.** The committee recommended inviting Herb Schwab to serve as the swimming data specialist for the 2026 men's and women's championships. The committee thanked Lia Fusaro for serving as the diving data specialist in recent years and will seek a replacement for the 2026 men's and women's championships.
- e. **Selection of swimming and diving announcers for 2026 championships.** The committee recommended inviting Michael Poropat to serve as the swimming public address announcer for the 2026 men's and women's championships. The committee thanked Lia Fusaro, the diving public address announcer, for her service in recent years and will seek a replacement for the 2026 men's and women's championships.

## 8. Qualifying.

- a. **End-of-season competition process and form.** The committee reviewed the end-of-season competition process and form and made no changes for the 2025-26 season. NCAA staff will make this an electronic form for 2025-26.
- b. **Qualifying standards and conversions.**

The committee recommended a change to the selection process and qualifying standards for the individual events (see Action Item 2-a).

For relay events, the qualifying standards will remain the three-year average of the 16<sup>th</sup> best time on the championship finals performance list, except for the women's qualifying standards in the 800 freestyle relay and 400 medley relay and the men's qualifying standards in the 400 medley relay. Those events will remain at the standards established for 2025 since they are faster than those projected for 2026. The provisional standard will remain the three-year average of the 24<sup>th</sup> best time on the performance list for all women's and men's relays.

For diving, the committee recommended no adjustments to the current qualifying standards.

The committee made no changes to the conversion factors for the 2026 championships.

The committee reminds the membership that in non-Olympic years, time standards achieved in 50-meter racing courses are not eligible for selection.

- c. **Fine structure for 2025-26 season.** The committee approved the fine structure for the 2025-26 season, noting two changes. The committee will implement a \$500 fine for not adding the competition schedule by the same deadline as the rosters. Schedule submission is important for ensuring adequate and on-time submission of results. The committee also moved the roster and schedule submission deadline from early September to Oct. 1 or before the first scheduled competition. The later deadline should assist teams with having a clearer picture of their roster and schedule for the season and allow coaches adequate time to make the necessary updates on the USA Swimming SWIMS 3.0 system. The new Oct. 1 deadline will remain Oct. 1 annually and will not change with the calendar for a consistent deadline that is easy to remember annually.

## 9. Selection of swimmers.

- a. **Review of selection and relay qualification procedures.** The committee recommended a change to the selection process and qualifying standards for the individual events (see Action Item 2-a). The committee recommended no changes to the current relay qualification procedures for the 2026 championships.



- b. **OME entry procedures.** The committee reviewed the current OME entry procedures and made no changes. Should the proposed changed to the selection process be approved, it is noted that institutions will still be required to enter into the OME conference champions who win the conference championship and meet the qualifying standard during the championship final.
- c. **Late entry/corrected entry process.** The committee affirmed that once the selection process begins, there are no late entries after that point. Once the pre-selection psych sheets are posted, coaches are responsible for reviewing their entries and contacting the NCAA staff immediately with any issues ahead of the 4 p.m. Eastern start time of the selection process.
- d. **USA Swimming staff support and SWIMS database system.** USA Swimming staff recapped the third year of SWIMS 3.0 database system and selection tool, noting positive performance. The committee recognized Katie Trace, coordinator of events and data at USA Swimming, for her excellent responsiveness and efforts this season.

#### 10. Review of 2025 championships.

- a. **Participant survey results.** The committee reviewed the participant surveys from the 2025 championships and will relay host-specific feedback to the tournament manager. The committee thanked the staffs of Washington State University, the Seattle Sports Commission and the Weyerhaeuser King County Aquatic Center for hosting the 2025 championships. The committee noted feedback focused on location, hospitality, team space, massage therapy location and warmup lane availability.
- b. **OMEGA timing system.** The committee reviewed the performance of the OMEGA timing system and timing crew.
- c. **Team seating selection process.** The committee reviewed the team seating selection process and made no changes. Based on the facility deck space and bleacher size, the committee will review the amount of space allotted to the top 15 teams based on team size, if possible.
- d. **Massage therapy policies.** The committee reviewed the massage therapy selection process and made no changes. The committee will annually evaluate the ability to select two adjacent spots based on facility layout and space availability. A team must list two massage therapists on its deck pass list to be eligible for two spots.
- e. **Team ticket sale policies.** The committee reviewed the team ticket sales policies and made no changes.

- f. **Team video service.** The committee was pleased with the team video services provided by Sideline Scout at the men's and women's championships. The committee will evaluate if that service is necessary at future host sites based on each facility layout and capabilities.
- g. **Media – review of policies and access on deck by photographers/videographers.** The committee reviewed policies regarding videographer/photographer access and discussed limiting team content (photographer and videographer) credentials on the pool deck. It is common at other NCAA championships for there to be a limit and the committee noted the tight deck space and feedback on the number of people on deck. NCAA staff will investigate this further for the committee to revisit before the 2026 championships.
- h. **Awards presenters and schedule.** The committee will discontinue the practice of awards presenters and will review the impact of the proposed new schedule of events on the awards ceremony timing and process.
- i. **Awards ceremony stand-ins.** Should the proposed new schedule of events take effect for the 2026 championships, this policy will no longer be needed if the awards ceremonies for all events be moved after the conclusion of the last event each night.
- j. **Deck passes and credential policies.** The committee made will permit diving only teams to have up to four deck passes like a team with only one swimmer represented.
- k. **Championship experience enhancements.** The committee reviewed the championship experience elements and applauded the use of the LED arch and individual introductions during finals with lighting and smoke effects. The committee supported the additional enhancements for the event winners with a national champion sign for each winner and the national champion signature wall. The committee recommended a better location for the signature wall to be part of the awards ceremony going forward for greater impact. The committee also noted feedback emphasizing music/DJ as a key element to the championship experience. The committee will continue to work on enhancing the championship experience each year.

## 11. 2026 action plan.

- a. **Schedule of events.** The committee reviewed and supported the coaches association recommendation to revise the schedule of events for the 2026 championships to better position the championships for linear broadcast coverage (See Action Item 2-b).
- b. **Areas of focus for 2026 site.** The committee discussed initial plans for the 2026 championships, including notes from the 2022 championships. The committee will also focus on the following areas with the host: student-athlete and fan experience, hospitality, team seating, diving meet operations and community engagement opportunities.

- c. **Full wall timing pads.** The committee discussed a proposal from the head meet referees to implement full wall timing pads at the championships to alleviate issues with backstroke starts. The committee decided to retain use of the gutter-hung timing pads, which they think are best for short-course events.

## 12. Diving.

- a. **Zone diving subcommittee.** The committee reviewed the roster of zone diving subcommittee members and noted that Zone C still needs to identify a replacement for a new term.
- b. **DiveMeets zone diving registration process.** The committee reviewed the DiveMeets registration process and made no changes. The committee was pleased with efforts to remind coaches of the deadline to keep the number of late entries low. The committee reminds the membership that DiveMeets is required for entries and results for the 2025-26 season and no paper entries or results will be accepted.
- c. **Zone diving host responsibilities.** The committee will ensure the host staff and assigned zone subcommittee member communicate regarding schedule of events during the planning process.
- d. **Diving site representative responsibilities.** The committee reviewed and made no changes to the site representative responsibilities. NCAA staff will investigate potential options to add a meet referee at each zone diving meet in the future, but no current action anticipated for 2026.
- e. **Zone diving meet qualifying standards.** The committee made no changes to the current qualifying standards.
- f. **Zone diving scheduling options.** The committee made no changes to the zone diving scheduling options.
- g. **Alternate process for championship.** The committee will revise the alternate process language in the prechampionships manual for more clarity for the membership on diver alternates from the zone meet to the championships.
- h. **Appeals process.** The committee reviewed the appeals process for diving and recommended that the secretary-rules editor and an assigned official from the final site be involved in any appeals process taking place at the zone meets to ensure compliance with the playing rules.
- i. **Judge panel assignments by round of zones.** The committee will assign this topic to the zone subcommittee for a recommendation to the full committee.

- j. **2026 number of qualifying spots per zone.** The committee confirmed the number of qualifying spots for each zone for the 2026 championships as follows:

- k. **2026 reimbursement spots per zone.** The committee confirmed the reimbursement allocations for each zone for the 2026 championships as follows:

- l. **2026 zone diving dates and sites.** The committee reviewed dates and recommended sites for the 2026 championships (see Action Item 2-c).
- m. **Zone reallocation.** The committee will assign the initial review of the allocation of institutions per zone to the zone subcommittee.
- n. **Team diving event.** In light of the feedback and recommendation received from the coaches association, the committee tabled the addition of the team diving event. The committee will revisit in the future in collaboration with the coaches association.

### 13. Committee.

- a. **Committee composition and vacancies.** The committee will have four new members for the 2025-26 season after the terms conclude for Matt Barany, Ryan Rougeux and Steve Schaffer plus an already vacant position. The committee thanks our departing committee members for their service on the committee.
- b. **Committee timeline.** The committee reviewed the proposed timeline for 2025-26 and made no changes.

- c. **Committee responsibilities and championships coverage plan.** The committee reviewed responsibilities will make edits at a future meeting if the schedule of events recommendation is approved.

**14. Manual updates and review.** The committee asked staff to make the necessary changes and general updates to the manuals in preparation for the 2025-26 season.

**15. Future sites.** In 2026, Georgia Institute of Technology will host the women's championships and men's championships at the McAuley Aquatic Center in Atlanta. A site visit will be scheduled with all key stakeholders in August or September. The 2027 and 2028 women's championships and men's championships will be hosted by the University of Texas at Austin at the Lee & Joe Jamail Texas Swimming Center in Austin, Texas.
