INFORMATIONAL ITEMS.

1. **Rules update.** Greg Lockard, secretary-rules editor, updated the committee on playing rules and officiating for the sport along with encouraging the committee to provide any rules feedback since it will be a rules change year.
2. **Committee updates.** Staff provided the committee with updates on the conflict-of-interest statement and various championships manuals.
3. **Competition Oversight Committee.** Staff updated the committee on the latest actions from the Division I Competition Oversight Committee.
4. **Officials' registration and application submission deadline.** The committee reviewed the timeline for the officials' selection process. The committee also provided feedback on an initial draft of eligibility criteria for championships officials. All three divisional committees will review with a goal to approve a final draft of eligibility criteria at their 2025 annual meetings to go into effect for the 2025-26 championships.
5. **Championships updates.** Staff informed the committee that the end-of-season competition form is available on ncaa.org. Staff also informed the committee that all Division I institutions met the roster submission deadline.
6. **Membership survey.** Staff informed the committee that the membership survey will be distributed within the next month in conjunction with a women's basketball survey.
7. **Diving updates.** Staff informed the committee that coaches received the annual diving entry process correspondence recently. The committee reviewed and confirmed the members of the zone diving subcommittee. Staff confirmed all five zone hosts for 2025 and is reviewing submitted host budgets. The committee confirmed permitting each zone to compete the team diving event as an exhibition event in 2025.
