ACTION ITEMS.

INFORMATIONAL ITEMS.

- 1. December 2025 committee report.** The committee reviewed the report from its December 2025 videoconference and asked that the item regarding the committee's request to increase the male participant cap be amended.
- 2. Diving regionals site representatives.** The committee received an update on the process of securing site representatives for the diving regionals.
- 3. Diving judge qualifications.** The committee reviewed an updated draft of the diving judge qualifications document and asked that the championship manager clarify one portion of the qualifications. An updated draft of the qualifications document will be provided during the committee's next meeting.
- 4. Head diving coach contact information.** The committee was informed that the national office information technology staff moved the request to collect head diving coach contact information down their priority list, so the contact information is not likely to be collected during the current academic year.
- 5. Officials.** The committee received an update on the process of securing officials for the 2026 championships.
- 6. Walkout music procedure.** The committee discussed and determined a basic procedure for the No. 1 seed in each swimming event to request a walkout song to be played over the facility public address system as the participants for the event are walking to the starting blocks and being introduced by the public address announcer prior to their swimming event.
- 7. Student-athlete gift in lieu of banquet.** The committee received an update on the process of ordering a student-athlete gift in lieu of the banquet and affirmed its preference for the gift to be a backpack.
- 8. Fan enhancement.** The committee received an update on the process of selecting and ordering a fan enhancement giveaway item for the championships.
- 9. 2025-26 manuals.** The committee received an update on the process of updating and publishing the manuals associated with the championships.
