

REPORT OF THE NCAA DIVISION I MEN'S AND WOMEN'S TENNIS COMMITTEE APRIL 22, 2025, VIDEOCONFERENCE

INFORMATIONAL ITEMS.

- 1. NCAA staff update. NCAA staff introduced the new men's committee liaison, Kelsi Mahoney.
- **2. Broadcast update.** NCAA staff provided updates on plans for broadcast coverage of the 2025 championships.
- **3. Singles and doubles championships.** The committee reviewed the ITA's recommended proposals for tweaks to the fall singles and doubles pilot. The committee will discuss further on a future call.

- **5. Host waiver requests/bid review.** The committee reviewed and voted on host-submitted waiver requests for the 2025 preliminary rounds covering not having indoor backup and not selling tickets. NCAA staff will provide responses to individual hosts via email.
- **6. Site representatives.** The committee reviewed potential host sites based on current rankings and submitted bids. The committee determined committee assignments for obtaining site representatives ahead of selection.
- 7. Lineup and challenge process and procedures. The committee received the ITA lineup challenge guidelines and reviewed the timeline and its responsibilities for the 2025 championships.
- **8. Baylor University hosting updates.** Staff provided an update on hosting plans at Baylor.
- **9. Selections weekend.** The committee discussed the selections weekend timeline and responsibilities and received the selections policies and procedures document.
- **10. Annual meeting.** The committee's annual meeting is June 24-25 to be conducted virtually.
- 11. Other business. Staff reviewed the progress of the new attestation form submissions.
- **12. Next meeting.** The committee will meet for selections April 27-28.
