



**REPORT OF THE NCAA DIVISION I
MEN’S AND WOMEN’S TENNIS OVERSIGHT COMMITTEE
APRIL 21, 2026, VIDEOCONFERENCE**

INFORMATIONAL ITEMS.

1. **Pilot Program: Singles and Doubles Championships.** The Division I Men’s and Women’s Tennis Oversight Committee amended the NCAA Division I Men’s and Women’s Tennis Championships. Specifically, the committee permanently moved the NCAA Division I Men’s and Women’s Singles and Doubles Championships to the fall.
2. **Discussion of Nonprofit and Commercial Trademarks and Logos.** The oversight committee discussed the playing-rules subcommittee’s recommendation for placement of commercial and nonprofit trademarks or logos on the playing surface and courts. The committee provided feedback to the playing rules staff and plans to vote on the issue at a future meeting.
3. **Site representatives.** The oversight committee discussed site representatives for the upcoming team championships.
4. **Host waiver requests/bid reviews.** The oversight committee discussed preliminary-round hosts and reviewed host waiver requests.
5. **Approve April 7 Tennis Oversight Committee Report.** The oversight committee approved its report from the April 7 meeting.
