1. **Welcome and roll call.** The committee chair and NCAA staff welcomed a new oversight member to the committee.
2. **Student-athlete nominations review and vote.** The committee appointed student-athletes Emma Dell from Indiana University Indianapolis, Mert Oral from the University of Michigan, Autumn Rabjohns from Northwestern University and Steven Rice from Tulane University to serve on the oversight committee.
3. **Squad size limit.** The committee took action to increase the championship squad size from nine to 10 student-athletes to be consistent with the roster limit effective for the 2026 championships.
4. **Survey review and pilot program discussion.** NCAA staff provided the committee with a historical overview of the fall singles and doubles pilot program and discussed next steps on continuing to solicit membership feedback before a final vote this spring. The committee will continue to discuss the pilot program during its future meetings.
