

REPORT OF THE NCAA DIVISION I MEN'S AND WOMEN'S TENNIS COMMITTEE FEBRUARY 12, 2025, VIDEOCONFERENCE

INFORMATIONAL ITEMS.

- 1. NCAA staff update. NCAA staff updated the committee on the departure of the men's championship staff liaison from the NCAA national office. Staff will keep the committee informed on plans for replacement when known.
- **2. Broadcast update**. NCAA staff updated the committee on discussions with ESPN regarding potential solutions for the international availability of the championships.
- **3. Sports Oversight Committee update**. NCAA staff provided an update on the upcoming Feb. 19 meeting of the Sports Oversight Committee.
- 4. Championships updates.
 - **a. Banquet.** The committee reviewed banquet options at Baylor University for the 2025 spring championships and provided feedback to share with the host.
 - **b. Practice schedule.** The committee reviewed the draft of the practice schedule for the final site and made recommendations for changes to the practice court assignor. The committee will review the next draft at its next meeting.
 - **c. Championships enhancements.** The committee discussed potential activation ideas for the 2025 championships and other enhancement ideas to share with the host.
 - **d. Championships travel.** The committee discussed championship travel plans to Waco, Texas, in the spring.
- **5. Nominating committee feedback.** The committee provided feedback on the nominees to replace outgoing committee member Peter Pilling.
- **6. Preliminary-round hotel waiver request.** The committee reviewed a waiver request from an institution regarding the distance of hotels exceeding the 30-minute/30-mile standard. NCAA staff will communicate the decision with the institution directly.
- **7. Other business.** The committee received updates from the ITA on its ranking algorithm and the electronic line calling pilot.
- **8. Future meetings.** The committee will meet Tuesday, March 11.
