



**REPORT OF THE
NCAA DIVISION I MEN'S AND WOMEN'S TENNIS OVERSIGHT COMMITTEE
SEPT. 10, 2025, VIDEOCONFERENCE**

ACTION ITEMS.

INFORMATIONAL ITEMS.

1. **Welcome and roll call.** The committee chair and NCAA staff welcomed 12 new oversight committee members, Paige Newman, the new NCAA staff liaison to the women's subcommittee, and Khadian Harrison, one of the new NCAA governance and member services liaisons to the oversight committee.
 - **At-large seat.** The committee approved Paul Wardlaw, head women's tennis coach at the University of Denver, for the final at-large seat for the women's championship subcommittee and oversight committee.
2. **Committee orientation.** The committee chair and NCAA staff reviewed key responsibilities, expectations, policies and procedures, and important dates for serving on the committee. Staff also reminded committee members to complete their conflict of interest statement.
3. **Fall singles and doubles membership survey results.** NCAA staff provided background information and history to the oversight committee on the singles and doubles pilot. Staff also reviewed the survey results with the overall goal for the oversight committee to make a decision on the fall singles and doubles pilot before team selection in the spring.
4. **Sports Oversight Committee update and Division I governance structure.**
 - a. **Tennis oversight committee.** NCAA staff provided an overview of key responsibilities of the NCAA Division I Men's and Women's Tennis Championships subcommittee, legislative authority of the oversight committee, voting procedures, meeting cadence and participation, and future agenda topics.
 - b. **Electronic line calling.** The committee reviewed and approved the previous tennis committee's recommendation to permit an electronic line calling system approved by the Intercollegiate Tennis Association to be used during the preliminary rounds of the NCAA team championships if the host has used it throughout the season and the officials are trained to use it. It also agreed to permit ITA-approved electronic line calling systems to be used at the singles and doubles championships and team championships final site if available, effective for the 2025-26 championships.
 - c. **Committee chair.** The committee approved a waiver request to allow Alison Silverio, head women's tennis coach at the University of Notre Dame, formally elected by the previous tennis committee, to serve as overall chair, despite not being an administrator.

5. Fall individual championships.

- a. Committee travel.** NCAA staff provided an update on committee expectations for championship attendance and travel authorizations.
- b. Officials.** NCAA staff provided an update on officials' assignments for the fall singles and doubles championships.
- c. Host planning.** NCAA staff and the committee chair provided an update on planning for both the fall singles and doubles championships and the spring team championships site visits.

6. Other business. NCAA staff reminded committee members of upcoming Division I governance structure membership virtual trainings.

7. Future meetings. The committee will meet Wednesday, Oct. 8.
