

REPORT OF THE NCAA DIVISION II WOMEN'S VOLLEYBALL COMMITTEE SEPT. 25, 2025, VIDEOCONFERENCE

- **8. Triennial budget requests.** The committee received information about the triennial budget request timeline and process. The committee discussed options related to a three-weekend championship format.

- **10. Regional CRS requirement.** The committee discussed the membership's readiness to implement the required CRS system at regional host sites. The committee directed the championship manager to send communication to athletics directors, senior woman administrators and head coaches reminding them of the CRS system requirement to host a regional.
