SUBJECT: 2021 National Collegiate Beach Volleyball Information.

The following is important information concerning the 2021 season:

1. <u>Lineup Challenge Process</u>. For the 2021 season, coaches will be able to challenge pre- or post-match legality of team lineups and player movement regulations. Coaches will be required to fill out a challenge form and submit it to the NCAA within 24 hours after the start of the match. The committee will review the challenge and if it is determined that a player was played out of order, the team will forfeit the match at that position as well as receive a fine. Fines will be assessed according to the approved Competition Oversight Committee structure.

- 3. <u>Selection Criteria</u>. As a reminder the committee will select three teams from the East region, three teams from the West region and two teams at large.

Selection criteria for the regional bids (in-region comparison):

- a. Record versus regional opponents.
- b. Head-to-head competition.
- c. Results versus common opponents.
- d. Strength of schedule.
- e. Overall record. (For the 2020-21 academic year, the NCAA Division I Competition Oversight Committee waived the .500 rule for fall, winter and spring sports, which

normally requires teams to have overall won-lost records of .500 or better for at-large selections.)

Selection criteria for at-large bids.

- a. Head-to-head competition.
- b. Results versus common opponents.
- c. Strength of schedule.
- d. Overall record. (For the 2020-21 academic year, the NCAA Division I Competition Oversight Committee waived the .500 rule for fall, winter and spring sports, which normally requires teams to have overall won-lost records of .500 or better for at-large selections.)
- 4. <u>2021 Rules Modifications</u>. The 2021 rules modifications are now available by clicking here. Please note on the modifications those items highlighted in yellow as these are new for 2021. New modifications include: game jersey numbering; Playing Rules Changes Related to Commemorative/Memorial Uniform Patches; and duration of time-outs. - 5. <u>NCAA Scoresheet</u>. It is required that institutions use the NCAA scoresheet during competition. The scoresheet can be found <u>here</u>.
- 6. <u>Regular Season Survey</u>. The committee will be sending out a survey later this season requesting feedback from coaches on potential items that they will be discussing during their annual meeting. Please make sure to complete the survey.
- 7. <u>Selection Show</u>. The eight teams for the championship will be selected on Sunday May 2nd with the time to be determined, on NCAA.com.
