# EDUCATIONAL SUPPLEMENT: Team Lineups and Player Movement Regulation



MODIFIED 2/25

This educational supplement has been developed to further clarify the language and intent of the current NCAA Beach Volleyball Rules Modifications section: TEAM LINEUPS and PLAYER MOVEMENT REGULATIONS (pgs. 12-15). Additionally, this supplement is intended for use with the SAMPLE LINEUP Scenarios and associated LINEUP FORM Examples. Color has been incorporated for enhanced reference.

### <u>Lineup Regulations Made Simple(r)</u>

Regulation 1: Coaches must play their pairs (positions 1-5) in order of ability.

Note: The "order of ability" is a ranking of pairs that is determined by the coach. The coach must distinguish an order of ability. The coaches' order of ability ranking is NOT to be influenced by the anticipated lineup of an opposing team. Any attempt to "match-up" against a specific opponent by changing the order of pairs is inconsistent with this regulation.

Regulation 2: Player movement from position to position is permitted ONLY by one position up or down as determined by the previous match lineup. This permitted movement applies to each individual player.

Note: Regulation 2 is a **limitation**. This limitation, and the **Alternate** entry limitations, can create a conflict with the "order of ability" regulation. When such circumstances arise, the objective **limitation** (regulation 2) shall be the governing regulation applied.

#### Season Opening Status

All roster players will begin the season with status as either a <u>Player (Original Player)</u> or as an <u>Alternate (Alternate Player)</u>. Only after the first match is played may a player become a <u>Removed Player</u>.

### <u>Player</u>

Player status applies initially to only the ten (10) players in the lineup for the team's **first countable contest of the season.** An **Alternate** shall become a **Player** if, after performing in the lineup, that **Alternate** gets moved up or down one slot for an ensuing match instead of continuing in the same spot or returning to the Alternate list.

#### Alternate (A)

Full Alternate status applies initially to all roster players that were NOT in the lineup for the

team's first countable contest of the season. The **Alternates** are listed in the **Alternates** section of the lineup form.

A full status **Alternate** may enter the lineup at any position.

**Once entered into the lineup** and performing at a position, that **Alternate** may then:

- a) Be returned to the Alternates list for the next match; or
- b) Continue to play at the position entered, and thereby maintain **Alternate** player status until the player leaves the lineup from that position and returns to the **Alternates** list; or
- c) Be moved up or down a position per lineup regulation 2 above, resulting in the player losing Alternate status and becoming a Player. Once a Player, if she is subsequently removed from the lineup, she becomes a Removed Player, listed in the Removed Players section of the lineup form.

#### **Alternate Clarifications**

- An Alternate that has performed in a match and returns to the Alternates list per option a) or above, shall retain full Alternate status if the performance was at position 5; if the performance was at a higher position (1-4), the Alternate shall return to the Alternates list as a Limited Alternate with the 1-4 position played noted in the Limited column on the lineup form; Limited status Alternates may ONLY return to the lineup at the position previously performed, or at No. 5.
- There is no limit to the number of consecutive matches an **Alternate** may perform at the same position.
- There is no limit to the number of times an Alternate may enter at a specific position (either 5 or the "limited" position) and return to the Alternates list.
- A <u>Limited</u> <u>Alternate</u> may enter the designated 1-4 position OR the number 5 position and then return to the <u>Alternates</u> list without any change in status. There is no limit to how many times this may happen.
- An Alternate that plays at position 4, and then moves to position 5 for the ensuing match shall become a Player by regulation due to being moved up or down one spot and remaining in the lineup; the Alternate that plays at 4 may be returned to the Alternates list (and sit out a match), and then re-enter at position 5, but must sit out a match after performing at position 4 to retain Alternate status.

# Removed Player (RP)

A **Player** that is removed from the lineup, for any reason, becomes a **Removed Player** and shall be listed in the **Removed Players** section of the lineup form. A **Removed Player** may return to the active lineup ONLY in the position from which she was removed<sup>1</sup>. Once she has returned to the lineup and played at her return position, she may subsequently be moved under Lineup regulation 2. If she is removed again, she returns to the **Removed Players** list with the "last position played" designation which determines the only position at which she may return to the lineup.<sup>2</sup>

<sup>1</sup>In 2020, the NCAA Women's Beach Volleyball Committee modified the TEAM LINEUPS and PLAYER MOVEMENT REGULATIONS by adopting a protocol to adjust a student-athlete's returning spot if a student-athlete is out of the lineup for a significant amount of time due to injury, academics, etc. Please reference the current NCAA Beach Volleyball Rules Modifications (pg. 8) for complete details. <sup>2</sup>In 2025, the NCAA Women's Beach Volleyball Committee modified the TEAM LINEUPS and PLAYER MOVEMENT REGULATIONS by clarifying that a Player may be removed from the official team lineup in the event of injury or illness and until The Toss (as defined by Rule 7.1 in the USA Volleyball 2023-2025 Beach Rules Book) for the affected Pairs match. <sup>\*</sup> This move, under the **Alternate** regulation, is permissible. However, the fact that **Alternates** may enter the lineup at any position does not permit a violation of the order of ability regulation. Since **Alternates** may enter at any position, the proper lineup will have **Alternates** entering as a pair positioned in the correct order of ability as judged by the head coach. If this pair did not play in Match 1 because they were deemed to be the sixth best pair in order of ability, then the correct entry position for Match 2 would be a position 5.
