

REPORT OF THE NCAA DIVISION I MEN'S WRESTLING OVERSIGHT COMMITTEE OCTOBER 7, 2025, VIDEOCONFERENCE

ACTION ITEMS.

INFORMATIONAL ITEMS.

- 1. Rules update. The committee received a report from Jimmy Chung, the secretary-rules editor. As of October 6, there were 383 officials registered in RQ+ as opposed to 420 at the same time last year. The deadline for officials to register is October 18.
- **2. Officiating update.** The committee received a report from Mike McCormick, the national coordinator of officials, who attended the Intercollegiate Wrestling Officials Association Conference Oct. 3-4 in Saint Louis.
- **3. Student-athlete member appointment.** The committee appointed Noah Mulvaney, a junior at Bucknell University, as the student-athlete representative to the oversight committee.
- **4. Legislative update.** The committee requested having the transfer portal window moved back to the month of April. In addition, the committee requested to have the first permissible contact for recruitable student-athletes be April 1 of their junior year. The committee was instructed that the Division I Cabinet was reviewing both topics and further instruction on timing and ability to change both items would be coming later this fall.
- **5. Selection of coaches for ranking polls for 2025-26 season.** The committee discussed the nominees but ran out of time for selection. The committee agreed to convene Oct. 16 to select the coaches.
- **6. Mock selection show for coaches.** The committee liked the idea of recording an education session for coaches on the selection process and instructed staff to develop one prior to the end of the year.
- 7. Automatic qualification. The committee approved the following conferences for automatic qualification in 2025-26: Atlantic Coast Conference, Big Ten Conference, Big 12 Conference, Eastern Intercollegiate Wrestling Association, The Ivy League, Mid-American Conference, Pac-12 Conference and Southern Conference.
- **8. Annual meeting date.** The committee discussed conducting its annual meeting in mid-April but is waiting to verify whether meetings would be virtual or in-person to confirm the date.
