INFORMATIONAL ITEMS.

1. **NCAA Division I Cabinet Referral Regarding Notification of Transfer Window in Football.** The NCAA Division I Academics and Eligibility Committee discussed a referral from the NCAA Division I Cabinet regarding the impact of the new football notification of transfer period on quarter institutions. The Academic and Eligibility Committee recognizes the unique challenges schools with early term start dates experience but noted that these nuances are best addressed through institutional processes. Additionally, the Academics and Eligibility Committee expressed concern with allowing student-athletes to engage in athletics activities and receive revenue share payments without being an enrolled student and possible unintended consequences of this flexibility such as delayed graduation. Finally, the Academics and Eligibility Committee determined that calendar and enrollment issues are best addressed at the institutional level and should not be a basis for relief of the full-time enrollment requirement.
2. **NCAA Eligibility Center Update.** The Academics and Eligibility Committee received an update from the NCAA Eligibility Center staff regarding academic and athletic eligibility certification data and trends for incoming prospective student-athletes.
3. **Report of the NCAA Division I Academics and Eligibility Committee November 21 meeting.** The Academics and Eligibility Committee reviewed and approved the report from its November 21 meeting.
4. **Overview of the Public Release of the NCAA Division I Graduation Success Rate Data for Student-Athletes Entering College in 2018-19.** Due to time constraints, the committee will address this agenda item at its next meeting.
