

REPORT OF THE NCAA DIVISION I BOARD OF DIRECTORS JUNE 28, 2024, VIDEOCONFERENCE

INFORMATIONAL ITEMS.

- 1. Approval of Institutions Moving to Active Division I Membership or Football Bowl Subdivision Status. The NCAA Division I Board of Directors approved active Division I membership status for the following institutions that successfully completed the four-year process of reclassifying from Division II: (Unanimous voice vote.)
 - a. Bellarmine University;
 - b. Tarleton State University;
 - c. University of California, San Diego; and
 - d. Utah Tech University.

In addition, the board approved active FBS membership status for the following institutions that successfully completed the applicable reclassification processes: (*Unanimous voice vote.*)

- a. Jacksonville State University;
- b. James Madison University; and
- c. Sam Houston State University.
- 2. NCAA Division I Board of Directors Finance Committee Report. The Division I Board of Directors Finance Committee reviewed results from a recently completed membership survey regarding the creation of a women's basketball performance fund. Changes to the revenue distribution formula require a legislative vote of the Division I membership, which is anticipated to occur at the January 2025 NCAA Convention. The deadline for sponsorship of a legislative proposal requires the Board of Directors to sponsor a proposal during its August meeting. If adopted by the membership, the fund would pay out beginning with the 2025-26 fiscal year based on performance in the 2024-25 NCAA Women's Basketball Championship. The Board of Directors Finance Committee meets August 1 and will develop a recommendation for the board's consideration during its August 6 meeting.
- **3. NCAA Division I Council Update.** The Board of Directors received an update regarding key actions taken during the council's June 25-26 meeting.
- **4. Legal Landscape Update.** The Board of Directors received an update on issues related to the proposed settlement of key legal cases, including opportunities to organize the decision-making structure and establish priorities.

- 5. Update from NCAA President Charlie Baker. President Baker updated the board on issues affecting the Association in general and particularly those impacting Division I, including the success to date of the NCAA's fan database and the upcoming launch (August 1) of the NCAA's post-eligibility insurance program.
