

REPORT OF THE NCAA DIVISION I BOARD OF DIRECTORS INFRACTIONS PROCESS COMMITTEE JUNE 8, 2021, VIDEOCONFERENCE

- 1. Continued Engagement with Stakeholders. As part of its ongoing effort to collect input from stakeholders to help inform recommendations regarding the infractions process, the NCAA Division I Board of Directors Infractions Process Committee received a presentation and engaged in discussion with outside counsel who represent institutions and individuals in the infractions process. The committee appreciated the conversation and noted that it helped identify specific areas in which the committee may want to discuss further as it formulates future recommendations.
- 2. **Division I Infractions Appeal Process Debrief.** The Infractions Process Committee discussed the comprehensive presentations received during the committee's April 13 and May 25 videoconferences on the infractions appeals process.
- **3. Further Review of Identified Tension Points.** The Infractions Process Committee reviewed a revised inventory of tension points gleaned from the constituents who have had the opportunity to engage with the committee thus far and agreed they are developed enough for staff to begin activating next steps, including seeking additional feedback from constituents in specific areas and positioning the committee to consider how best to prioritize the tension points in order to facilitate the development of recommendations.
- **4. Review of Committee Charge and Priorities.** The Infractions Process Committee reviewed its charge from the NCAA Division I Board of Directors and noted the following priority areas and items to be addressed moving forward:

	• Ensure efficient use of available tools.
	• Identify new tools to be used during investigation and adjudication.
	• More effectively communicate and advocate for process/outcomes.

Transparency	• Infractions Process Committee is the conduit for timely interaction

Rules	• Determine whether violation levels are categorized appropriately.
Modernization	• Focus time and resources on rules that are integral to the division.
