ARCHIVED BLANKET WAIVER REQUESTS
Updated April 17, 2024

The NCAA Division I Committee for Legislative Relief and NCAA academic and membership affairs staff have authority to decide most NCAA Division I legislative relief requests, including blanket waivers of legislation.

The NCAA Division I Committee for Legislative Relief has authority to issue blanket legislative relief for the NCAA Division I membership. In addition, the NCAA Division I Council and/or one of its standing committees may request the academic and membership affairs staff to issue blanket legislative relief for the Division I membership in some circumstances.

The NCAA academic and membership affairs staff maintains authority to issue blanket legislative relief in certain situations. Staff will decide on blanket waivers in the following situations: (1) Blanket waiver requests resulting from newly adopted legislation; and (2) Blanket waiver requests from the NCAA Division I Council (or one of its standing committees), NCAA Division I Board of Directors or the NCAA Board of Governors.

Blanket legislative relief may only be provided for certain time periods (e.g., academic years or terms, weekends) or circumstances (e.g., COVID-19 recruiting dead period, National Championship events). The effective date (s) of the waivers listed below have expired and are no longer considered active relief of the legislation. Additionally, for blanket waivers that are older than five years, the Request/Self Reports Online (RSRO) cases tied to the blanket waiver request have been archived.

NCAA Division I Committee for Legislative Relief Administrative Committee Blanket Waiver: Student-Athlete Participation in 2023 Major League Soccer College Showcase - Approved November 8, 2023.

ARCHIVE INFO: EFFECTIVE ONLY FOR DECEMBER 6-9, 2023.

The NCAA Division I Committee for Legislative Relief Administrative Committee approved a blanket waiver to permit men's soccer student-athletes to participate in the 2023 Major League Soccer (MLS) College Showcase for a period that exceeds 48 hours. Further, the blanket waiver permits participation in the showcase without considering it as the student-athletes one permissible tryout with a professional sports organization after initial full-time enrollment.

In granting this request, the Committee for Legislative Relief Administrative Committee noted:

1. MLS will conduct the College Showcase from December 6-9, 2023;
2. MLS will invite and provide expenses to approximately 44 draft eligible student-athletes;

3. Extending the tryout length beyond 48-hours supports student-athlete health and well-being by providing additional time for the professional teams to conduct a comprehensive evaluation of the participating student-athletes without all necessary activities having to occur within a 48-hour time period;
4. A student athlete who is invited to participate in the College Showcase may miss class for such participation;
5. Similar relief exists in sport-specific legislation in basketball and ice hockey; and
6. The NCAA Division I Student-Athlete Experience Committee supports the blanket waiver request.

NCAA Division I Blanket Waiver Women's Basketball Student Managers and Noncoaching Sport-Specific Staff Members Serving as Practice Players During the 2023-24 Season - Approved October 3, 2023

ARCHIVE INFO: BLANKET RELIEF EFFECTIVE ONLY FOR THE 2023-24 WOMEN'S BASKETBALL REGULAR SEASON.

At the recommendation of the NCAA Division I Women's Basketball Oversight Committee, the NCAA academic and membership affairs staff approved a blanket waiver request permitting women's basketball student managers and up to two women's basketball noncoaching staff members with sport-specific responsibilities to also serve as practice players during the 2023-24 playing season.

In granting this request, staff noted:

1. This waiver is effective immediately, and is an extension of previous blanket waivers which provided flexibility for women's basketball student managers and noncoaching staff members with sport-specific responsibilities to serve as practice players during the 2021-22 and 2022-23 playing seasons;
2. The student manager and noncoaching staff position(s) existed as of October 3, 2023;
3. The names of designated noncoaching staff positions that will be serving as practice players must be designated by the institution and kept on file in the institution's athletics department;
4. This waiver does not permit women's basketball student managers or noncoaching staff members with sport-specific responsibilities who are not counted within the institution's coaching limitations who are performing practice player duties to engage in on-court coaching activities;
5. This waiver provides flexibility for institutions to conduct on-court countable athletically related activities and practice activities with the typical number of staff and practice players to assist in on-court activities;

6. The Women's Basketball Coaches Association will study this issue and work with the Women's Basketball Oversight Committee to determine if legislation in this area should be sponsored in the future;
7. This waiver is in effect until the conclusion of the institution's 2023-24 regular season schedule;
8. This waiver does not apply to the NCAA Division I Championship as it is under the purview of the NCAA Division I Women's Basketball Committee, who will take up that discussion separately at a future meeting; and
9. This waiver does apply to other events (e.g., conference championships, WBIT, WNIT) unless these events have a rule that precludes this waiver from applying to the events.

NCAA Division I Committee for Legislative Relief - Football Championship Subdivision - Exempt Postseason Participation from Counting Toward Use of a Season of Competition - Approved October 3, 2023

ARCHIVED INFO: EFFECTIVE ONLY FOR THE 2023-24 FOOTBALL POSTSEASON CONTESTS.

At the request of the NCAA Football Championship Subdivision Oversight Committee, the NCAA academic and membership affairs approved a blanket waiver request in championship subdivision football to exempt postseason participation (e.g., 2023-24 NCAA Division I Football Championship, 2023 Celebration Bowl) from the limit of four contests a student-athlete may participate in without using a season of competition.

In granting this request, staff noted:

1. The blanket waiver is applicable to postseason competition that occurs during the 2023-24 academic year;
2. The recent adoption of the notification of transfer window and the necessity of accelerated discussions and decisions for student-athletes and coaches regarding future participation opportunities;
3. The potential impact of student-athletes opting out of participation in postseason competition on participating football student-athletes; and

4. The Football Championship Subdivision Oversight Committee (FCS) agreed that the newly created Football Bowl Subdivision (FBS) and the FCS Oversight Committees will continue to review football's season-of-competition rule.

NCAA Division I Men's Basketball Oversight Committee Legislative Relief Waiver of the Contact when Classes are in Session Legislation - *Approved August 31, 2023*

ARCHIVE INFO: NCAA DIVISION I PROPOSAL 2023-47 EFFECTIVE JANUARY 10, 2024.

At its August 24, 2023, meeting, the NCAA Division I Men's Basketball Oversight Committee Legislative Subcommittee (acting on behalf of the NCAA Division I Men's Basketball Oversight Committee) requested a blanket waiver to permit contact to occur with a men's basketball prospective student-athlete at the prospective student-athlete's educational institution during the time of day when classes are in session when it is otherwise permissible to have contact during the academic year recruiting period. The Men's Basketball Oversight Committee recently introduced legislation into the January 2024 legislative cycle to eliminate the prohibition in men's basketball on contact at a prospective student-athlete's educational institution during the time of day when classes are in session; however, the Men's Basketball Oversight Committee recognized that the new legislation would not be effective until January 2024 thus the blanket waiver was recommended to provide men's basketball coaches with an opportunity to engage in this form of contact during the entirety of the 2023-24 academic year recruiting period.

Pursuant to NCAA Division I Committee for Legislative Relief policies and procedures, the NCAA academic and membership affairs staff approved the waiver with conditions on August 30, 2023.

Waiver Conditions.

- One-time waiver request; and
- The blanket waiver will expire at the conclusion of the 2023-24 academic year recruiting period (e.g. currently scheduled to end on May 2, 2024).

Waiver Rationale.

1. In sports other than basketball, contact is permitted with prospective student-athletes at their educational institutions during the time of day when classes are in session;
2. Current legislation, in all sports, requires an educational institution's executive officer to provide permission for an institution's coaching staff member to have contact with a

- prospective student-athlete at the educational institution which provides an appropriate guardrail that ensures there is not a disruption to a prospective student-athlete's school day;
3. NCAA Division I Proposal No. 2022-6 (RECRUITING – CONTRACT RESTRICTIONS AT SPECIFIED SITES – PROSPECTIVE STUDENT-ATHLETE'S EDUCATIONAL INSTITUTION – NO CONTACT WHEN CLASSES ARE IN SESSION – SPORTS OTHER THAN BASKETBALL) would have extended the prohibition in basketball against recruiting contact at a prospective student-athlete's educational institution during the time of day when classes are in session to all other sports. This proposal was tabled in April 2022 pending a review of recruiting legislation and defeated in April 2023 based on the application of the sunset provision;
 4. The ability for Division I men's basketball coaches to meet with a prospective student-athlete at their educational institution alongside other academic stakeholders such as school administrators, teachers, counselors and coaches supports the academic success of men's basketball prospective student-athletes;
 5. The waiver maintains the goal of the NCAA and its members to increase the scholastic influence and minimize the involvement of outside third parties in the recruiting process;
 6. Allows men's basketball coaches to travel to prospective student-athlete's educational institutions during times that do not impact their team's practice and competition schedules which allows for more time with their own student-athletes during the playing season and supports student-athlete well-being; and
 7. The National Association of Basketball Coaches supports the waiver request.

Finally, the NCAA Division I Women's Basketball Oversight Committee reviewed this blanket waiver during its August 30 meeting and noted its support for maintaining the current legislation in women's basketball.

NCAA Division I Committee for Legislative Relief- Football Bowl Subdivision- Limit on the Number of Preseason Practice Participants - *Approved July 21, 2023*

ARCHIVED INFO: EFFECTIVE ONLY FOR THE 2023 FOOTBALL PREASESON.

The NCAA Division I Committee for Legislative Relief Administrative Committee approved a blanket waiver to permit Football Bowl Subdivision (FBS) institutions to increase the football preseason participant limit from 110 to 120 for the 2023-24 academic year.

The blanket waiver does not modify any current legislative exceptions to replace student-athletes who voluntarily withdraw or sustain an injury that prevents further participation in preseason activities.

In granting this request, the Committee for Legislative Relief Administrative Committee noted:

1. The waiver is only applicable for FBS institutions for the 2023-24 academic year;
3. The NCAA Division I Football Oversight Committee supported the request;
4. The current legislated limit did not contemplate the impact of the COVID-19 season-of-competition waiver on roster sizes; and

4. The Football Oversight Committee will continue to review the legislation and decide whether to introduce legislation for future academic years.

NCAA Division I Committee for Legislative Relief Blanket Waiver Football Annual Signing (FBS) and Initial Counter (FBS/FCS) Limits - *Approved June 27, 2023*

ARCHIVE INFO: NCAA DIVISION I PROPOSAL 2023-32 EFFECTIVE OCTOBER 4, 2023.

At the request of the NCAA Division I Football Oversight Committee, NCAA the academic and membership affairs staff extended, for an additional year (i.e., through the 2024-25 academic year), the May 18, 2022, blanket waiver that suspends the annual signing (FBS) and initial counter (FBS/FCS) limits.

The blanket waiver continues to permit institutions to award athletics aid (National Letter of Intent, institutional offer of athletics aid) based on the overall counter limit (85) and in championship subdivision football, the annual equivalency limit (63).

In granting the request, staff noted:

1. During the June 27-28, 2023, NCAA Division I Council meeting, the council introduced legislation to eliminate the annual signing and initial counter limits, based on a recommendation from the Football Oversight Committee; and,
2. The current blanket waiver expires before the 2024-25 academic year and institutions are already planning recruiting philosophies and distribution of athletics aid for the 2024-25 academic year. This extension provides institutions certainty when planning for the next recruiting class while the council considers a legislative solution.

NCAA Division I Committee for Legislative Relief--- Football--- Number of Official Visits--- Institutional Limits - *Approved June 27, 2023*

Archive Info: NCAA DIVISION I PROPOSAL NO. 2023-44 EFFECTIVE APRIL 1, 2024.

At the request of the NCAA Division I Football Oversight Committee, the NCAA academic and membership affairs staff approved a blanket waiver request to permit Football Bowl Subdivision and NCAA Football Championship Subdivision institutions to increase the institutional official visits limit in the sport of football by 14 (e.g., 56 to 70) during the period of April 1, 2023, through March 31, 2024.

The blanket waiver does not modify any current legislative exceptions for official visits. For example, an institution remains able to use up to six visits retained from April 1, 2022, through March 31, 2023, and Bylaw 13.6.2.2.7 (Head Coaching Change) remains available.

This blanket waiver is only effective through March 31, 2024. Once NCAA Division I Proposal No. 2023-44 goes into effect on April 1, 2024, the blanket waiver and exceptions listed below shall not be applied.

In granting this request, staff noted:

1. The waiver is applicable only for the April 1, 2023, through March 31, 2024, annual official visit cycle. This limited relief from the institutional official visit limit provides appropriate short-term flexibility and promotes responsible recruiting practices;
2. An institution may continue to provide additional official visits (up to 25% of the limitation for football) after a new head coach is hired, provided the previous head coach used 75% or more of the official visits permitted for the April 1, 2023, through March 31, 2024, recruiting cycle;
3. An institution may retain up to six unused visits from the April 1, 2022, through March 31, 2023, recruiting cycle for the next April 1, 2023, through March 31, 2024, recruiting cycle and the blanket waiver allows the Football Oversight Committee additional time to consider legislative solutions. The Football Oversight Committee will continue to review football's official visit rules, including the timing of the annual official visit cycle, and determine if exceptions to institutional official visit limitations (e.g., head coach change, unused visits) are necessary with a potential legislated increase. Institutions should remain aware of the Football Oversight Committee's review of football's official visit rules when planning for future recruiting cycles.

NCAA Division I Committee for Legislative Relief -- Football Bowl Subdivision Exempt Postseason Participation from Counting Toward Use of a Season of Competition - *Approved June 27, 2023*

ARCHIVE INFO: EFFECTIVE ONLY FOR 2023-24 FOOTBALL POSTSEASON CONTESTS.

At the request of the NCAA Division I Football Oversight Committee, the NCAA academic and membership affairs staff approved a blanket waiver request in bowl subdivision football to exempt postseason participation (conference championship game, bowl game, College Football Playoff contest(s) from the limit of four contests a student-athlete may participate in without using a season of competition.

In granting this request, staff noted:

1. The blanket waiver is applicable to postseason competition that occurs during the 2023-24 academic year;
2. The recent adoption of the notification of transfer window and the necessity of accelerated discussions and decisions for student-athletes and coaches regarding future participation opportunities;
3. The potential impact of football student-athletes opting out of participation in postseason competition on participating football student-athletes; and
4. The blanket waiver allows the Football Oversight Committee additional time to consider legislative alternatives to football's season-of-competition legislation.

NCAA Division I Committee for Legislative Relief Blanket Waiver: Baseball 2022-23 Maximum Official Visit Limit – *Approved May 22, 2023*

ARCHIVE INFO: EFFECTIVE FOR 2022-23 ACADEMIC YEAR ONLY.

The NCAA Division I Committee for Legislative Relief approved the blanket waiver in baseball, to permit institutions to provide up to 40 official visits during the 2022-23 academic year.

In granting this request, the Committee for Legislative Relief noted:

1. This is a one-time waiver request applicable through July 31, 2023, (the conclusion of the 2022-23 official visit cycle) and the Committee for Legislative Relief encouraged the baseball community to pursue a legislative solution for future recruiting cycles;
2. A one-time increase in the institutional official visit limit from 25 to 40 provides institutions additional flexibility to allocate official visits between high school junior, high school senior and transfer prospective student-athletes;
3. The waiver provides similar relief to previous blanket waivers issued, in baseball, following the adoption of Division I Proposal No. 2017-111, which permitted institutions to provide junior prospective student-athletes official visits in sports other than basketball and football; and
4. The NCAA Division I Student-Athlete Experience Committee and the American Baseball Coaches Association support the waiver request.

NCAA Division I Committee for Legislative Relief Blanket Waiver Men's and Women's Basketball -- Number of Official Visits -- Institutional Limitations – *Approved March 8, 2023*

ARCHIVE INFO: BLANKET RELIEF ONLY PROVIDED THROUGH JULY 31, 2023.

At the request of the NCAA Division I Men's and Women's Basketball Oversight Committees, the NCAA academic and membership affairs staff approved a blanket waiver to allow institutions to provide 35 official visits (increase of 25%) in men's basketball and 30 official visits (increase of 25%) in women's basketball over the period of August 1, 2021, through July 31, 2023. This would be an increase of seven official visits in men's basketball and six official visits in women's basketball prior to July 31, 2023, and would capture the rolling two-year period of 2021-22 and 2022-23.

The blanket waiver does not modify any current legislative exceptions for official visits.

In granting this request, staff noted:

1. This addresses the impact of recent changes in NCAA legislation (e.g., one-time transfer exception, NCAA Transfer Portal windows) by providing additional official visits to help institutions address possible roster depletion.
2. The waiver is applicable through July 31, 2023, and provides relief of the rolling two-year period of August 1, 2021, through July 31, 2023. This one-time waiver gives limited relief from the institutional official visit limit, provides appropriate short-term flexibility, and promotes responsible recruiting practices.
3. The Men's and Women's Basketball Oversight Committees will gather additional data on the use of official visits and consider whether to recommend a legislative change.

Finally, staff noted if legislation regarding the men's basketball and women's basketball official visit institutional limitations has not changed prior to August 1, 2023, then the rolling two-year period

limit resets to 28 official visits for men's basketball and 24 for women's basketball for the ensuing rolling two-year period of August 1, 2023, through July 31, 2025.

NCAA Division I Committee for Legislative Relief Blanket Waiver Use of Spider Pads during the 2023 Football Spring Practice Period (FBS/FCS) - *Approved February 13, 2023*

ARCHIVE INFO: NCAA DIVISION I PROPOSAL NO. 2023-31 EFFECTIVE OCTOBER 4, 2023.

At the recommendation of the NCAA Division I Football Oversight Committee Administrative Subcommittee, the NCAA academic and membership affairs staff approved a blanket waiver to permit the use of spider pads during noncontact practices for the 2023 football spring practice period. The blanket waiver permits FBS and FCS student-athletes to wear headgear and spider pads during any spring noncontact practice session.

In granting the request, staff noted:

1. One-time waiver request for the 2023 football spring practice period;
2. Noncontact practice sessions during the spring practice period may involve only headgear and spider pads as protective equipment; and
3. The NCAA Division I Football Competition Committee and Football Oversight Committee Administrative Subcommittee supported a consistent approach to the use of headgear and spider pads during noncontact practice sessions throughout the football playing seasons model.

NCAA Division I Committee for Legislative Relief Blanket Waiver -- Student-Athlete Participation in 2023 USA Baseball/Major League Baseball Draft Combine - *Approved February 8, 2023*

ARCHIVE INFO: BLANKET RELIEF ONLY PROVIDED FOR 2023 USA BASEBALL/MLB DRAFT COMBINE.

The NCAA Division I Committee for Legislative Relief approved a blanket waiver to permit baseball student-athletes to participate in the 2023 USA Baseball/MLB Draft Combine for a period that exceeds 48-hours. Further, the blanket waiver permits participation in the draft combine without considering it as the student-athlete's one permissible tryout with a professional sports organization after initial full-time enrollment.

In granting this request, the Committee for Legislative Relief noted:

1. USA Baseball will conduct the third USA Baseball/MLB Draft Combine;
2. USA Baseball and MLB will provide expenses to approximately 150 draft-eligible four-year college participants and approximately 150 high school participants to attend the event;
3. Extending the tryout length beyond 48 hours supports student-athlete health and well-being by providing additional time for the professional teams to conduct a comprehensive evaluation of the participating student-athletes without all necessary activities having to occur within a 48-hour time period;
4. The NCAA Division I Student-Athlete Experience Committee supports the blanket waiver; and
5. The blanket waiver provides relief similar to existing sport-specific legislation in basketball and ice hockey.

NCAA Division I Committee for Legislative Relief- Certified Audit (FBS)- - *Approved January 11, 2023.*

ARCHIVE INFO: BLANKET RELIEF ONLY PROVIDED FOR 2022-23 ACADEMIC YEAR.

At the recommendation of the NCAA Division I Football Oversight Committee, the NCAA Division I Council approved a waiver of Bylaw 20.10.9.3.2 (certified audit) for the 2022-23 academic year. FBS institutions will not be required to undertake an annual certified audit verifying its football attendance for 2022-23.

NCAA Division I Blanket Waiver Football -- Number of Official Visits -- Institutional Limitations - *Approved December 22, 2022*

ARCHIVE INFO: BLANKET RELIEF ONLY PROVIDED FOR 2022-23 FOOTBALL RECRUITING PERIOD.

At the request of the NCAA Division I Football Oversight Committee, the NCAA academic and membership affairs staff approved a blanket waiver request to permit Football Bowl Subdivision and NCAA Football Championship Subdivision institutions to increase the institutional limits on official visits by 14 (e.g., 56 to 70) during the period of April 1, 2022, through March 31, 2023.

The blanket waiver does not modify any current legislative exceptions for official visits. For example, an institution remains able to use up to six visits retained from April 1, 2021, through March 31, 2022, and Bylaw 13.6.2.3.7 (Head Coaching Change) remains available.

In granting this request, staff noted:

1. The impact of recent changes in NCAA legislation (e.g., one-time transfer exception, NCAA Transfer Portal windows, current blanket waiver of football's initial counter and annual signing limit rules) by providing additional official visits to help institutions address possible roster depletion;
2. The waiver is applicable only for the April 1, 2022, through March 31, 2023, annual official visit cycle. This one-time, limited relief from the institutional official visit limit provides appropriate short-term flexibility and promotes responsible recruiting practices;
3. The Football Oversight Committee will gather additional data on the use of official visits and consider whether to recommend a legislative change;
4. An institution may continue to provide additional official visits (up to 25% of the limitation for football) after a new head coach is hired, provided the previous head coach used 75% or more of the official visits permitted for the April 1, 2022, through March 31, 2023, recruiting cycle; and
5. An institution may retain up to six unused visits from the April 1, 2022, through March 31, 2023, recruiting cycle for the next April 1, 2023, through March 31, 2024, recruiting cycle. Institutions should remain aware of the Football Oversight Committee's review of institutional limits on official visits when planning for future recruiting cycles.

postseason participation from the limit of four contests a student-athlete may participate in without using a season of competition.

In granting this request, staff noted:

1. The blanket waiver is a one-time approval for the 2022-23 academic year and is applicable to postseason competition that occurs after December 15, 2022;
2. The recent adoption of the notification of transfer window and the necessity of accelerated discussions and decisions for student-athletes and coaches regarding future participation opportunities;
3. The impact of student-athletes opting out of participation in postseason competition.
4. A majority of FBS conferences support the blanket waiver request; and
5. This blanket waiver provides additional time for the Football Oversight Committee to review the impact of season-of-competition legislation in football and explore a future legislative concept.

1. The replaced student-athlete no longer participates as a member of the team in countable athletically related activities; and
2. In cross country, field hockey, soccer, track and field and men's water polo, the student who is replaced must have exhausted eligibility and must remain enrolled at the institution.

In granting this request, the Committee for Legislative Relief Administrative Committee noted:

1. The intent of midyear replacement legislation is to allow an institution to provide financial aid to another deserving student-athlete by replacing a graduated student-athlete who will no longer participate as a member of the team;
2. The impact of increased enrollment in summer school and participation in voluntary and required summer athletics activities on student-athlete eligibility and graduation timelines;
3. The impact of the NCAA Division I COVID-19 season-of-competition and extension-of-eligibility blanket waivers on student-athlete's eligibility and graduation timelines; and
4. The one-time blanket waiver provides short-term relief to allow for additional discussion and review of a future legislative solution.

1. MLS will conduct the College Showcase from December 9-12, 2022;
2. MLS will invite and provide expenses to approximately 45 draft eligible student-athletes;
3. Extending the tryout length beyond 48-hours supports student-athlete health and well-being by providing additional time for the professional teams to conduct a comprehensive evaluation of the participating student-athletes without all necessary activities having to occur within a 48-hour time period;
4. Similar relief exists in sport-specific legislation in basketball and ice hockey; and
5. The Student-Athlete Experience Committee supports the blanket waiver request.

3. The Student-Athlete Experience Committee supported one-time relief for the 2022-23 academic year only, due to the ongoing work of the Transformation Committee and NCAA Division I Legislative Committee Modernization of the Rules Subcommittee; and
4. The one-time waiver approval provides the Men's Lacrosse Coaches Association time to pursue a legislative solution in the future.

2. Relief is only provided from the conclusion of the student-athlete's playing season until the student-athlete withdraws from the draft, or not later than 10 days after the conclusion of the NBA Draft combine, whichever is earlier; and
3. A student-athlete shall not miss class in conjunction with such training activities.

In granting this request, staff noted:

1. The Commission on College Basketball recommended that men's basketball student-athletes receive a meaningful assessment of their professional prospects and be able to receive assistance from certified agents;
2. After a Division I men's basketball student-athlete signs a SPAC, an NCAA-certified agent can permissibly provide the student-athlete (and family members) with transportation,

lodging and meal expenses associated with meeting with the agent or a professional team;
and

3. Men's basketball student-athletes preparing for the NBA Draft and NBA Draft Combine regularly employ outside trainers to obtain a meaningful assessment of their professional prospects.

2. This blanket waiver does not permit a noncoaching staff member to engage in coaching activities;
3. Similar blanket waivers were issued for sports other than basketball and football during the 2020-21 and 2021-22 academic years and this blanket waiver provides additional time for the NCAA Division I Legislative Committee Modernization of the Rules Subcommittee to develop personnel legislative concepts;

1. Two-year college PSA would have exhausted their two-year college athletics eligibility at the conclusion of the 2021-22 basketball season but for an additional year of two-year college eligibility provided during the 2020-21 basketball season due to COVID-19 pandemic;
2. Two-year college PSA must have graduated from a two-year college or will graduate from a two-year college at the conclusion of the 2022 summer term;
3. Two-year college PSA must meet all other criteria in the basketball on-campus evaluation legislation (see NCAA Bylaw 13.11.2.1); and
4. Relief is only provided when official and unofficial visits may occur through August 5, 2022, in men's basketball and through August 13, 2022, in women's basketball in order to assist Division I institutions in roster management decisions prior to the start of 2022 fall term.

In granting the request, the Committee for Legislative Relief noted the following:

- But for the additional year of two-year college eligibility provided during the 2020-21 basketball season as a result of the COVID-19 pandemic, these two-year college PSAs would have exhausted their two-year college athletics eligibility at the conclusion of the 2021-22 basketball season and would have been able to participate in an on-campus basketball evaluation;
- Blanket waiver allows two-year college PSAs and Division I institutions to make a more informed decisions in the recruiting process which may reduce the chance of transfer in the future; and
- Cohort of two-year college PSAs who are eligible to use the blanket waiver relief have already graduated from a two-year college or are on track to graduate from a two-year college this summer and are seeking to move to the next step in their academic experience by pursuing a degree at a four-year institution.

The blanket waiver does not permit Football Bowl Subdivision institutions to conduct on-campus evaluations.

In June 2022, an NCAA Football Championship Subdivision institution may conduct an on-campus evaluation with a high school junior (class of 2023), high school senior (class of 2022) and two-year college transfer or four-year college transfer prospective student-athlete (PSA), provided:

1. The on-campus evaluation must be conducted during a PSA's unofficial visit to the institution and after the PSA's scholastic season has concluded; and
2. Before participating in the on-campus evaluation, the PSA must undergo a medical examination or evaluation administered in accordance with the requirements in NCAA Division I Bylaw 13.11.2.10- (g) (On-campus Evaluations- Basketball).

In granting the request, staff noted:

2. An institution may not conduct an on-campus evaluation with more than one PSA at the same time;
3. The on-campus evaluation activities (other than medical examination or evaluation) may not exceed one hour;
3. All activities must be noncontact and no protective equipment may be worn by the PSA;
4. The institution may not issue apparel or equipment to the PSA; and,
5. Only countable coaches and graduate assistant coaches may conduct the on-campus evaluation with the PSA.

The waiver has been effective since April 25, 2022, and will continue to apply until NCAA Division I Proposal No. 2022-30 goes into effect on July 1, 2023.

In granting this extension request, the academic and membership affairs staff noted relief may only be provided when:

1. One or more of the head and/or assistant coaches are not in attendance for countable athletically related activities (e.g., practice, film review);
2. The noncoaching staff position(s) existed as of April 1, 2022;
3. The names of designated noncoaching staff positions must be designated by the institution and kept on file in the institution's athletics department;
4. No more than four coaches and noncoaching staff members (six for the national service academies) combined engage in providing instruction to student-athletes at any one time; and
5. Relief expires on June 30, 2023.

Please note, this action also allows the designated noncoaching staff member(s) to participate in skill-instruction activities as practice players.

3. The waiver provides similar relief to a previous blanket waiver issued in baseball following the adoption of NCAA Division I Proposal No. 2017-111, which permitted institutions to provide junior PSAs official visits in sports other than basketball and football; and
4. The NCAA Division I Student-Athlete Experience Committee and NCAA Division I Baseball Committee support the waiver request.

In granting this request, the Committee for Legislative Relief noted:

1. The combination of unforeseen and uncontrollable circumstances resulting in a significant number of student-athletes returning to Division I baseball, a sport which carries a rigid roster and financial aid limits which include, but are not limited to:
 - The American Baseball Coaches Association (ABCA) indicated general support for a permanent legislative change to the overall roster and counter limits and the minimum equivalency value legislation which may be introduced in a future legislative cycle; and
 - The uncertainty surrounding the structure and timing of the 2022 Major League Baseball (MLB) draft due to ongoing collective bargaining agreement negotiations between the MLB and MLB Players Association which may result in additional student-athletes returning to their respective institutions during the 2022-23 academic year.
2. The additional counters (up to five) must be included in the maximum team equivalency limit (11.7) and must be provided the minimum individual equivalency value (25%);
3. The Baseball Committee supports the waiver request; and

4. This is a one-time waiver request for the 2022-23 academic year and the Committee for Legislative Relief encouraged the ABCA to consider recommending legislative proposals for the Student-Athlete Experience Committee to review.

In granting this request, the Committee for Legislative Relief noted:

1. USA Baseball will conduct the second USA Baseball/MLB Draft Combine;
2. USA Baseball and MLB will provide expenses to 100 draft-eligible four-year college participants and 100 high school participants to attend the event;
3. Extending the tryout length beyond 48-hours supports student-athlete health and well-being by providing additional time for the professional teams to conduct a comprehensive evaluation of the participating student-athletes without all necessary activities having to occur within a 48-hour time period;
4. The NCAA Division I Student-Athlete Experience Committee and NCAA Division I Baseball Committee supports the blanket waiver; and
5. The blanket waiver provides relief similar to existing sport-specific legislation in basketball and ice hockey.

At the recommendation of the NCAA Division I Men's and Women's Basketball Oversight Committees, the NCAA academic and membership affairs staff approved a blanket waiver of the required day off during the playing season legislation beginning with any designated week that includes January 7, 2022. Specifically, the blanket waiver allows institutions to not provide a required day off to its basketball teams during any week during the regular season in which one of the following scenarios occurs as a result of COVID-19 pandemic:

- The institution's basketball team has a COVID-19 "shutdown period" that occurs during the regular season;
- The institution's basketball team has less than seven student-athletes available for practice due to COVID-19 on one or more days during the impacted week; or
- The institution's basketball team has a postponed contest rescheduled to the impacted week.

At the recommendation of the Men's and Women's Oversight Committees, staff noted if an institution's basketball team meets any of the criteria, it must apply one of the two conditions below to ensure the intent of the required day off during the playing season legislation is preserved:

- The institution must provide its basketball student-athletes with two days off within the two weeks immediately preceding or following the impacted week; or
- The institution's basketball team may use a travel day as a required day off during the impacted week. In utilizing this option, an institution must provide its basketball student-athletes with an additional required day off (e.g., increase from 14 to 15) before the end of the 2021-22 academic year. Please note, this option is only available to autonomy institutions and those nonautonomy institutions that have opted into NCAA Division I Bylaw 17.1.7.7.1.

Additionally, an institution's Faculty Athletics Representative, applicable medical personnel and student-athletes must participate in the development of any alternative schedule and support its implementation.

In granting this request, staff noted the unique and extenuating circumstances associated with the COVID-19 pandemic. Because the nature of the request is intended to limit or change the timing of student-athlete access to discretionary time as allocated by the legislation, which has the potential to have material impact on student-athlete well-being, an institution's medical personnel must be properly consulted as to the overall impact on student-athlete well-being and have ultimate discretion as to the appropriateness on whether to apply the blanket waiver.

ARCHIVE INFO: BLANKET RELIEF ONLY FOR THE 2021-22 FOOTBALL SEASON.

At the request of the NCAA Division I Football Oversight Committee, the NCAA academic and membership affairs staff approved the following blanket waiver of NCAA Division I Bylaw 18.7.2.1 in the event that an insufficient number of institutions meet the definition of a "deserving team" to participate in postseason bowl games during the 2021-22 season. An institution that meets a condition set forth below shall be eligible to participate as an alternate in a bowl game provided all available deserving teams have been selected.

The terms of participation in the postseason bowl game applicable to the originally contracted conference participant shall be the same for the alternate. All institutions that meet the first condition below must be selected before an institution that meets the second condition may be selected and so forth in descending order:

1. An institution that would have met the exception in Bylaw 18.7.2.1.1 but for the fact that one victory was against a FCS opponent that had not averaged 90% of the permissible maximum

- number of grants-in-aid per year in football during a rolling two-year period and the institution's waiver request, per Bylaw 18.7.2.1.1.1, was denied.
2. An institution that participated in 13 regular-season contests and finished the season with a record of six wins that count toward meeting the definition of a "deserving team" and seven losses.
 3. An institution that is in its final year of reclassification from the Football Championship Subdivision to the Football Bowl Subdivision and meets the definition of a "deserving team" pursuant to Bylaw 18.7.2.1 or the exception in Bylaw 18.7.2.1.1.
 4. An institution that finished its season with a minimum of five wins that count toward meeting the definition of a "deserving team" and a maximum of seven losses but achieved a multiyear NCAA Division I Academic Progress Rate (APR) that permits postseason participation. Alternates identified pursuant to this condition shall be identified as eligible in descending order based on the institutions' multiyear APRs. If multiple institutions achieved the same multiyear rate, the institution with the highest single-year APR, beginning with the most recent reporting year and continuing until a higher rate is found, shall be identified as eligible first. An institution that is identified as an alternate must declare whether it will participate in a bowl game. An alternate institution that declares an intention to participate shall select an available bowl game in which to participate.

In approving the blanket waiver, staff noted:

1. The blanket waiver is only applicable for the 2021-22 season; and
2. The Football Oversight Committee will examine data from the 2021-22 postseason and consider recommending a legislative change during the 2022-23 legislative cycle.

1. The extended COVID-19 recruiting dead period impacted the evaluation of PSAs for more than a year;
2. Cost savings and efficiencies realized by institutions for coaches evaluating at an event taking place in the locale of the annual men's lacrosse coaches' association convention;

3. The blanket waiver is supported by men's lacrosse head coaches and the men's lacrosse coaches' association;
4. The NCAA Division I Student-Athlete Experience Committee supported one-time relief for the 2021-22 academic year only and encouraged the men's lacrosse coaches' association to consider alternate legislative options in the future; and
5. The waiver provides the men's lacrosse coaches' association time to evaluate legislative options to make attendance at this event permissible in the future.

1. The NCAA Division I men's basketball student-athlete has signed a 2022 Standard Player Agent Contract (SPAC) with the NCAA-certified agent;
2. Relief is only provided from the conclusion of the student-athlete's playing season until the student-athlete withdraws from the draft, or not later than 10 days after the conclusion of the NBA Draft combine, whichever is earlier; and
3. A student-athlete shall not miss class in conjunction with such training activities.

In granting this request, staff noted:

1. The Commission on College Basketball recommended that men's basketball student-athletes receive a meaningful assessment of their professional prospects and be able to receive assistance from certified agents;
2. After a Division I men's basketball student-athlete signs a SPAC, an NCAA-certified agent can permissibly provide the student-athlete (and family members) with transportation, lodging and meal expenses associated with meeting with the agent or a professional team;
3. Men's basketball student-athletes preparing for the NBA Draft and NBA Draft Combine regularly employ outside trainers to obtain a meaningful assessment of their professional prospects; and

4. Legislation regarding the provision of benefits from NCAA certified agents to Division I men's basketball student-athletes (and their family members) is an area of autonomy and all five autonomy conferences support the waiver request.

The NCAA Division I Committee for Legislative Relief approved a blanket waiver to permit Division I women's lacrosse coaches to evaluate prospective student-athletes (PSA) beginning at 2 p.m. Eastern time Friday, November 19, 2021, at the Intercollegiate Women's Lacrosse Coaches Association President's Cup.

In granting this request, the Committee for Legislative Relief noted:

1. The evaluation period currently begins at 5 p.m. Eastern time on Friday November 19, 2021. This request is to start the period three hours earlier at 2 p.m.;
2. There is overwhelming support from the women's lacrosse head coaches and the Coaches Association; and
3. The Coaches Association is meeting later this month to consider a legislative change to the women's lacrosse recruiting calendar that would make attendance for the entirety of this event permissible in the future.

NCAA Division I Committee for Legislative Relief Blanket Waiver Noncoaching Staff Members Participation in Managerial Duties for Sports Other than Basketball and Football during 2021-22 Playing Season – Approved October 22, 2021

ARCHIVE INFO: BLANKET RELIEF ONLY PROVIDED FOR 2021-22 ACADEMIC YEAR.

NCAA Division I sport programs in sports other than basketball and football may permit up to two Division I sport specific noncoaching staff members to engage in managerial duties during on-court and on-field practice activities (e.g., throw batting practice, pass a ball, assist with drills) provided the noncoaching staff position existed as of October 1, 2021. The noncoaching staff member(s) designated to perform such on-court or on-field managerial duties must be designated by the institution and kept on file in the athletics department. The sport-specific noncoaching staff members in sports other than basketball and football are only permitted to perform these managerial duties until the conclusion of an institution's 2021-22 playing season.

In granting this request, the NCAA academic and membership affairs staff noted:

1. A reduction of managers due to the health and safety impact of COVID-19 pandemic continues to exist at many member institutions, this waiver provides flexibility for designated noncoaching staff members to participate in on-court or on-field practice activities while performing managerial duties.
2. This waiver does not permit a noncoaching staff member to engage in coaching activities;
3. This waiver provides flexibility for institutions to conduct on-court or on-field countable athletically related activities and practice activities with the typical number of staff to assist in on-court or on-field activities;
4. Off-campus recruiting will have increased importance following the COVID dead period, the waiver would provide additional assistance to conduct practice during the time that one or more countable coaches are recruiting;
5. NCAA Division I Council approved on September 15, 2021, a blanket waiver permitting up to two noncoaching staff members in basketball to engage in coaching (instructional) duties during the 2021-22 season. This waiver provides similar but more limited relief for other sport programs; and
6. The waiver was requested and supported by the NCAA Division I Student-Athlete Experience Committee.

The NCAA Division I Committee for Legislative Relief approved a blanket waiver request to permit student-athletes to engage in countable athletically related activities on November 2, 2021, while participating in postseason practice and competition provided:

1. Postseason practice or competition is scheduled to occur during the institution's declared week that includes November 2, 2021;
2. The institution must provide student-athletes with an additional day during the 2021-22 academic year dedicated to civic engagement;
3. The institution and conference must provide education or programming related to civic engagement to student-athletes on November 2, 2021; and
4. If student-athletes are participating in a postseason conference championship practice or competition on November 2, 2021, the conference must provide general education or programming related to civic engagement to the championship attendees (e.g., participants, fans, officials).

In approving this blanket waiver request, the Committee for Legislative Relief noted:

1. The NCAA Division I Student-Athlete Advisory Committee, the sponsor of NCAA Division I Proposal No. 2020-4, supported a one-time approval of the waiver request subject to the conditions outlined above;
3. Proposal No. 2020-4 was adopted during the COVID-19 pandemic, through a nontraditional legislative cycle; therefore, adequate education and tracking on the impact of the proposal may not have occurred;
4. Proposal No. 2020-4 was adopted to provide student-athletes additional opportunities to participate in civic engagement activities (e.g., voting, community service) on election day, including during non-presidential election years; therefore, future similar requests for relief may be denied; and
4. Generally, an institution is not required to provide student-athletes with a required day off per week during participation in one conference and postseason championship.

NCAA Division I Committee for Legislative Relief Blanket Waiver Football (FBS/FCS) Annual Signing Limit and Initial Counter Limit - *Approved October 7, 2021*

ARCHIVE INFO: BLANKET RELIEF PROVIDED THROUGH JULY 31, 2022. NCAA DIVISION I PROPOSAL 2023-32 EFFECTIVE OCTOBER 4, 2023.

At the request of the NCAA Division I Football Oversight Committee and the NCAA Division I Council, the NCAA academic and membership affairs approved the following blanket waiver of the annual signing limit (FBS) and initial counter limit (FBS/FCS) legislation to permit the following to occur through July 31, 2022.

- Football Bowl Subdivision: Waive the annual signing limit (NCAA Bylaw 13.9.3.3) and initial counter legislation (Bylaws 15.5.6.1 and 15.5.1.10.1) for 2022-23 enrollees to permit an institution to replace up to seven counters who depart on or after the end of the institution's fall term or the first date of the early National Letter of Intent (NLI) signing period (December 15, 2021), whichever is earlier, provided the counters being replaced would have been academically eligible to compete in the institution's next regular academic term.
- Football Championship Subdivision: Waive the initial counter legislation (Bylaw 15.5.6.2), for 2022-23 enrollees to permit an institution to replace up to seven counters who depart on or after the end of the institution's fall term or the first date of the early NLI signing period (December 15, 2021), whichever is earlier, provided the counters being replaced would have been academically eligible to compete in the institution's next regular academic term.

While the blanket waiver is effective immediately, relief is not available until the end of the fall term or the first date of the early National Letter of Intent signing period (December 15, 2021), whichever is earlier.

In approving the blanket waiver request, the NCAA academic and membership affairs noted:

1. The blanket waiver provides short-term relief to permit institutions to address roster depletion and attrition;
2. Relief provides institutions additional opportunities to use available football scholarships; and
3. The Football Oversight Committee requested the blanket waiver and the council supported the request.

NCAA Division I Blanket Waiver Women's Basketball Managers Serving as Practice Players for 2021-22 Season - *Approved October 6, 2021*

ARCHIVE INFO: BLANKET RELIEF PROVIDED DURING THE 2021-22 WOMEN'S BASKETBALL PLAYING SEASON ONLY.

Upon the recommendation from the NCAA Division I Women's Basketball Oversight Committee, the NCAA academic and membership affairs staff approved a blanket waiver request permitting women's basketball student managers to also serve as practice players during the 2021-22 playing season.

In granting this request, staff noted:

1. This waiver is effective beginning October 11, 2021, and is an extension of a previous blanket waiver (Case No. 1109415) which provided flexibility for student managers to serve as practice players during the 2020-21 playing season;
2. This waiver does not permit women's basketball student managers who are performing practice player duties to engage in on-court coaching activities;
3. This waiver provides flexibility for institutions to conduct on-court countable athletically related activities and practice activities with the typical number of staff and practice players to assist in on-court activities; and
4. The COVID-19 pandemic continues to cause uncertainty, and this waiver will allow for the creation of "bubbles" around the basketball team by including only those personnel essential to supporting the program.

The waiver is effective beginning September 20, 2021.

In granting this request, the council noted relief may only be provided when:

1. One or more of the head and/or assistant coaches are not in attendance for countable athletically related activities (e.g. practice, film review);
2. The noncoaching staff position(s) existed as of August 1, 2021;
3. The names of designated noncoaching staff positions must be designated by the institution and kept on file in the institution's athletics department;
4. No more than four coaches and noncoaching staff members (six for the national service academies) combined engage in providing instruction to student-athletes at any one time; and
5. Relief expires at the end of the institution's 2021-22 playing season (i.e., after the team's final contest of the season).

Please note, this action also allows the designated noncoaching staff member(s) to participate in skill-instruction activities as practice players.

In granting this request, the Committee for Legislative Relief noted:

1. The ongoing discussion within the Division I governance structure surrounding exempt contests;
2. The NCAA Division I Competition Oversight Committee supported similar blanket waiver relief (Case Nos. 966358, 989638, 1052262) during the 2017-18, 2018-19 and 2019-20 academic years;
3. The Competition Oversight Committee recommended Proposal No. 2019-122 into the 2019-20 legislative cycle as a mechanism to provide a consistent framework for postseason competition in all sports other than basketball and football;
4. Proposal No. 2019-122 was tabled in April 2020 due to the COVID-19 pandemic and will be reviewed during the 2021-22 legislative cycle;
5. The unique opportunity to provide additional student-athletes with a postseason participation experience; and
6. This is a one-time waiver request for the 2021-22 academic year.

The NCAA Division I Committee for Legislative Relief approved a blanket waiver request to permit Division I institutions to provide complimentary admissions to individuals designated by a student-athlete using digital ticketing.

In granting this request, the Committee for Legislative Relief noted:

1. Digital ticketing technology has evolved to sufficiently address public safety concerns and the operational burden associated with hard ticket admissions procedures;
2. Each institution remains responsible for ensuring admission credentials are provided to the proper individuals and there is no ability for a designated individual to assign admission credentials to an individual not designated by the student-athlete;
3. The adoption of NCAA Division I Proposal No. 2021-2 permitted the provision of complimentary admissions to a prospective student-athlete or high school, preparatory school or two-year college coach;
4. A similar proposal was not adopted for complimentary admissions provided to individuals designated by the student-athlete as the governing legislation is an area of autonomy; and
5. All five autonomy conferences support the waiver request.

2. Competition opportunities for institutions to use the foreign team in the United States exempted contests legislation have diminished as a result of travel restrictions due to the COVID-19 pandemic; and
3. The NCAA Hockey Commissioner's Association and the NCAA Division I Men's Ice Hockey Committee supported the waiver request.

The NCAA Division I Committee for Legislative Relief approved a blanket waiver request to permit a student-athlete with remaining eligibility who is enrolled in an institution other than the institution from which the student-athlete previously received a baccalaureate degree and is enrolled in a graduate or professional school, is seeking a second baccalaureate or equivalent degree, or is enrolled as a full-time student while taking course work that would lead to the equivalent of a major or degree to participate in intercollegiate athletics provided the student-athlete fulfills the conditions of the nonrecruited or nonscholarship student exception set forth in NCAA Bylaw 14.5.5.2.9.

In granting this request, the Committee for Legislative Relief noted:

1. The application of the COVID-19 extension-of-eligibility and season-of-competition blanket waivers providing student-athletes additional competition opportunities on an extended timeline will result in an increase in student-athletes seeking to apply their postgraduate eligibility at a new institution;
2. NCAA Division I Proposal No. 2018-103 was established to permit an undergraduate student-athlete who does not receive aid or attends an institution that does not offer athletics aid and was not recruited to explore other athletics and academic opportunities without being required to fulfill an academic year of residence at another institution; and
3. Similar relief should be provided to allow a postgraduate transfer student-athlete who did not receive aid at the previous institution or attended an institution that does not offer athletics aid in their sport and was not recruited to utilize their remaining eligibility at another Division I institution.

The NCAA Division I Committee for Legislative Relief approved a blanket waiver request to permit a conference or an institution to provide the educational benefits specified in the *Alston*/Grant-in-Aid litigation injunction to student-athletes, in sports other than basketball and bowl subdivision football, and to specify that the NCAA, a conference or an institution may provide student-athletes, in sports other than basketball and bowl subdivision football, academic or graduation awards or incentives that have a value up to the maximum value of awards an individual student-athlete could receive in an academic year in participation, championship and special achievement awards (combined) listed in Figures 16-1, 16-2, and 16-3.

Specifically, this waiver extends the legislation adopted for basketball and bowl subdivision football per NCAA Division I Proposal No. 2020-3 to all other sports. The waiver applies through the 2021-22 academic year or until permanent legislation is adopted.

In granting this request, the Committee for Legislative Relief noted:

1. Proposal No. 2020-3 was adopted, in basketball and bowl subdivision football, in response to an injunction entered against the NCAA and conference defendants in the *Alston*/Grant-In-Aid legislation;
2. Based on the recent decision of the United States Supreme Court in the *Alston* case, the benefits currently available to student-athletes in basketball and bowl subdivision football should be extended to all other sports; and
3. The waiver was requested and supported by the NCAA Division I Council Coordination Committee.

NCAA Division I Committee for Legislative Relief -- Women's Basketball Qualifying Regular-Season Multiple-Team Events -- 2021-22 Season- *Approved July 19, 2021*

ARCHIVE INFO: BLANKET RELIEF ONLY PROVIDED FOR 2021-22 ACADEMIC YEAR.

At the recommendation of the NCAA Division I Women's Basketball Oversight Committee, the NCAA academic and membership affairs staff approved a blanket waiver of the qualifying regular-season multiple-team event legislation in women's basketball to permit the following maximum contest limit options during the 2021-22 season:

- 27 (games or scrimmages) and one qualifying regular-season multiple-team event that does not exceed four contests (current legislation);
- 28 (games or scrimmages) and one qualifying regular-season multiple-team event that does not exceed three contests;
- 29 (games or scrimmages) and one qualifying regular-season multiple-team event that does not exceed two contests; or
- 29 contests (games or scrimmages) during a playing season in which the institution does not participate in a qualifying regular-season multiple-team event.

Women's basketball programs are expected to meet all other MTE criteria included in Bylaw 17.4.5.2.1. These criteria include:

- The event is sponsored by the NCAA, an active member or a member conference of the Association or the Women's Basketball Coaches Association;
- The event includes not more than four contests per institution and concludes not later than 14 days after the first contest of the event;
- Participation is limited, by conference, to one team per conference and, by institution, to not more than once in the same event in any four-year period; and
- Each participating institution is using Bylaw 17.5.5.3-(a) as its maximum contest limitation for the playing season in which it participates in the event.

In granting this request, staff noted the blanket waiver provides women's basketball programs with similar scheduling options that currently exist in the men's basketball multiple-team event legislation. Additionally, the blanket waiver provides equitable avenues for women's basketball student-athletes to participate in the maximum number of permissible contests (31). Further, staff noted the lack of four-game MTE opportunities that currently exist for women's basketball teams to have the opportunity to schedule the maximum permissible number of contests. The blanket waiver is only for the 2021-22 women's basketball season and the additional flexibility encourages the creation of more MTE options for women's basketball teams in the future. Finally, the blanket waiver allows the Women's Basketball Oversight Committee time to collect additional data regarding the role of MTEs in women's basketball.

NCAA Division I men's basketball coaches may evaluate at regularly scheduled 2020-21 academic year regular season and/or post-season high school contests that are still being played as a result of high school athletics associations delaying the start of the high school basketball season due to the COVID-19 pandemic provided the contests occur during the prescribed June 18 (noon)-20 (6 p.m.) and June 25 (noon) -27 (6 p.m.) evaluation periods.

In granting this request, the NCAA academic and membership affairs staff noted:

1. Relief is provided for National Federation of State High School Associations', non-NFHS or independent high school athletics associations' regularly scheduled 2020-21 academic year regular and/or post-season high school contests that are still being played as a result of the season being pushed back due to the COVID-19 pandemic;
2. The contest must be part of the high school's 2020-21 academic year regular basketball schedule in place as of June 15, 2021;

NCAA Division I women's gymnastics coaches may evaluate prospective student-athletes June 2, through June 6, 2021, at the 2021 U.S. Gymnastics Championships, which occurs during the recruiting dead period from June 1 through June 15, 2021. Note, USA Gymnastics has expanded the dates of the championships from June 3-6 to June 2-6 as a result of the COVID-19 pandemic.

In granting this request, the NCAA Division I Committee for Legislative Relief noted:

1. USA Gymnastics supports the extension of the waiver request;
2. The U.S. Gymnastics Championships are typically held in mid-August but the dates changed as a result of COVID-19 during summer 2020 and 2021 becoming an Olympic year;

3. This is the first time the U.S. Gymnastics Championships have occurred during the June 1-15 dead period since the adoption of NCAA Proposal No. 2017-47;
4. This waiver does not permit for off-campus contact with prospective student-athletes or their family members; and
5. This waiver is a one-time waiver request.

Further, the blanket waiver permits participation in the draft combine without considering it as the student-athlete's one permissible tryout with a professional sports organization after initial full-time enrollment.

At the recommendation of the NCAA Division I Student-Athlete Experience Committee, staff approved the blanket waiver on a one-time basis and noted:

- USA Baseball will conduct the inaugural USA Baseball/MLB Draft Combine, June 20-28, 2021;
- USA Baseball and MLB will provide expenses to 100 draft-eligible four-year college participants and 100 high school participants to attend the event;
- Extending the tryout beyond 48 hours will ensure a quality experience and promote the health and safety of participating student-athletes completing on-field and off-field assessments while maintaining required social distancing, testing and other COVID-19 health and safety protocols;
- The Baseball Committee supports the blanket waiver; and
- The blanket waiver provides relief similar to existing sport-specific legislation in basketball and ice hockey.

In granting this request, staff noted the unique and extenuating circumstances associated with the COVID-19 pandemic.

Legislative Relief Blanket Waiver -- Men's Basketball Qualifying Regular-Season Multiple-Team Events -- 2021-22 Season- - *Approved May 7, 2021*

ARCHIVE INFO: BLANKET RELIEF PROVIDED ONLY DURING 2021-22 MEN'S BASKETBALL SEASON.

During its May 7 meeting, the NCAA Division I Men's Basketball Oversight Committee reviewed the previous blanket waiver of the qualifying regular-season multiple-team event (MTE) legislation in men's basketball that was in place for the 2020-21 season and agreed that limited relief of the MTE legislation should be extended to the 2021-22 season due to the impact the COVID-19 pandemic had on the previous basketball season.

At the recommendation of the Men's Basketball Oversight Committee, the NCAA academic and membership affairs staff approved the blanket waiver on May 10 to permit the following:

- Two teams from the same conference may participate in the same MTE provided one or both teams signed a contract to participate in the same event during the 2020-21 season; and
- A team may participate in the same MTE twice in a four-year period provided the team's first participation in the four-year period occurred during the 2020-21 season.

Staff noted the MTE blanket waiver that was in place for the 2020-21 season has expired. Therefore, institutions are expected to meet all other MTE criteria that were adopted April 30, 2020, during the 2021-22 men's basketball season. These criteria include:

- The MTE is sponsored by the NCAA, an active member or a member conference of the Association or the National Association of Basketball Coaches;
- The MTE includes not more than three contests per institution. An MTE in which each institution participates in three contests must conclude not later than 10 days after the first contest of the event. An MTE in which each institution participates in two contests must conclude not later than five days after the first contest of the event;
- Each participating institution must participate in the same number of contests in the MTE;
- Each participating institution in the MTE must use the same maximum contest limitation for the 2021-22 basketball season; and
- The MTE may include a non-Division I institution as a participant only if the non-Division I institution serves as the host of the event.

In granting this request, staff noted the unique and extenuating circumstances associated with the COVID-19 pandemic that impacted the student-athlete experience in an MTE during the 2020-21 season.

The Men's Basketball Oversight Committee will continue to monitor the impact of the COVID-19 pandemic on the 2021-22 men's basketball season and determine if further relief of the MTE legislation is necessary in the future.

Finally, institutions seeking relief of the MTE legislation in women's basketball should file a legislative relief waiver request in RSR0. Those waivers will be reviewed on a case-by-case basis by the NCAA Division I Women's Basketball Oversight Committee and staff for the 2021-22 season.

*(*Updated May 11, 2021: Due to the updated NBA deadline for student-athletes to request NBA Undergraduate Advisory Committee feedback, additional clarification regarding eligibility for the May 4 blanket waiver has been provided below.)*

At the recommendation of the NCAA Division I Men's Basketball Oversight Committee, the NCAA academic and membership affairs approved a legislative relief blanket waiver to permit a men's basketball student-athlete who has requested an NBA Undergraduate Advisory Committee evaluation and declared for the 2021 NBA Draft to use institutional facilities while engaging in workout activities with an outside trainer.

Further, the blanket waiver permits a men's basketball student-athlete who has requested an Undergraduate Advisory Committee evaluation and declared for the 2021 NBA Draft to participate in countable athletically related activity (CARA) for up to four hours per day and 20 hours per week.

In granting this request for the 2021 NBA pre-draft process only, staff noted:

1. Relief is only provided until the men's basketball student-athlete withdraws from the draft, or not later than 10 days after the conclusion of the NBA Draft combine (July 7, 2021), whichever is earlier.

2. Due to the delayed 2021 NBA pre-draft process based on the continuing impact of the COVID-19 pandemic, providing an increased number of student-athletes with access to outside trainers and coaching staff members in preparation for the 2021 NBA Draft supports student-athletes in making informed decisions about their future collegiate and professional basketball opportunities.
3. An institution's coaching staff member may arrange the use of institutional facilities and observe workout activities with an outside trainer on- or off-campus; however, the coach may not conduct, supervise or participate in these workout activities unless the time is included in daily and weekly CARA limitations.
4. The men's basketball student-athlete remains responsible for compensating the outside trainer at his or her normal rate.
5. Relief does not increase the current daily and weekly CARA limitations permitted by the men's basketball draft combine invitation exception.
6. Since the deadline has passed for student-athletes to request feedback from the NBA's Undergraduate Advisory Committee, this relief is limited to men's basketball student-athletes who have previously requested feedback within the established timeframe.

*On May 5, 2021, the NBA announced that the deadline for student-athletes to request feedback from the NBA's Undergraduate Advisory Committee would be extended from April 12 to May 15. Given that the intent of the blanket waiver was to limit relief to student-athletes who had previously requested feedback and that the blanket waiver was published prior to the newly established NBA deadline, student-athletes who requested feedback from the NBA's Undergraduate Advisory Committee prior to the May 4 blanket waiver publication date are eligible for relief pursuant to the blanket waiver. If a student-athlete requested or requests feedback from the NBA's Undergraduate Advisory Committee after the May 4 blanket waiver publication date and wishes to receive similar relief of the legislation, those circumstances will need to be reviewed by NCAA staff on an individual basis to determine whether relief should be provided. The NCAA academic and membership affairs staff approved a blanket waiver to permit student-athletes, in sports other than basketball and football, to participate in up to eight hours of required virtual nonphysical countable athletically related activities (e.g., film review, chalk talk, team

meetings) per week beginning on the first date following the conclusion of the institution's final exam period for 2021 spring term. The waiver expires on the first day of classes for the institution's 2021 fall term or the start of the preseason practice period, whichever is earlier.

Further, the blanket waiver permits prospective student-athletes (e.g., incoming freshmen, transfers) to participate in up to eight hours of required virtual nonphysical countable athletically related activities per week provided the prospective student-athlete has completed all academic requirements for high school graduation or applicable transfer requirements.

At the recommendation of the NCAA Division I Student-Athlete Experience Committee, staff approved the blanket waiver on April 28 and noted the following:

1. The blanket waiver extends the NCAA Division I Council Coordination Committee action originally approved on April 20, 2020;
2. The blanket waiver permits sports other than basketball and football to require up to eight hours per week of virtual nonphysical countable activities (e.g., film review, chalk talk, team meetings) and, for each sport, requires an institution to provide student-athletes at least one day off per week (rather than the legislated two days outside the playing season);
3. Student-athletes do not need to be enrolled during any 2021 summer term in order to apply this waiver; and
4. After completing all academic requirements for high school graduation or all transfer academic requirements, a prospective student-athlete who participates in virtual nonphysical countable athletically related activity may be considered a student-athlete.

In granting this request, staff noted the unique and extenuating circumstances associated with the COVID-19 pandemic.

Finally, because the nature of the request may decrease the amount of student-athlete discretionary time allocated by legislation, institutional medical staff should be properly consulted as to the impact on overall student-athlete well-being and have ultimate discretion as to the appropriateness of any supplemental required activities.

At the recommendation of the NCAA Division I Football Oversight Committee, the NCAA academic and membership affairs staff approved the blanket waiver on April 28 and noted the following:

1. A previous blanket waiver allowed FBS and FCS institutions to initiate telephone calls at their discretion to an individual (or the individual's family members) beginning February 1 of the individual's junior year of high school through the conclusion of the temporary COVID-19 recruiting dead period;
2. On April 15, 2021, the NCAA Division I Council agreed that the temporary COVID-19 recruiting dead period would expire on May 31, 2021, and all sports will return to their legislated recruiting calendars on June 1;
3. On April 15, 2021, the council also approved the following blanket waivers:
 - a. A blanket waiver, effective June 1 through December 31, 2021, to permit an institutional staff member who has passed the NCAA recruiting certification exam to initiate telephone calls to prospective student-athletes; and
 - b. A blanket waiver to permit on-campus evaluations of prospective student-athletes in football during June and July 2021 when institutional football camps and clinics are otherwise permissible;
4. NCAA legislation does not permit telephone calls to junior prospective student-athletes in football during the months of June and July; and
5. With the addition of on-campus evaluations during the months of June and July, the waiver will provide an appropriate opportunity for institutional staff members who have passed the NCAA recruiting certification exam to communicate with prospective student-athletes.

3. Football graduate assistant coaches must satisfy all other requirements of the graduate assistant coach legislation, including academic enrollment;
4. The blanket waiver does not permit an individual to serve as a graduate assistant coach for a period of more than two years (e.g., third year, fourth year) unless the individual a successfully completes 24-semester or 36-quarter hours during the initial two-year period; and
5. The blanket waiver applies to all football graduate assistant coaches serving in that capacity during the 2020-21 academic year, recognizing that a first, second- or third-year football graduate assistant coach may not have had the opportunity to gain experience due to a cancelled or shortened football season.

Outside Competition in Sports Other than Basketball and Football - *Approved December 18, 2020*

ARCHIVE INFO: BLANKET RELIEF PROVIDED ONLY FOR THE 2020-21 ACADEMIC YEAR.

The NCAA academic and membership affairs staff approved a blanket waiver to permit, in sports other than basketball and football, a student-athlete to participate in noncollegiate, amateur competition on an outside team during the 2020-21 academic year if his or her institution will not engage in competition during the term. Regulations that apply to permissible outside competition (e.g., limit on number of student-athletes from any one institution) continue to apply under the application of the waiver. An institution or conference may not provide expenses for such competition and the student-athlete must be in good academic standing. A student-athlete who remains enrolled at the institution may not miss class to participate in outside competition. All competition should adhere to federal, state, local and other applicable guidelines related to COVID-19.

The NCAA Division I Committee on Academics action allow the missed term exception to apply to any term in which outside competition occurs under circumstances consistent with the blanket waiver.

In granting this request, staff noted:

1. The blanket waiver extends the NCAA Division I Council Coordination Committee and the NCAA Division I Committee on Academics action from August 5, 2020, for all sports other than basketball and football;
2. The extension of the blanket waiver provides flexibility and support of student-athlete well-being during the COVID-19 pandemic;
3. The NCAA Division I Student-Athlete Experience Committee requested and supported an extension to of the Council action for the remainder of the 2020-21 academic year; and
4. The Division I Student-Athlete Advisory Committee supported the waiver request.

In granting this request, staff noted the unique and extenuating circumstances associated with the COVID-19 pandemic.

Participation in Required Virtual Nonphysical Countable Athletically Related Activities – *Approved December 16, 2020*

ARCHIVE INFO: BLANKET RELIEF PROVIDED ONLY FOR THE 2020-21 ACADEMIC YEAR.

The NCAA academic and membership staff approved a blanket waiver to permit student-athletes to participate in up to eight hours of required virtual nonphysical countable athletically related activities (e.g., film review, chalk talk, team meetings) per week beginning upon the student-athlete's return to campus for safety protocols (e.g., mandated testing activities, required quarantine period) or the opening day of classes of the institution's winter/spring 2021 term, whichever is earlier. The waiver applies until one week before the start of the final examination period of the institution's 2021 spring term.

In granting this request, staff noted:

1. The blanket waiver extends the NCAA Division I Council Coordination Committee action from April 20, 2020, that was previously extended on May 15, May 22, June 17 and July 22, 2020, for all sports;
2. The blanket waiver permits all sports to require up to eight hours per week of virtual nonphysical countable activities (e.g., film review, chalk talk, team meetings) and, for each sport, requires an institution to provide student-athletes at least one day off per week (rather than the legislated two days outside the season);
3. Allowing the July 22, 2020, Council Coordination Committee action to expire at the conclusion of the institution's fall 2020 term allows student-athletes a break from participation in countable athletically related activities between terms;
4. Student-athletes do not need to be enrolled full time during the during winter/spring 2021 terms in order to apply this waiver. This would include student-athletes who are not enrolled in any credits during the term;

5. The waiver was requested and supported by the NCAA Division I Student-Athlete Experience Committee; and
6. The Collegiate Commissioners Association Compliance Administrators and Student-Athlete Advisory Committee supported the waiver request.

In granting this request, staff noted the unique and extenuating circumstances associated with the COVID-19 pandemic.

Finally, because the nature of the request may decrease the amount of student-athlete discretionary time allocated by legislation, institutional medical staff should be properly consulted as to the impact on overall student-athlete well-being and have ultimate discretion as to the appropriateness of any supplemental required activities.

Transfer Year of Residence - Approved December 16, 2020

ARCHIVE INFO: BLANKET RELIEF PROVIDED ONLY FOR THE 2020-21 ACADEMIC YEAR.

During its December 16 meeting, the NCAA Division I Council approved a blanket waiver request providing relief for four-year college transfer student-athletes currently serving a transfer year of residence during the 2020-21 academic year, provided the following criteria are met:

1. The student-athlete must have transferred from a Division I institution to the current Division I institution by the start of the 2020 fall term;
2. The student-athlete must have left the previous four-year institution academically eligible, in good standing and under no disciplinary suspension;
3. The student-athlete must have no previous four-year college transfer history (i.e., the blanket waiver is applicable to first-time 4-4 transfers only); and
4. The current institution's head coach and the student-athlete certify that no direct or indirect communication or contact occurred before the student-athlete's name was entered into the NCAA Transfer Portal (per NCAA Division I Bylaw 13.1.1.3). Note: A sample template may be accessed [here](#).

Four-year college transfer student-athletes who qualify for the blanket waiver of Bylaw 14.5.5.1 must additionally be certified as academically eligible to compete, consistent with applicable progress-toward-degree requirements.

Required Athletically Related Activities Permitted During Basketball Three-Day Winter Break, *Approved November 19, 2020 - Updated December 14, 2020, For Men's Basketball Only*

ARCHIVE INFO: BLANKET RELIEF PROVIDED ONLY FOR THE 2020-21 ACADEMIC YEAR.

Upon further review of COVID-specific scheduling challenges and related circumstances impacting Division I autonomy men's basketball and its ability to accommodate the traditional three-day winter break period in basketball during the 2020-21 playing season, the NCAA Division I Men's Basketball Oversight Committee reviewed and updated the November 19 blanket waiver on December 14 to provide an additional option for relief of the three-day winter break period legislation in men's basketball.

NCAA Division I autonomy men's basketball programs (and those Division I institutions opting into the legislation) may use one of the following options:

1. May participate in required athletically related activities during the three consecutive days off during the institution's official vacation period after the first term of the academic year (e.g., winter break) as approved on November 19; OR
2. May provide three nonconsecutive days off from any required athletically related activities or countable athletically related activities during the institution's official vacation period after the first term of the academic year (e.g., winter break).
 - Consistent with the regular application of the three-day break legislation, institutions that choose Option B are required to provide the same total number of days off from countable athletically related activities (CARA) and required athletically related activities (RARA) during the winter break as had been scheduled prior to the waiver approval (i.e., an additional one, two or three days off beyond the required one day off per week based on an institution's designation of week and when the three consecutive day break was scheduled to occur).

On November 19, at the recommendation of the NCAA Division I Men's and Women's Basketball Oversight Committees, the NCAA academic and membership staff approved a blanket waiver to permit Division I men's and women's basketball student-athletes to engage in RARA only during the three-day winter break.

In granting the November 19 original request for RARA activities to occur during the consecutive three-day winter break period (Option A), staff noted the unique and extenuating circumstances associated with the COVID-19 pandemic and that many basketball student-athletes will remain on campus during the 2020-21 winter break. Permitting basketball student-athletes to engage in RARA during the three consecutive days off allows institutions to schedule activities that will discourage the potential for isolating behavior and encourage players to spend time with teammates while also providing them with an opportunity to physically rest and recover from countable athletically related activities during the season.

If an institution chooses to utilize the consecutive three-day winter break period (Option A), examples of permissible activities may include, but are not limited to the following:

- Team meal.
- Team entertainment.
- Voluntary shoot around (without the presence of a coaching staff member or a sport-specific staff member).
- Athletic training/injury prevention and treatment.
- Academic advising and study table.
- Team building activities.
- Promotional activities.
- Community service.

Use of Option A does not permit basketball student-athletes to engage in CARA during the three-day winter break period. CARA includes any required activity with an athletics purpose involving student-athletes and at the direction of, or supervised by, one or more of an institution's coaching staff (including strength and conditioning coaches), including, but not limited to the following types of activities: practice, film review, walk-through, and shoot around.

On December 14, the Men's Basketball Oversight Committee reviewed the November 19 action and supported an additional option for relief in men's basketball to include three nonconsecutive days off to provide flexibility due to conference scheduling models.

In granting the December 14 request for days off from CARA and RARA to occur on nonconsecutive days during the winter break period (Option B), the staff noted the unique and extenuating circumstances associated with the COVID-19 pandemic and the compression of conference scheduling framework that exists only because of the COVID-19 pandemic. The intent of Option B is to permit schools to accommodate scheduling challenges while still requiring three nonconsecutive days off from RARA and CARA, providing a consistent amount of aggregate number of days off from CARA and RARA during the winter break as has been traditionally legislatively required.

Finally, because the nature of the request may decrease the amount of aggregate or consecutive student-athlete discretionary time allocated by legislation, institutional medical staff should be properly consulted as to the impact on overall student-athlete well-being and have ultimate discretion as to the appropriateness of the implementation of either waiver option.

The blanket waiver originally released on November 19, 2020, (Option A) remains applicable for women's basketball. While the NCAA Division I Women's Basketball Oversight Committee considered the request for three nonconsecutive days off for CARA and RARA (Option B), it identified that similar scheduling challenges have not been reported to date in the women's game and it declined to take action at this time. The Women's Basketball Oversight Committee will revisit this in the future, if appropriate.

National Women's Soccer League Blanket Waiver *Approved, December 15, 2020*

The NCAA Division I Committee for Legislative Relief approved a blanket waiver to allow Division I women's soccer student-athletes to enter the National Women's Soccer League's draft (and potentially be drafted), while maintaining collegiate eligibility to compete during the 2021 spring championship segment.

In granting this request, the Committee for Legislative Relief noted:

1. This is a one-time request for the 2020-21 academic year only;
2. The blanket waiver does not permit a student-athlete to sign with an agent or an agreement to join a team, if drafted;
3. Any use of a student-athletes name, image or likeness by the professional league must be informational in nature;
4. The unique and extenuating circumstances associated with the COVID-19 pandemic and the impact of the pandemic on the 2020-21 soccer playing season; and
5. The NCAA Division I Student-Athlete Experience Committee supported the waiver request.

Permit Men's and Women's Swimming and Diving Student-Athletes Who Have a Realistic Chance at Competing for an Olympic Team Spot to Continue to Train with Their Collegiate Coaches Once the Championship Season Concludes - *Approved December 10, 2020*

ARCHIVE INFO: BLANKET RELIEF PROVIDED ONLY FOR THE 2020-21 ACADEMIC YEAR.

In granting this request, the NCAA Division I Committee for Legislative Relief noted:

- The request was granted based on student-athlete well-being and the elite and unique circumstances surrounding potential participation in the Olympic Games.

Specifically, the blanket waiver permits the following:

1. Women's swimming and diving student-athletes who achieve a 2021 U.S. Olympic Team Trials qualifying time or qualifying score by March 21, 2021, to continue to be coached by their collegiate coach through the 2021 US Olympic Trials;
2. Men's swimming and diving student-athletes who achieve a 2021 U.S. Olympic Team Trials qualifying time or qualifying score by March 28, 2021, to continue to be coached by their collegiate coach through the 2021 US Olympic Trials;

3. Women's swimming student-athletes who have not achieved an Olympic Trial qualifying time by March 21, 2021, to be coached by their collegiate coach through events ending May 16, 2021, provided the student-athlete achieves a time within one percent (of either the long-course meters or short-course yards time standards for the 2019 Senior National Championships) for events that are 200 meters/yards or longer and two percent for events that are 100 meters/yards and shorter;
4. Women's diving student-athletes who have not achieved an Olympic Trial qualifying score by March 21, 2020, to be coached by their collegiate coach through events ending May 4, 2021, provided the student-athlete achieves a score within three percent of the minimum qualifying score in the relevant individual or synchronized diving event for the 2021 Olympic Trials;
5. Men's swimming student-athletes who have not achieved an Olympic Trial qualifying time by March 28, 2021, to be coached by their collegiate coach through events ending May 16, 2021, provided the student-athlete achieves a time within one percent (of either the long-course meters or short-course yards time standards for the 2019 Senior National Championships) for events that are 200 meters/yards or longer and two percent for events that are 100 meters/yards and shorter; and
6. Men's diving student-athletes who have not achieved an Olympic Trial qualifying score by March 28, 2021, to be coached by their collegiate coach through events ending May 4, 2021, provided the student-athlete achieves a score within three percent of the minimum qualifying score in the relevant individual or synchronized diving event for the 2021 Olympic Trials.

Baseball Blanket Waiver *Approved, June 9, 2020; Updated December 4, 2020*

ARCHIVE INFO: BLANKET RELIEF PROVIDED ONLY FOR THE 2020-21 AND 2021-22 ACADEMIC YEARS.

The NCAA Division I Committee for Legislative Relief granted a blanket waiver in baseball for the 2020-21 and 2021-22 academic years only, to allow schools to:

- Eliminate the varsity squad size limitation (i.e., 35-man roster) for the 2020-21 academic year and to increase the varsity size limitation from 35 to 40 for the 2021-22 academic year;
- Increase the annual counter limit from 27 to 32; and
- Renegotiate athletics aid agreements to provide less than 25 percent.

In granting this request, the Committee for Legislative Relief noted:

- The extenuating and extraordinary circumstances surrounding and impacts of the COVID-19 pandemic;

- The significant reduction in the number of student-athletes and incoming signees selected in the Major League Baseball first-year player draft;
- The combination of unforeseen and uncontrollable circumstances resulting in a significant number of student-athletes returning to Division I baseball, a sport which carries a rigid roster and financial aid limits; and
- The American Baseball Coaches Association, NCAA Committee on Women's Athletics, Baseball Committee, NCAA Division I Competition Oversight Committee, NCAA Division I Student-Athlete Experience Committee and NCAA Gender Equity Task Force supported the blanket waiver for the 2020-21 academic year.
- Staff approved an extension to the blanket waiver requested by Student-Athlete Experience Committee for the 2020-21 academic year, noting an increase in the varsity squad limitation from 35 to 40 for the 2021-22 academic year.

Additionally, the Committee for Legislative Relief noted:

- The blanket waiver only applies to the 2020-21 and 2021-22 academic years.
- For the 2020-21 academic year:
 - For student-athletes with multiyear financial aid agreements: Schools may provide less than a 25 percent equivalency during the 2020-21 academic year; however, the school must ensure that the total amount of aid provided over the period of the new amended agreement is equal to or greater than the total provided in the student-athlete's original aid agreement.
 - For student-athlete with one-year financial aid agreements: Schools may provide less than a 25 percent equivalency during the 2020-21 academic year; however, the school must renew the student-athlete's agreement for the 2021-22 academic year and provide at least a 25 percent equivalency or the average of the aid received during 2020-21 and the amount that would have been received by the student-athlete under the original aid agreement, whichever is greater.
- For the 2021-22 academic year:
 - The varsity squad size limitation is increased from 35 to 40;
 - For student-athletes with multiyear financial aid agreements: Schools may provide less than a 25-percent equivalency during the 2021-22 academic year; however, the school must ensure that the total amount of aid provided over the period of the new amended agreement is equal to or greater than the total provided in the student-athlete's original aid agreement.
 - For student-athletes with one-year financial aid agreements: Schools may provide less than a 25-percent equivalency during the 2021-22 academic year; however, the school must renew the student-athlete's agreement for the 2022-23 academic year and provide at least a 25-percent equivalency or the average of the aid received during 2021-22 and the amount that would have been received by the student-athlete under the original aid agreement, whichever is greater.

Final Date for Football Bowl Subdivision Regular Season and Conference Championship Contests for 2020-21 Season Only - *Approved November 25, 2020*

NCAA Division I Football Bowl Subdivision programs may participate in regular season contests, including a conference championship game, as late as Saturday, December 19, 2020.

At the recommendation of the NCAA Division I Football Oversight Committee, the academic and membership affairs staff approved the blanket waiver with the following condition:

- An institution shall limit its total regular season playing schedule to not more than 12 contests (games or scrimmages) unless a legislated exception is met.

Blanket Waiver Men's and Women's Ice Hockey Maximum Contest Limitations - *Approved November 25, 2020*

The NCAA Division I Committee for Legislative Relief approved a blanket waiver for Division I men's and women's ice hockey teams to participate in one exhibition contest against any NCAA Division I, Division II or Division III institutions during the 2020-21 academic year that does not count against the team or individual maximum contest limitations.

In granting this request, the Committee for Legislative Relief noted:

1. The waiver is approved for the 2020-21 academic year only;
2. Competition opportunities for institutions have diminished as a result of the COVID-19 pandemic; and
3. The Hockey Commissioner's Association supported the waiver request.

Virtual Recruiting Activities -- Permissible Callers, *Approved December 2, 2020*

The academic and membership affairs staff approved a blanket waiver to permit all coaches, including volunteer coaches, full-time institutional staff members and current students to initiate recruiting calls (e.g., telephone calls, video calls) involving prospective student-athletes who an institution is permitted to call. The flexibility applies for the remainder of the temporary COVID-19 recruiting dead period.

In granting this request, staff noted:

1. The NCAA Division I Council approved a blanket waiver to expand the list of permissible callers for the sport of football on November 18, 2020;
2. The COVID-19 pandemic, specifically noting official and unofficial visits are not permissible during the temporary COVID-19 recruiting dead period. The blanket waiver is intended to provide institutions additional opportunities for engaging with prospective student-athletes to share as much information as possible to help the prospective student-athletes make informed decisions;
3. On November 18, 2020, the temporary COVID-19 recruiting dead period was extended by the council through at least April 15, 2021;
4. The Collegiate Commissioners Association Compliance Administrators, the Student-Athlete Advisory Committee and the NCAA Division I Men's and Women's Basketball Oversight Committees supported the waiver request; and
5. The waiver was requested and supported by the NCAA Division I Student-Athlete Experience Committee.

Men's Basketball Qualifying Regular-Season Multiple-Team Events 2020-21 Season Only, *Updated November 25, 2020*

ARCHIVE INFO: BLANKET RELIEF PROVIDED ONLY FOR THE 2020-21 ACADEMIC YEAR.

Upon further review of specific urgent circumstances impacting multiple-team events during the 2020-21 playing season, the NCAA Division I Men's Basketball Oversight Committee reviewed and updated the previous blanket waiver on November 25 to provide additional relief of the qualifying regular-season multiple-team event legislation in the sport of men's basketball. The additional relief is noted below in bold text.

1. NCAA Division I men's basketball programs may participate in a multiple-team event that does not meet the legislated MTE requirements during the 2020-21 playing season provided:
2. The institution's original multiple-team event participation was impacted by an unforeseen circumstance caused by the COVID-19 pandemic (e.g., cancelled, rescheduled, an institution withdrew from the event due to state/local health and safety guidelines, institution is required to quarantine);
3. The circumstances were outside of the institution's control; and
4. One or more of the conditions outlined below is satisfied.

At the recommendation of the Men's Basketball Oversight Committee, the academic and membership affairs staff approved the blanket waiver on October 25 to permit the following:

- Two teams from the same conference may participate in the same MTE provided the teams do not play each other in the MTE, unless the contest occurs during the final round of a bracketed event;
- A team may participate in the same MTE twice in a four-year period provided the team participates in the event during the 2020-21 season and the original location of the event was moved due to the pandemic;
- An event in which each institution participates in three contests may conclude not later than 24 days after the first contest of the event;
- An event in which each institution participates in two contests may conclude not later than 19 days after the first contest of the event;
- One non-Division I team (that is not serving as the host of the MTE) may participate in an MTE provided the team is located within 450 miles of the sponsoring institution or conference;
- Teams may participate in a different number of games in an MTE provided all teams were originally scheduled to participate in the same number of games in the event;
- Teams in the same event may use different maximum contest limitations provided all teams were originally scheduled to use the same maximum contest limit; and
- A team may participate in two MTEs during the 2020-21 season provided the team does not exceed the maximum contest limitation of 27 games;
- An event may only include one contest and still be considered an MTE; and
- Two teams may compete against each other twice in the event and still be considered an MTE.

In granting this request, staff noted the unique and extenuating circumstances associated with the COVID-19 pandemic.

Countable Athletically Related Activities Following Competition in Sports Other Than Football, *Approved November 24, 2020*

ARCHIVE INFO: BLANKET RELIEF PROVIDED ONLY FOR THE 2020-21 ACADEMIC YEAR.

The NCAA Division I Committee for Legislative Relief approved a blanket waiver to permit NCAA Division I sports other than football to participate in up to one hour of film review and/or team meetings following competition when the team is competing on the following day during the 2020-21 playing season provided:

1. Teams do not participate in any physical countable athletically related activities (e.g., practice, strength/conditioning workouts, walk-through, shootaround) following competition; and
2. Time spent in film review and/or team meetings following competition be included in the daily (four) and weekly (20) hour limitations.

Finally, because the waiver creates the potential for increased required activity while potentially decreasing time that would be otherwise allocated at the discretion of student-athletes, an institution's medical staff should be properly consulted as to the impact on overall student-athlete well-being and have ultimate discretion consistent with independent medical care legislation, with respect to any required postcompetition activities that occur on the same calendar day.

In granting this request, the Committee for Legislative Relief noted:

1. The unique and extenuating circumstances associated with the COVID-19 pandemic and the impact of the pandemic on scheduling and competition during the 2020-21 playing season;
2. The Collegiate Commissioners Association Compliance Administrators (CCACA) supports the waiver request; and
3. The NCAA Division I Men's Basketball and Women's Basketball Oversight Committees and Student-Athlete Experience Committee support the waiver request.

Required Athletically Related Activities Permitted During Basketball Three-Day Winter Break, *Approved November 19, 2020*

ARCHIVE INFO: BLANKET RELIEF PROVIDED ONLY FOR THE 2020-21 ACADEMIC YEAR.

NCAA Division I autonomy men's and women's basketball programs (and those Division I institutions opting into the legislation) may participate in required athletically related activities during the three consecutive days off during the institution's official vacation period after the first term of the academic year (e.g., winter break).

At the recommendation of the NCAA Division I Men's and Women's Basketball Oversight Committees, the academic and membership affairs staff approved a blanket waiver to permit Division I basketball student-athletes to engage in Required Athletically Related Activities (RARA) only during the three-day winter break.

In granting this request, staff noted the unique and extenuating circumstances associated with the COVID-19 pandemic and that many basketball student-athletes will remain on campus during the 2020-21 winter break. Permitting basketball student-athletes to engage in RARA allows institutions to schedule activities that will discourage the potential for isolating behavior and encourage players to spend time with teammates while also providing them with an opportunity to physically rest and recover from countable athletically related activities (CARA) during the season.

During the three-day winter break period, examples of permissible activities may include, but are not limited to the following:

- Team meal.
- Team entertainment.
- Voluntary shoot around (without the presence of a coaching staff member or a sport-specific staff member).
- Athletic training/injury prevention and treatment.
- Academic advising and study table.
- Team building activities.
- Promotional activities.
- Community service.

The blanket waiver does not permit men's and women's basketball student-athletes to engage in CARA during the three-day winter break period. CARA includes any required activity with an athletics purpose involving student-athletes and at the direction of, or supervised by, one or more of an institution's coaching staff (including strength and conditioning coaches), including, but not limited to the following types of activities: practice, film review, walk-through, and shoot around.

Finally, because the nature of the request may decrease the amount of student-athlete discretionary time allocated by legislation, institutional medical staff should be properly consulted as to the impact on overall student-athlete well-being and have ultimate discretion as to the appropriateness of any supplemental required activities.

NCAA Division I women's basketball programs may participate in a qualifying regular season multiple-team event that does not meet the legislated multiple-team event requirements during the 2020-21 playing season provided:

1. The institution's original multiple-team event participation was impacted by an unforeseen circumstance caused by the COVID-19 pandemic (e.g., cancelled, rescheduled, an institution withdrew from the event due to state/local health and safety guidelines, institution is required to quarantine);
2. The circumstances were outside of the institution's control; and
3. One or more of the conditions outlined below is satisfied.

At the recommendation of the NCAA Division I Women's Basketball Oversight Committee, the academic and membership affairs staff approved the blanket waiver to permit the following:

1. Two teams from the same conference may participate in the same multiple-team event provided the teams do not play each other in the multiple-team event, unless the contest occurs during the final round of a bracketed event;
2. A team may participate in the same multiple-team event twice in a four-year period provided the team participates in the event during the 2020-21 season and the original location of the event was moved due to the pandemic;
3. An event may conclude not later than 21 days after the first contest of the event;
4. Teams may participate in a different number of games in a multiple-team event provided all teams were originally scheduled to participate in the same number of games in the event;
5. Teams in the same event may use different maximum contest limitations provided all teams were originally scheduled to use the same maximum contest limit; and
6. A team may participate in two multiple-team events during the 2020-21 season provided the team does not exceed the maximum contest limitation of 27 games (23 and up to four contests within a multiple-team event(s) or 25 contests with no multiple-team event(s).

In granting this request, staff noted the unique and extenuating circumstances associated with the COVID-19 pandemic.

The NCAA Division I Committee for Legislative Relief approved a blanket waiver to permit women's rowing teams to conduct a winter training trip on or off the institution's campus for a period of no more than two weeks during the 2020-21 academic year.

In granting this request, the Committee for Legislative Relief noted:

1. The waiver allows the NCAA Division I governance structure and coaching association time to assess team training during the winter break period and the location of practice;
2. A waiver of this legislation was granted for the 2020-21 academic year only;
3. The conference was unable to sponsor legislation to address this issue during the 2020-21 legislative cycle due to the legislative moratorium that was enacted in response to COVID- 19 pandemic. However, the conference is encouraged to sponsor legislation at the next available opportunity; and
4. Cost savings realized by institutions being able to conduct these training trips closer to and in the locale of the institution and greater ability to monitor/adhere to state, local and institutional COVID-19 safety protocols.

Men's Basketball Qualifying Regular-Season Multiple-Team Events 2020-21 Season Only, *Approved October 23, 2020*

NCAA Division I men's basketball programs may participate in a qualifying regular season multiple-team event that does not meet the legislated multiple-team event requirements during the 2020-21 playing season provided:

1. The institution's original multiple-team event participation was impacted by an unforeseen circumstance caused by the COVID-19 pandemic (e.g., cancelled, rescheduled and one institution withdrew from the event due to state/local health and safety guidelines, institution is required to quarantine);
2. The circumstances were outside of the institution's control; and
3. One or more of the conditions outlined below is satisfied.

At the recommendation of the NCAA Division I Men's Basketball Oversight Committee, the NCAA academic and membership affairs staff approved the blanket waiver to permit the following:

- Two teams from the same conference may participate in the same multiple-team event provided the teams do not play each other in the multiple-team event, unless the contest occurs during the final round of a bracketed event;
- A team may participate in the same multiple-team event twice in a four-year period provided the team participates in the event during the 2020-21 season and the original location of the event was moved due to the pandemic;
- An event in which each institution participates in three contests may conclude not later than 14 days after the first contest of the event;
- An event in which each institution participates in two contests may conclude not later than nine days after the first contest of the event;
- One non-Division I team (that is not serving as the host of the multiple-team event) may participate in a multiple-team event provided the team is located within 400 miles of the sponsoring institution or conference;
- Teams may participate in a different number of games in an multiple-team event provided all teams were originally scheduled to participate in the same number of games in the event;
- Teams in the same event may use different maximum contest limitations provided all teams were originally scheduled to use the same maximum contest limit; and
- A team may participate in two multiple-team events during the 2020-21 season provided the team does not exceed the maximum contest limitation of 27 games.

In granting this request, staff noted the unique and extenuating circumstances associated with the COVID-19 pandemic.

Noncoaching Staff Members Participation in Managerial Duties for Sports Other than Basketball and Football during 2020-21 Playing Season, *Approved September 9, 2020*

NCAA Division I sport programs in sports other than basketball and football may permit up to two Division I sport specific noncoaching staff members to engage in managerial duties during on-court and on-field practice activities (e.g., throw batting practice, pass a ball, assist with drills) provided the noncoaching staff position existed as of September 7, 2020, and the institution has prohibited some or all student managers from attending practice or other countable athletically related activities due to the health and safety impact of COVID-19 pandemic. The noncoaching staff member(s) designated to perform such on-court or on-field managerial duties must be designated by the institution and kept on file in the athletics department. The sport-specific noncoaching staff members in sports other than basketball and football are only permitted to perform these managerial duties until the conclusion of an institution's 2020-21 playing season or when the institution permits all student managers to attend practice or other countable athletically related activities, whichever is earlier.

In granting this request, the NCAA academic and membership affairs staff noted:

1. With the reduction of many managers due to the health and safety impact of COVID-19, this waiver provides flexibility for designated noncoaching staff members to participate in on-court or on-field practice activities while performing managerial duties.
2. This waiver does not permit a noncoaching staff member to engage in coaching activities;
3. This waiver provides flexibility for institutions to conduct on-court or on-field countable athletically related activities and practice activities with the typical number of staff to assist in on-court or on-field activities;
4. This waiver assists institutional efforts to limit the individuals in contact with teams to those essential to supporting the programs; and
5. The waiver was requested and supported by the NCAA Division I Student-Athlete Experience Committee and aligns with the blanket waiver approved on September 8, 2020, for noncoaching staff in the sport of basketball (See Case No. 1109415).

In cross country, field hockey, football, soccer, track and field, women's volleyball and men's water polo, institutions may apply midyear replacement legislation to provide athletics aid to a new recipient without making the second student-athlete a counter for the remainder of the 2020-21 academic year, provided the replaced student-athlete would have graduated in 2020 fall term but is returning in the 2021 spring or fall term to exhaust eligibility directly resulting from the NCAA

Division I Board of Directors' action allowing institutions to self-apply season of competition and extension of eligibility waivers due to the COVID-19 pandemic.

In granting this request, academic and membership affairs staff noted:

- The impact of the COVID-19 pandemic on student-athlete's decisions to return to exhaust eligibility;
- The Board of Directors' August 21, 2020, actions regarding the NCAA Board of Governors' directives related to student-athlete well-being - financial aid limitations (exemptions); and
- The blanket waiver only applies to the 2020-21 academic year.

Blanket Waiver Basketball Noncoaching Staff Members Participation in Managerial Duties and Women's Basketball Practice Players for 2020-21 Season, *Approved September 8, 2020*

ARCHIVE INFO: BLANKET RELIEF ONLY PROVIDED FOR 2020-21 ACADEMIC YEAR.

NCAA Division I men's and women's basketball programs may permit up to two Division I men's and women's basketball-specific noncoaching staff members to engage in managerial duties during on-court activities (e.g., rebound, pass, assist with drills) provided the noncoaching staff position existed as of September 7, 2020, and the institution has prohibited some or all student managers from attending practice or other countable athletically related activities due to the health and safety impact of COVID-19. The noncoaching staff member(s) designated to perform such on-court managerial duties must be designated by the institution and kept on file in the athletics department. The basketball-specific noncoaching staff members are only permitted to perform these managerial duties until the conclusion of an institution's 2020-21 playing season or when the institution permits all student managers to attend practice or other countable athletically related activities, whichever is earlier.

Additionally, in women's basketball, up to two basketball-specific noncoaching staff members permitted to engage in managerial duties during the 2020-21 playing season may also serve as practice players. For institutions still utilizing student managers, those student managers may also serve as practice players during the 2020-21 playing season. In both instances, the practice player duties may be performed by basketball-specific noncoaching staff members and student managers until the conclusion of the institution's 2020-21 playing season or when the institution permits practice players to attend practice, whichever is earlier.

In granting this request, the academic and membership affairs staff noted:

1. With the reduction of many managers due to the health and safety impact of COVID-19, this waiver provides flexibility for designated noncoaching staff members to participate in on-court practice activities while performing managerial duties. Additionally, in women's basketball only, this waiver provides similar flexibility for designated noncoaching staff members and managers to serve as practice players;
2. This waiver does not permit a noncoaching staff member and student managers performing practice player duties in women's basketball to engage in on-court coaching activities;
3. This waiver provides flexibility for institutions to conduct on-court countable athletically related activities and practice activities with the typical number of staff to assist in on-court activities;
4. This waiver assists institutional efforts to limit the individuals in contact with basketball teams to those essential to supporting the programs; and
5. The waiver was requested and supported by the NCAA Division I Men's and Women's Oversight Committees.

Critical Injury or Illness Insurance Blanket Waiver, *Approved August 11, 2020.*

Division I student-athletes may borrow against future earnings potential to secure a loan from an established, accredited commercial lending institution, for the purpose of purchasing critical injury or illness insurance (and other similar coverage).

In granting this request, the NCAA Division I Committee for Legislative Relief noted:

- Allowing student-athletes to secure a loan to pay for the premium for critical injury or illness insurance under the same circumstances that a student-athlete is permitted to obtain a loan to pay the premium for disabling injury or loss of value insurance is a logical extension of a current practice to a recently developed product and supports student-athlete well-being;
- The intent of NCAA Proposal No. 2014-12 was to acknowledge that student-athletes should be able to borrow against earnings potential for purpose of buying career-related insurance products other than disability insurance to assist in the decision-making process when deciding to remain in college and achieve, or get closer to achieving, the ultimate goal of obtaining a college degree; and
- The blanket waiver relief is effective through January 2022.

For the 2020 football season, NCAA Division I Football Bowl Subdivision (FBS) and NCAA Division I Football Championship Subdivision (FCS) institutions may play their first contest beginning on the Saturday prior to the Thursday preceding Labor Day. This allows an institution's first football contest to occur on Saturday, August 29, 2020.

In granting this request, the academic and membership affairs staff noted:

1. Relief is provided on a one-time basis for the 2020 football season due to the impact of the COVID-19 pandemic, specifically noting institutions should follow all applicable legislative, policy and institutional health and safety requirements;
2. The maximum contest limitations for the 2020 football season (12 for FBS and 11 for FCS) remain in effect. The FBS and FCS annual exemptions (NCAA Division I Bylaw 17.10.5.2) also remain in effect; and
3. The blanket waiver was requested by the NCAA Division I Football Oversight Committee.

This waiver permits an institutional coaching staff member to make telephone calls to prospective student-athletes (e.g., high school, two-year and four-year transfer student-athletes) at their discretion from May 2020, through the conclusion of the COVID-19 recruiting dead period.

In granting this request, the NCAA Division I Committee for Legislative Relief Administrative Committee noted:

1. This is a one-time waiver request, applicable during the COVID-19 recruiting dead period.
2. The COVID-19 pandemic, specifically noting official and unofficial visits are not permissible during the COVID-19 recruiting dead period,
3. An institution may not make telephone calls to an individual prior to April 15 of their junior year of high school; and
4. The blanket waiver was reviewed and supported by the NCAA Division I Football Oversight Committee.

Financial Aid for Olympic Hopefuls Blanket Waiver, *Approved March 27, 2020*

Division I schools may honor athletics aid agreements and exempt the 2019-20 amount from financial aid limitations for student-athletes that took a leave of absence during the 2019-20 academic year to train for official national team tryouts and competition.

In granting this request, the NCAA Division I Committee for Legislative Relief Administrative Committee noted:

1. The extenuating and extraordinary circumstances surrounding the COVID-19 pandemic;
2. The blanket waiver only applies to the 2020 spring term; and
3. The blanket waiver only applies to student-athletes who were awarded athletically related financial aid for the 2019-20 academic year and who have not yet enrolled full time during the 2019-20 academic year due to participation in:
 - a. Official Pan American, Parapan American, World Championships, World Cup, World University Games (Universiade), World University Championships, Olympic and Paralympic training, tryouts and competition;
 - b. Officially recognized training and competition directly qualifying participants for final Olympic or Paralympic tryouts; or
 - c. Official tryouts and competition involving national teams sponsored by the appropriate national governing bodies of the U.S. Olympic and Paralympic Committee (or, for student-athletes representing another nation, the equivalent organization of that nation, or for student-athletes competing in a non-Olympic or non-Paralympic sport, the equivalent organization of that sport).

The blanket waiver also permits institutions to arrange the use of institutional facilities for such workouts and allows coaches to observe the workouts without counting toward required and countable athletically related activity limits.

In granting this request, staff noted:

1. Relief is only provided after the men's basketball student-athlete receives an NBA Draft Combine invitation (including a conditional Combine invitation), or a G League Elite Camp invitation until the men's basketball student-athlete withdraws from the draft, or June 3, 2020, whichever is earlier.
2. An institution's coaching staff may observe workout activities with an outside trainer; however, they may not conduct these workout activities unless the time is included in daily/weekly time limitations.
3. The men's basketball student-athlete remains responsible for compensating the outside trainer at his or her normal rate.
4. The blanket waiver was requested by the NCAA Division I Men's Basketball Oversight Committee.

In granting this request, the NCAA Division I Committee for Legislative Relief noted:

- The request was granted based on student-athlete well-being and the elite and unique circumstances surround potential participation in the Olympic Games.

Specifically, the blanket waiver permits the following:

1. Women's swimming and diving student-athletes who achieve a 2020 U.S. Olympic Team Trials qualifying time or qualifying score by March 22, 2020, to continue to be coached by their collegiate coach through the June 21-28, 2020, Olympic Trials;
2. Men's swimming and diving student-athletes who achieve a 2020 U.S. Olympic Team Trials qualifying time or qualifying score by March 29, 2020, to continue to be coached by their collegiate coach through the June 21-28, 2020, Olympic Trials;
3. Women's swimming student-athletes who have not achieved an Olympic Trial qualifying time by March 22, 2020, to be coached by their collegiate coach through events ending May 9, 2020, provided the student-athlete achieves a time within one percent (of either the long-course meters or short-course yards time standards for the 2019 Senior National Championships) for events that are 200 meters/yards or longer and two percent for events that are 100 meters/yards and shorter;
4. Women's diving student-athletes who have not achieved an Olympic Trial qualifying score by March 22, 2020, to be coached by their collegiate coach through events ending April 26, 2020, provided the student-athlete achieves a score within three percent of the minimum qualifying score in the relevant individual or synchronized diving event for the 2020 Olympic Trials;
5. Men's swimming student-athletes who have not achieved an Olympic Trial qualifying time by March 29, 2020, to be coached by their collegiate coach through events ending May 9, 2020, provided the student-athlete achieves a time within one percent (of either the long-course meters or short-course yards time standards for the 2019 Senior National Championships) for events that are 200 meters/yards or longer and two percent for events that are 100 meters/yards and shorter; and
6. - The financial hardship that would be incurred by prospective and current student-athletes;
- The confusion surrounding the proper process for legislative changes of the impacted legislation;
- Multiple Division I institutions and conferences supported the waiver request; and
- Division I conferences named in Constitution 5.3.2.1.1 are committed to reviewing the impacted legislation during the 2018-19 legislative cycle.

Further, the Committee for Legislative Relief noted:

- This blanket waiver allows institutions to provide actual and necessary expenses to prospective student-athletes who have not yet triggered student-athlete status but are eligible to participate in summer athletics activities pursuant to NCAA Bylaws 13.11.3.9

- (required summer athletic activities - basketball) or 13.11.3.10 (required summer athletics activities - football);
- This blanket waiver allows institutions to provide actual and necessary expenses to current, enrolled student-athletes during periods of time when the student-athlete is eligible to participate in summer athletics activities pursuant to Bylaws 17.1.7.2.1.5.1 (basketball) or 17.1.7.2.1.5.2 (football), but is not enrolled in summer school (i.e., gaps in enrollment);
 - This blanket waiver allows institutions to provide expenses to student-athletes, including graduate transfers, who may participate in required summer athletics activities without being enrolled in summer school (i.e., satisfies a prong of Bylaw 17.1.7.2.1.5); and

- The event does not affect NCAA championship selections; therefore, no competitive advantage will be gained by allowing institutions and student-athletes to participate in the event; and
- The NCAA Division I Legislative Committee supported the blanket waiver for the 2017-18 academic year.

NCAA Division I men's and women's basketball programs may begin on-court preseason basketball practice September 25, 2018, which is 42 days prior to the new first permissible contest date of Tuesday, November 6.

In granting this request, the academic and membership affairs staff noted:

1. NCAA Proposal No. 2017-73 was adopted in January 2018 with an immediate effective date;
2. At the time Proposal No. 2017-73 was adopted, many NCAA Division I men's and women's basketball teams had their schedules already set for the 2018-19 basketball season and are unable to move their first contest to occur prior to the former first permissible contest date (Friday, November 9, 2018) due to contractual obligations;
3. Allowing all Division I basketball programs to commence on-court basketball practice on September 25, 2018, eliminates any potential competitive advantage gained by those institutions who are able to schedule their first contest prior to November 9, 2018;
4. NCAA Division I men's and women's basketball teams shall not engage in more than 30 days of countable athletically related activities before the institution's first regular-season contest;
5. National Association of Basketball Coaches and Women's Basketball Coaches Association support the waiver request; and
6. This waiver is only for the 2018-19 basketball season.

Further, as part of the blanket waiver, Division I institutions should note that attendance at the Next Generation Showcase does not count toward the institution's 130 recruiting person days. All other Division I and Division II recruiting legislation (e.g., contact with a prospective student-athlete) applies.

In granting this request, the Division I and Division II Committees for Legislative Relief noted:

- The celebratory nature of the NCAA Final Four Fan Fest and Next Generation Sunday will provide educational programming daily to its participants.
- Approval of the blanket waiver allows the NCAA Division I and Division II governance structures time to assess the basketball recruiting dead period legislation and events held in conjunction with the NCAA Division I Men's Basketball Championships.
- The blanket waiver was supported by the National Association for Basketball Coaches.
- The blanket waiver was reviewed and supported by the NCAA Division I Men's Basketball Oversight Committee and the NCAA Division II Men's Basketball Committee.

Twenty Football Bowl Subdivision (FBS) and NCAA Football Championship Subdivision (FCS) institutions' first contests are scheduled to occur between August 24 and August 31, 2017. Without the waiver, no on-campus recruiting activities would be permissible. This conflict was an unintended consequence of the newly adopted legislation;
- Approval of the blanket waiver allows the NCAA Division I Council governance structure time to assess the new football recruiting dead period legislation;
- The blanket waiver is supported by multiple Division I institutions representing FBS and FCS institutions; and
- The blanket waiver was reviewed by the NCAA Division I Football Oversight Committee. The Football Oversight Committee will continue to evaluate the issue and consider whether to propose a legislative solution.

Women's Ice Hockey Contest Against A Team That Has Qualified For The 2018 Winter Olympics. *Approved May 3, 2017.*

The NCAA Division I Committee for Legislative Relief approved a blanket waiver in the sport of women's ice hockey to permit teams to exempt one contest in the United States during the 2017-18 academic year against an international team that has qualified for the 2018 Winter Olympics and is training in the U.S.

In granting this request, the Committee for Legislative Relief noted:

- The intent of the legislation to allow an institution to exempt one contest against the U.S. Olympic team during that team's training for participation in the Winter Olympics from its annual ice hockey contest limitations, is to allow Team USA to compete against as many Division I institutions as possible.
- The women's U.S. National Team is not competing against any collegiate institutions leading up to the 2018 Winter Olympics.
- Approving the blanket waiver request does not allow an institution to exempt an additional contest.
- The unique competition opportunity for women's ice hockey student-athletes.

- Applicant conference must work with applicable bodies to sponsor legislation to address similar issues in future years;
- The American Volleyball Coaches Association supports the waiver request; and
- Due to the circumstances addressed in the request, (i.e., postseason championship competition), the academic and membership affairs staff received feedback from the NCAA Division I Committee on Women's Athletics and the NCAA Division I Softball Committee.

- Given the timing of these all-star events, incoming student-athletes would potentially be otherwise required to forego the opportunity to participate in an all-star contest or delay summer school enrollment in order to participate in the event.
