**INFORMATIONAL ITEMS.**

1. **Review of NCAA Division I Committee for Legislative Relief's February 20, 2025, report.** The Committee for Legislative Relief reviewed and approved its February 20, 2025, report.
2. **NCAA Division I Governance Update.** The Committee for Legislative Relief received an update on recent and upcoming Division I governance meetings including an update from the NCAA Division I Decision-Making Working Group. The Decision-Making Working Group has proposed changes to the NCAA Division I governance structure which would change the current structure, including altering all Division I committee responsibilities and composition. The proposed structure may include a consolidation of the Committee for Legislative Relief with other committees. The NCAA Division I Board of Directors will consider the changes to the structure during its June 23, 2025, meeting.
3. **NCAA Office of Legal Affairs Update.** The committee received an update from the NCAA Office of Legal Affairs.
4. **Review of the 2024-25 Required Day off During the Playing Season blanket waiver.** The committee reviewed and provided feedback on the 2024-25 Required Day off During the Playing Season blanket waiver request. The committee may choose to review the waiver at a future videoconference.
5. **Update on the Student-Athlete Eligibility Review.** The committee received an update on the review of the student-athlete eligibility legislation. The review of student-athlete eligibility has been paused while other legislative changes are considered. The NCAA Division I Council does not plan to consider any student-athlete eligibility legislation changes during the June meeting.
6. **Overview of Cases from January 1, 2025, through April 30, 2025.** The committee received an overview of the cases decided by the committee and the NCAA academic and membership affairs staff from January 1, 2025, through April 30, 2025.
