INFORMATIONAL ITEMS.

- **2021 Preliminary Round Site Determinations – Men’s Lacrosse, Women’s Lacrosse, Men’s Tennis and Women’s Tennis.** The committee approved recommendations for potential preliminary round hosts as detailed below. The respective sport committees evaluated the potential hosts based on a combination of strength of teams, geographical location and host and facility capabilities.

Men’s Lacrosse – First Round: The NCAA Division I Men’s Lacrosse Committee will narrow down the six sites (refer to table immediately below) to four sites on Sunday, May 9 when selections are announced. Each site will host two first round games.
