ACTION ITEMS.

INFORMATIONAL ITEMS.

- 1. Women’s volleyball – regional competition option.** The Competition Oversight Committee approved the recommendation from the Division I Women’s Volleyball Committee to expand the regional rounds of competition so that they may be conducted either on Thursday/Saturday or Friday/Sunday. The COC agreed with the sport committee’s rationale that providing the option will increase broadcast coverage of the regionals and has minimal impact on host institutions and participating teams.

- 2. Women’s beach volleyball – day change for the opening-round dual.** The COC also approved the recommendation from the NCAA Women’s Beach Volleyball Committee to conduct the opening-round dual of the championship on Friday as the first dual of the day versus Wednesday as the only dual that day. The COC agreed with the sport committee’s rationale that moving the dual to Friday will enable national television exposure on ESPNU and ESPN+ and will enhance participants’ experience as being a true part of the championship. The first match on Friday would start at 8 a.m. local time, which is just one hour earlier than the current start time for the day. The winning team will play one more match later in the day, which is not a significant impact on the participating team.
