

REPORT OF THE NCAA DIVISION I COUNCIL JANUARY 11, 2023, MEETING

In an effort to connect NCAA Division I Council items to the NCAA pillars of academics, fairness and well-being, items included in this report have an identifying pillar. There is an additional pillar, operational, that is used to denote items that relate to maintaining a stable and efficient Division I.

KEY ITEMS.

- 1. NCAA Division I Transformation Committee Update. (Academics/Fairness/Well-Being/Operational) The NCAA Division I Council received a presentation from Transformation Committee co-chairs Greg Sankey and Julie Cromer, who guided the Council through the committee's <u>final report</u> to the NCAA Division I Board of Directors. The co-chairs summarized the committee's progress over the past year and reviewed the broad areas upon which the committee focused its work. The co-chairs also reviewed the specific recommendations to the Board of Directors and emphasized that they offer a roadmap for groups within the governance structure to modernize the division in the coming months.
- 2. Undergraduate Transfer Waiver Guidelines. (Fairness/Well-Being/Operational) The Council approved recommendations from the NCAA Division I Council Transfer Advisory Group on undergraduate four-year college transfer waiver guidelines. The approved guidelines will be used to assess waivers submitted for undergraduate transfer student-athletes whose first championship season occurs at a different Division I institution during the 2023-24 academic year. The Council action included the following:
 - a. Elimination of all existing undergraduate transfer waiver guidelines, except for the student-athlete physical injury or illness, student-athlete mental health and diagnosed education impacting disability guidelines;
 - b. Updated the existing student-athlete physical injury and illness guideline to remove the need for the previous institution to provide its understanding of why the student-athlete transferred;
 - c. Updated the existing student-athlete mental health guidelines to require a causal connection between the student-athlete's mental health and their transfer decision be demonstrated, as well as the student-athlete's distance from their support system be considered. Additionally, instruct the NCAA staff to coordinate with the Mental Health Panel to establish best practices for care plans;
 - d. Approved a new exigent circumstance guideline for situations that are pressing, demanding and clearly necessitate a student-athlete's departure from the institution (e.g., physical assault or abuse, sexual assault) and are unrelated to the student-athlete's athletics participation (e.g., playing time, position preference or changes to athletics scholarship); and
 - e. Recommended that the Transfer Advisory Group consider the current waiver review processes and make recommendations for appellate review, including certain

waiver requests that fall outside of the recommended guidelines and/or information standards.

Additionally, the Council affirmed that undergraduate transfer waivers submitted based on academic reasons (e.g., degree offered does not meet expectations, change of major) or athletic reasons (e.g., reduced playing time, change of position) will be denied.

3. Legislative Actions. (Academics/Fairness/Well-Being/Operational) The Council adopted four proposals, defeated one proposal and referred two proposals in the regular 2022-23 legislative cycle. The Council adopted seven proposals as noncontroversial legislation. Additional information is included below. All legislative actions are detailed in Attachment A and voting results are available in Attachment B.

(Note: Noncontroversial and emergency legislation is final at the conclusion of the Division I Council meeting. Noncontroversial and emergency legislation with an immediate effective date is effective January 11, 2023. Standard review legislation (other than noncontroversial and emergency legislation) adopted by the Council is not final until the conclusion of the Board of Directors meeting (January 12), during which the Board has the opportunity to review the legislation. Such legislation with an immediate effective date is effective January 12, 2023.)

a. NCAA Division I Proposal No. 2022-28 – Athletics Personnel. The Council adopted Proposal No. 2022-28 – Athletics Personnel and Recruiting – Limitations on the Number of Coaches and Off-Campus Recruiters and Recruiting Coordination Functions, which eliminates the volunteer coach designation, increases the number of countable coaches permitted in applicable sports, and eliminates the recruiting coordination functions legislation. The proposal also removes "makes or assists in making tactical decisions related to the sport during on-court or on-field practice or competition" as an element of the definition of a countable coach. Additionally, the proposal amends the graduate assistant coach designation in bowl subdivision football and eliminates the graduate assistant coach designation in championship subdivision football, swimming and diving, and women's rowing.

At the recommendation of the NCAA Division I Men's and Women's Basketball Oversight Committees, the Council <u>approved</u> a modification to the proposal that removed the seven-year limit for an individual to be eligible to serve as a manager in basketball.

b. Proposal No. 2022-30 – Men's and Women's Basketball Coaches. The Council adopted Proposal No. 2022-30 – Athletics Personnel and Recruiting – Limitations on the Number of Coaches and Off-Campus Recruiters – Basketball, which increases from four to six the limit on the number of coaches who may be employed by an institution and specifies that the two additional coaches shall not contact or evaluate prospective student-athletes off campus and are subject to the restrictions related to individuals associated with prospective student-athletes (men's basketball) and recruited prospective student-athletes (women's basketball).

- c. Proposal No. 2022-32 Official and Unofficial Visits. The Council referred Proposal No. 2022-32 Recruiting Official and Unofficial Visits to the NCAA Division I Legislative Committee to consider dividing the proposal for separate votes during the Council's April 2023 meeting. At the recommendation of the Division I Legislative Committee, the Council approved a modification of the proposal to remove the proposed elimination of sport-specific institutional official visit limitations that apply to baseball, basketball and football.
- d. Proposal No. 2022-34 Test-Score Requirements. The Council <u>adopted</u> Proposal No. 2022-34 Academic Eligibility Freshman Academic Requirements Elimination of Test-Score Requirements, which eliminates the standardized test score requirement from the initial-eligibility requirements and establishes minimum grade-point average requirements, as specified.
- e. Proposal No. 2023-1 Notification of Transfer Undergraduate Student-Athlete Exceptions. The Council <u>adopted</u> Proposal No. 2023-1 as noncontroversial legislation to specify that a student-athlete who will fulfill the conditions of an exception for a transfer from a four-year college set forth in NCAA Bylaw 14.5.5.2 other than the one-time transfer exception may initiate the notification-of-transfer process at any time by providing the student-athlete's institution with a written notification of transfer and completing an educational module related to transferring.
- f. Proposal No. 2023-4 Undergraduate 4-4 Transfer Athletics Aid. (Fairness/Operational) The Council <u>adopted</u> Proposal No. 2023-4 as noncontroversial legislation to specify that only an undergraduate four-year transfer awarded or issued athletically related financial aid in the academic year of initial full-time enrollment at the certifying institution shall be a counter for the period of the award (see Bylaw 15.3.3.3) unless a provision of Bylaw 15.5.1.2.1 is met.

ACTION ITEMS.

None.

INFORMATIONAL ITEMS.

- 1. Gender Equity Review. (Fairness/Well-Being/Operational) The Council received an update on the progress on recommendations included in the Phase 1 and Phase 2 gender equity reports. Additional information is available here.
- 2. Federated Playing Rules. (Operational) The Council received an update on the steps to establish processes to provide for federated playing rules, consistent with a provision for such included in the new NCAA Constitution. The NCAA Playing Rules Oversight Panel is expected to recommend in April that divisional governance bodies pursue legislative

actions to eliminate the requirement that playing rules must be common for all divisions. With the legislative change, a process will be proposed for Division I to handle recommendations for federated playing rules. The NCAA Division I Competition Oversight Committee, Men's and Women's Basketball Oversight Committees and the Football Oversight Committee discussed this issue during their meetings and provided feedback on how to develop a federated process for establishing playing rules, including a review of the composition of the adjudicating bodies within the process.

- 3. Reports from Council Committees. The Council received reports from the Council standing committees that included recommended actions and informational items. Roll call vote results of legislative actions are included in Attachment B.
 - a. **Division I Men's Basketball Oversight Committee.** The Council received a report from the Men's Basketball Oversight Committee that included the following informational item:
 - Reallocation of 2023 Men's College Basketball Academy Evaluation Days. (Operational) The Men's Basketball Oversight Committee anticipates that the 2023 Men's College Basketball Academy will occur over a four-day period rather than during the six-day legislated recruiting period in July. The Men's Basketball Oversight Committee discussed reallocating the two remaining evaluation days originally designated for recruiting activities associated with the Men's College Basketball Academy to two different days in July 2023. The Men's Basketball Oversight Committee will work with National Association of Basketball Coaches to recommend when the two evaluation days will occur. The Men's Basketball Oversight Committee will provide dates as a recommendation to the NCAA Division I Council Coordination Committee for approval. [Note: The total number of men's basketball evaluation dates in July will remain the same (10 evaluation days).]
 - **b. Division I Women's Basketball Oversight Committee.** The Council received a report from the Women's Basketball Oversight Committee that included the following informational items:
 - Championship Update. (Operational) The Women's Basketball Oversight Committee previewed the 2023 NCAA Division I Women's Basketball Championship, noting the NCAA's continued/additional investments relative to the growth of the championship and operational matters. Thirteen Corporate Champions and Partners, which represents most of the existing Corporate Champions and Partners, have currently opted in for 2023 Women's Final Four activations. The Corporate Champions and Partners that are activating are doing so in full scope from sponsorship and involvement within ancillary events; student-athlete elements; branding and signage; in-venue and local in-market elements; broadcast and digital

marketing elements; and hospitality. Ticket sales are trending ahead of historical benchmarks for regionals (2023 is the first year with the two-site regional model) and the Women's Final Four.

- 2) Transfer Activity Update. (Operational) The Women's Basketball Oversight Committee reviewed data from the transfer portal from 2020-2022 indicating that 74% of student-athletes who entered the portal in 2022 transferred to another NCAA member institution; 4% withdrew from the portal in 2022; and the remainder stayed active in the portal. Women's basketball has the second-highest women's sport total of student-athletes entering the transfer portal (24% of women's basketball student-athletes). Thirty percent of student-athletes who entered the transfer portal did so as prospective graduate students.
- 3) Implementation of Gender Equity Recommendations. (Fairness/ Operational) The Women's Basketball Oversight Committee received updates on the following:
 - a) The current work on the College Basketball Academy for women's basketball and the proposed model for summer 2023. The Women's Basketball Oversight Committee reviewed the previously identified goals, principles, budget, scheduled development and key timeline/benchmarks.
 - b) The continued focus on an agenda that includes education on mental and physical wellness and name, image, and likeness, along with NCAA rules and compliance, recruiting, professional opportunities, and the transfer portal for both players and chaperones.
 - c) Efforts to develop new and continuing officials with performance evaluations.
 - d) The status of a second NCAA-supported postseason tournament for women's basketball, noting that work continues to finalize the finances needed to support this event and for it to occur for the first time in the spring of 2024.
- Operational) The Women's Basketball Oversight Committee received an update on the current work on the College Basketball Summer Initiative Group for women's basketball and discussed the group's guiding principles and reviewed applicable legislation regarding student engagement in the summer period. There are plans to survey the Division I membership on summer school and access timelines to determine the impact on overall

calendars. The committee noted the need to conduct a review of how these activities could impact time off/recharge opportunities for student-athletes and coaches. The committee would like to collaborate with men's basketball in this regard while acknowledging the need to remain aware of women's student-athletes' and coaches' specific needs.

- Group. (Well-Being/Operational) The Women's Basketball Oversight Committee reviewed the opportunity to provide Student-Athlete Engagement Group members with access to behind-the-scenes and in-depth exposure to the many possibilities the sport has to offer after degree completion by attending the Women's Final Four. The program encourages the engagement group members to see the sport from a different perspective and introduce career opportunities that exist off the court. Select Student-Athlete Engagement Group members will conduct official business, meet with sport and industry leaders, participate in volunteer and community service initiatives and explore a career as a collegiate college official and/or coach. This coming year will serve as the pilot year of the program with the Women's Basketball Oversight Committee requesting permanent funding for the program in 2024 and beyond through the NCAA's next budget cycle.
- c. Joint Division I Men's and Women's Basketball Oversight Committees. The Council received a report from the joint Men's and Women's Basketball Oversight Committees that included the following informational items:
 - 1) Notification-of-Transfer Windows. (Fairness/Well-Being/Operational) The committees noted their continued support for basketball-specific windows anchored on a May 1 close date. The committees will continue collecting data and lessons learned from spring 2023 and develop recommendations for 2024 and beyond.
 - 2) Noncoaching Staff Blanket Waiver. (Operational) Anticipating the Council's vote on Proposal No. 2022-30, the committees directed the NCAA staff to extend the blanket waiver if Proposal No. 2022-30 is adopted by the Council to cover the time between the expiration of the blanket waiver (after last contest) and the start date of the proposal (July 1, 2023).
 - 3) Foreign Tour Waiver. (Fairness/Operational) The committees noted that the National Association of Basketball Coaches and the Women's Basketball Coaches Association requested, and staff approved a waiver to permit one men's and one women's team to be selected by the coaches associations to represent the United States in the 2023 Canada Basketball GloblJam without having to count those institutions' participation as their once-infour-years foreign tour. As part of the waiver approval, the coaches

associations will provide a plan on how to satisfy the current NCAA legislation in future years.

- **d. Division I Competition Oversight Committee.** The Council received a report from the Competition Oversight Committee that included the following informational items:
 - 1) Transformation Committee Report. (Operational) The Competition Oversight Committee reviewed the Transformation Committee's final report being submitted to the Division I Board of Directors, focusing particularly on the section pertaining to Division I championships. The Competition Oversight Committee appreciated the Transformation Committee's commitment to supporting championships and noted how some of the recommendations align with objectives the Competition Oversight Committee is pursuing (e.g., increase seeding to at least 50% for team sport championships).

The Competition Oversight Committee also noted the Transformation Committee's recommendation to accommodate access for 25% of active Division I members in good standing in team sports sponsored by more than 200 schools. The Competition Oversight Committee noted that if the Board of Directors approves moving forward with this recommendation, the relevant sport committees and oversight committees will be asked to review it by June 2023 and make final recommendations by January 2024 for implementation with the 2024-25 championships. The Competition Oversight Committee will explore this recommendation further, including the process to seek feedback from sport committees, during an upcoming meeting.

2) Bracketing Pilot Review. (Operational) The Competition Oversight Committee reviewed its pilot initiative implemented this past fall for women's soccer and women's volleyball in which 50% of the participants were seeded. Both sport committees reported that the increased seeding percentage produced a significantly enhanced championship experience. Given that the pilot was successful, the committee agreed to extend it to all team sports for 2023-24.

The Competition Oversight Committee also is interested in exploring other ideas that would help support bracket integrity (e.g., seeding 75%). In addition, the women's soccer and women's volleyball committees offered other suggestions to refine the process. Accordingly, the Competition Oversight Committee asked both sport committees to convene jointly to determine whether any adjustments should be made (noting that they could be sport-specific) and report recommendations before the committee meets in April to begin deliberating budget allocations for the coming cycle.

- 3) Men's and Women's Tennis Championships. (Well-Being/Operational) The Competition Oversight Committee approved a two-year pilot beginning in the fall of 2024 to conduct the singles and doubles portion of the NCAA Division I Men's and Women's Tennis Championships in the fall rather than in the spring. The action is meant to improve the tennis championships; clearly define, brand and enhance the fall and spring seasons; and support student-athlete health and safety by reducing the length of the current combined team and individual portion of the championships in the spring. A two-year pilot is an appropriate approach to ultimately determine whether the split format is best for the sport.
- Women's Golf Championships. (Fairness/Operational) The Competition Oversight Committee approved a recommendation from the women's golf committee to increase the number of teams advancing to the finals site from 27 to 30, effective for the 2023 championships. The Competition Oversight Committee's previous approval of an increase from 24 to 27 was implemented to align the percentage of teams advancing with men's golf. However, the sport committee noted the access ratio was being counted twice for access to the championship and access to the finals site, which is not the case for other sports (e.g., men's soccer has a 48-team tournament and women's soccer has a 64-team tournament but both tournaments have four teams at the finals site). The resulting field size of 156 also was acknowledged as the ideal maximum for major golf tournaments.
- Specifications for Nonpredetermined Sites. (Well-Being/Operational) The Competition Oversight Committee discussed issues during recent championship seasons in which some institutions that had earned the right to host via their seeds did not provide a championship-level experience for the participating teams (e.g., lack of proximate lodging, inadequate locker rooms, etc.). Such instances violate the core principle of providing an exemplary student-athlete experience in all championship rounds. Accordingly, the committee took the following actions:
 - a) Changed the guidelines outlined in bid specifications to requirements;
 - b) Charged sport committees with strengthening specifications as necessary and moving the submission deadline up to facilitate a more thorough evaluation;
 - c) Reinforced to sport committees to communicate clearly and formally that failure to meet these requirements will impact the institution's opportunity to host in the future, even if their seeding merits it; and

- d) Urged Competition Oversight Committee members to raise this issue at their conference meetings.
- 6) Championships Awards Program. (Operational) The Competition Oversight Committee continued discussing whether to award trophies to advancing teams at the preceding round as opposed to at the finals site, in order to present something tangible for teams to celebrate in the moment of advancement rather than after a defeat at the finals. The committee agreed to implement the following procedures:
 - a) For sports with regionals, present trophies to regional winners at the regional sites and to the national champion at the finals site. Also provide a trophy to the runner-up.
 - b) For sports with a single site only, present the trophy to the national champion. Also provide a trophy to the runner-up.
 - c) For sports with team place determined by a total of individual points, present trophies based on an Olympic model of gold (champion), silver (runner-up) and bronze (third place).
- **e. Division I Football Oversight Committee.** The Council received a report from the Football Oversight Committee that included the following recommendations and informational items:
 - 1) Waiver of Football Bowl Subdivision Attendance Audit Requirement. (Operational) The Council approved a waiver of Bylaw 20.10.9.3.2 (certified audit) for the 2022-23 academic year. Football Bowl Subdivision institutions will not be required to undertake a certified audit verifying its football attendance for 2022-23. Approving a waiver for the 2022-23 academic year provides time for the Football Oversight Committee to learn whether the Board of Directors will establish a review of FBS membership requirements per a recommendation from the Transformation Committee and, if so, to provide recommendations.
 - 2) The Role of Football in Division I. (Well-Being/Operational) The Football Oversight Committee continued its discussion on the role of football in the division. The committee began discussions related to its composition and structure to determine how the committee can best position itself to respond to the unique needs of each subdivision. The committee continues to express support for a joint football committee to discuss issues impacting each subdivision (e.g., recruiting, playing rules).
 - 3) 2023 Football Survey. (Operational) The Football Oversight Committee will solicit feedback from FBS and NCAA Football Championship

Subdivision conferences and the American Football Coaches Association on legislative concepts and topics the committee will discuss during the 2022-23 and 2023-24 academic years in the following areas:

- a) The NCAA Division I Football Oversight Committee Comprehensive Recruiting Review Subgroup recruiting model recommendations;
- b) The May 2022 annual signing/initial counters blanket waiver; and
- c) The football redshirt rule (Bylaws 12.8.3.1 and 12.8.3.1.6).

The survey will be distributed electronically on January 17, with responses due by January 31. The committee will review the survey results in mid-February.

- 4) Revised Recruiting Calendar. (Fairness/Well-Being/Operational) The Football Oversight Committee's revised recruiting model would modify the recruiting calendar, reduce off-campus recruiting activities during the fall and spring and modify the first opportunity for recruiting activities (telephone calls, electronic correspondence, off-campus contact). Based on membership feedback, the committee may recommend legislation to revise the current recruiting model to be effective before August 1, 2023.
- f. NCAA Division I Student-Athlete Advisory Committee. The Council received a report from the Student-Athlete Advisory Committee that included the following informational items:
 - 1) Transformation Committee Report. (Fairness/Well-Being/Operational) The Student-Athlete Advisory Committee reviewed the Transformation Committee's final report and noted its appreciation for the opportunity to collaborate on recommendations that enhance the student-athlete voice and experience.
 - 2) Outreach. (Operational) The Student-Athlete Advisory Committee is working to schedule another Town Hall meeting for student-athletes and will conduct the committee's annual video contest and various social media campaigns. The committee also created a midyear feedback form to optimize opportunities to increase efficiency at the national and conference levels.
- g. NCAA Division I Student-Athlete Experience Committee. The Council received a report from the Student-Athlete Experience Committee that included the following recommendations and informational items:

1) Preenrollment Amateurism Policies – Codification. (Operational) The Council <u>introduced</u> legislation into the 2023-24 legislative cycle to codify preenrollment amateurism policies in the 2022-23 Division I Council-Approved Review Process related to minimal competition, national/international competition and low-level/loosely organized competition.

<u>Rationale</u>. The proposal is consistent with rules modernization initiatives and aligns legislation with preenrollment amateurism policies that have been applied since 2014-15 as part of the Council-Approved Review Process. Although these policies are currently applied, codification of the standard date simplifies educational messaging, promotes consistency and actively guides prospective student-athletes on avoiding a delayed-enrollment condition.

- 2) Sport-Specific Recruiting Proposals. (Operational) The Student-Athlete Experience Committee plans to recommend that the Council, during its April meeting, adopt noncontroversial legislation to modify the recruiting calendars in the following sports:
 - a) <u>Women's Lacrosse</u>. Include shutdown periods and additional dead periods to promote the well-being of prospective student-athletes and coaches and protect the time for professional development for coaches during their annual convention. A significant majority of the Division I women's lacrosse coaches support this proposal.
 - b) <u>Baseball</u>. Add recruiting shutdown periods during the weeks of Thanksgiving and Christmas to provide coaches a timely break from recruiting and allow them to balance their personal and professional lives. Further, the timing of this shutdown allows prospective student-athletes a break from the recruiting process to spend time with their families during a holiday period that typically has fewer academics and athletics demands.
 - c) <u>Swimming and Diving</u>. Create recruiting shutdown periods to provide a healthier, more sustainable recruiting process that enables coaches and prospective student-athletes to make more informed decisions.
- 3) Proposal No. 2019-108 Baseball Recruiting Model. (Operational) The Student-Athlete Experience Committee plans to recommend that the Council, during its February 15 videoconference, remove Proposal No. 2019-108 from the table and amend it to reflect a phased recruiting timeline, as follows:

- a) August 1 of the junior year permissible to send correspondence, private messages, outgoing telephone calls, and accept incoming telephone calls.
- b) September 1 of the junior year permissible to engage in unofficial visits, official visits, and off-campus contact.

As part of its review of early recruiting throughout 2018-19, the Student-Athlete Experience Committee recommended the introduction of Proposal No. 2019-108, which was tabled in the spring of 2020. Since then, changes to professional opportunities and the climate surrounding roster management have resulted in a preference for recruitment later in a prospective student-athlete's educational path. An amendment to the proposal in February will allow for sufficient notice to the membership before an April vote on the amended proposal.

- h. NCAA Division I Strategic Vision and Planning Committee. The Council received a report from the Strategic Vision and Planning Committee that included the following recommendation:
 - **Single-Sport Conference Moratorium.** (Operational) The Council extended the tabling of Proposal No. 2020-17 (Automatic Qualification Single-Sport Conferences Grace Period and Field Selection) to at least June 2023. Although the Transformation Committee has delivered its report, there is still a significant amount of work to be done on membership issues. Clarity on future membership requirements and processes is necessary before re-opening the single-sport conference application process.
- **5. Report of the December 14 Council Videoconference.** (Operational) The Council approved the report of its December 14 videoconference.
