

REPORT OF THE NCAA DIVISION I COUNCIL JANUARY 15, 2025, IN-PERSON MEETING

In an effort to connect NCAA Division I Council items to the NCAA pillars of academics, fairness and well-being, items included in this report have an identifying pillar. There is an additional pillar, operational, that is used to denote items that relate to maintaining a stable and efficient Division I.

<u>KEY ITEMS</u>.

- Legislative Actions. (Academics/Fairness/Well-Being/Operational) The Division I Council adopted the following key legislative actions, effective on the dates specified. All legislative actions are detailed in Attachment A and voting results are available in Attachment B.
 - NCAA Division I Proposal No. 2024-12 Playing and Practice Seasons a. Preseason Practice Scrimmages/Exhibition Contests - Men's Basketball. The NCAA Division I Men's Basketball Oversight Committee adopted, and the Division I Council took no action on Proposal No. 2024-12, which is now considered adopted and final. The proposal permits, in men's basketball, an institution to play up to two preseason practice scrimmages and/or exhibition contests (or one of each) against a four-year collegiate institution prior to the first permissible contest date, provided the contests do not occur at a prospective student-athlete's educational institution or a facility that is regularly used by prospective student-athletes for practice or competition. In addition, the proposal eliminates the requirements that a preseason practice scrimmage must be conducted in privacy and without publicity or official scoring and that no class time shall be missed by men's basketball student-athletes in conjunction with such a scrimmage. The proposal is effective immediately for preseason exhibition contests and practice scrimmages occurring on or after August 1, 2025. A contract signed before January 14, 2025, may be honored.
 - b. Proposal No. 2024-57 Athletics Personnel Limitations on the Number of Off-Campus Recruiters Men's Basketball. The Men's Basketball Oversight Committee adopted, and the council took no action on Proposal No. 2024-57, which is now considered adopted and final. The proposal specifies that only four countable coaches may use a recruiting-person day during any single day when off-campus recruiting activities are permitted. The proposal is effective immediately.
 - c. Proposal No. 2024-59 Playing and Practice Seasons Baseball Length of Playing Season. The council divided the proposal for separate votes on the sections related to the length of the playing season and the section related to the number of nonchampionship season contests. The separate sections were renumbered as Proposal No. 2024-59-A and 2024-59-B. The council <u>adopted</u> the sections related to the length of the playing season (Proposal No. 2024-59-A). The council <u>tabled</u> the section related to the number of nonchampionship season contests (Proposal No. 2024-59-B). Proposal No. 2024-59-A is effective August 1, 2025. Proposal No. 2024-59-B may be addressed again after issues related to the roster limitations are resolved.

- d. Proposal No. 2024-62 Playing and Practice Seasons Women's Soccer First Date of Competition and Transition Period. The council <u>adopted</u> Proposal No. 2024-62, which moves up the first permissible contest date to the Wednesday before the 14th week before the start of the NCAA Division I Women's Soccer Championship. The proposal also creates a transition period prior to the preseason practice period. The proposal is effective July 1, 2026.
- e. Proposal No. 2024-64 Championships and Postseason Football National Collegiate Championships Women's Wrestling. The council <u>adopted</u> Proposal No. 2024-64, which establishes the NCAA Women's Wrestling National Collegiate Championship and creates the NCAA Women's Wrestling Committee. The proposal was subsequently adopted by Divisions II and III on January 17 and is effective immediately.
- f. Proposal No. 2024-65 Division Membership Definitions and Applications Single-Sport Conference – Sports Other Than Basketball and Football. The council <u>adopted</u> Proposal No. 2024-65, which, in sports other than basketball and football, establishes a definition and requirements for single-sport conferences. The proposal is effective immediately for new single-sport conferences. Entities that operated multiple single-sport conferences prior to the 2024-25 academic year are not required to submit applications for existing single-sport conferences. However, if a new single-sport conference is added, an application will be required.
- g. Proposal No. 2024-66 Division Membership Change of Division Membership – Division II or Division III to Division I. The council <u>adopted</u> Proposal No. 2024-66, which revises the process for institutions reclassifying from Division II or Division III to Division I. Before adopting the proposal, the council amended it to require that before advancing to active status, each of an institution's teams shall achieve a 930 multiyear NCAA Division I Academic Progress Rate from its most recent data submission. The proposal is effective immediately for an institution beginning the reclassification process during the 2025-26 academic year and thereafter. Institutions currently in the reclassification process may submit a request to the NCAA Division I Strategic Vision and Planning Committee to participate in the updated process.
- h. Proposal No. 2024-68 Committees Association-Wide Committees General Committees – Committee on Diversity, Equity, Inclusion and Belonging. The council <u>adopted</u> Proposal No. 2024-68, which transitions the NCAA Minority Opportunities and Interests Committee and the NCAA Committee on Women's Athletics to the NCAA Committee on Diversity, Equity, Inclusion and Belonging. The proposal was adopted by all three divisions and is effective September 1, 2025.

ACTION ITEMS.

INFORMATIONAL ITEMS.

- 1. Update from NCAA President Charlie Baker. (Fairness/Well-Being/Operational) The council received an update from President Baker on issues related to the proposed settlement of legal cases and the future Division I decision-making structure.
- 2. Update and Discussion of National Division I and Association-Wide Issues. (Academics/Fairness/Well-Being/Operational) The council received an update on the current legal landscape, including the proposed settlement of student-athlete compensation cases. In addition, the council received an update on congressional engagement efforts.
- Future Division I Decision-Making Structure. (Academics/Fairness/Well-Being/ 3. Operational) The council discussed the charge, timeline and roster for the NCAA Division I Decision-Making Working Group. The working group is tasked with developing a recommendation to redesign the Division I decision-making structure. The recommendation will be presented to the NCAA Division I Board of Directors, which has authority to adopt changes to the governance structure. The working group is asked to make a final recommendation not later than June 2025. It was noted that board action may be required sooner to allow the new structure to be populated and operational by the time the proposed settlement is effective in July 2025. The working group will collaborate with the autonomy conferences as they are preparing to develop a revised autonomy structure, which will also be acted on by the Board of Directors. The scope of the working group is limited to the decision-making structure for elements that are not currently, or which will be in the future, identified as areas of autonomy. It is anticipated that throughout the concept development process, the working group will seek feedback from the membership.
- 4. Update on Comprehensive Student-Athlete Eligibility Legislation Review. (Academics/Fairness/Well-Being/Operational) The council received an update on the comprehensive review of student-athlete eligibility legislation, which was authorized in June 2024. The council reviewed and provided feedback on concepts relating to agents, seasons of competition and the five-year period of eligibility. The council will continue to review and discuss these concepts during its upcoming meetings. Additional eligibility-related concepts will be discussed by the council on a rolling basis with anticipated completion of the review in October 2025.
- 5. Update on Transfer Portal Data, Division I Graduation Rates and the Development of the NCAA Division I Graduation Passport. (Academics/Fairness/Well-Being/ Operational) The council received a report on transfer portal data, Division I graduation rates, and the development of the NCAA Division I Graduation Passport. The Graduation Passport would modernize and enhance graduation tracking of all NCAA student-athletes with an emphasis on new graduation metrics and graduation of transfer student-athletes.

6. **Reports from Council Committees.** The council received reports from its standing committees that included action and informational items. Roll-call vote results of legislative actions are available in Attachment B.

a. NCAA Division I Men's Basketball Oversight Committee.

• July and August 2025 Recruiting Calendar Changes. (Fairness/Well-Being/Operational) The Men's Basketball Oversight Committee <u>amended</u> the men's basketball recruiting calendar for July and August 2025 due to the cancellation of the 2025 NCAA College Basketball Academy. The alterations create a dead period July 21-23, extend the second July nonscholastic evaluation period to Thursday, July 17, establish July evaluation periods begin 8 a.m. local time on Thursdays and end at 6 p.m. local time on Sundays, create a four-day quiet period the last Monday-Thursday period of July, and extend the current August dead period by two days to include August 4 and 5.

b. NCAA Division I Women's Basketball Oversight Committee.

- (1) **Change to Recruiting Calendar.** (Fairness/Well-Being/Operational) The Women's Basketball Oversight Committee <u>amended</u> women's basketball recruiting calendar for July 2025 due to the cancellation of the 2025 College Basketball Academy. The previous evaluation period and dead period related to the College Basketball Academy were changed to a quiet period July 24-29.
- (2) Interim Policy and Legislative Priorities. (Fairness/Well-Being/ Operational) The committee developed and finalized a proposed list of policy and legislative items for the group to focus on through July 31 based on the interim filters provided by the Division I Board of Directors. The list of items is subject to approval by the NCAA Division I Council Coordination Committee.

c. Division I Men's and Women's Basketball Oversight Committees.

• **Multiple Team Event Comprehensive Review.** (Fairness/Well-Being/Operational) The Men's and Women's Basketball Oversight Committees continued discussions and a comprehensive review of multiple team event legislation. Both committees separately discussed potential concepts that would change current multiple team event legislation. The Men's Basketball Oversight Committee also considered changes to maximum contests legislation. The Women's Basketball Oversight Committee contemplated some guiding principles of the legislation to enhance the changes to the current legislation. The committees will continue to review concepts at their next meetings.

d. NCAA Division I Sports Oversight Committee.

(1) **Oversight Committee Legislative Pilot Authority.** (Operational) The council granted limited authority in specific bylaws to the Sports Oversight Committee to introduce and approve legislative proposals pursuant to the pilot legislative process, subject to the review of the Division I Council. The limited authority includes bylaws regarding sportsmanship and other ethical behaviors, conduct of athletics personnel (NCAA Bylaw 11), processes and procedures related to the administration of the regular season and championships (Bylaw 31), playing and practice seasons (Bylaw 17) and recruiting (Bylaw 13). The action is effective immediately.

Based on the recent merger of the former NCAA Division I Competition Oversight Committee and the NCAA Division I Student-Athlete Experience Committee into the Sports Oversight Committee, this action provides an opportunity to address issues more efficiently and with increased nimbleness. The same legislative authority has been held and exercised in the pilot process by the Men's and Women's Basketball Committees and the NCAA Division I Football Oversight Committees.

- (2) **Committee Priorities.** (Fairness/Well-Being/Operational) The Sports Oversight Committee used its inaugural in-person meeting to discuss the committee's charge, duties and responsibilities. The committee provided feedback on aspects of its policies and procedures. In addition, nomination requests have been sent to the membership and it is anticipated that the committee will be fully populated by June 2025. During its next meeting, the committee will discuss potential sport groupings for subcommittee organization.
- e. NCAA Division I Legislative Committee.
 - Interim Policy and Legislative Priorities. (Fairness/Well-Being/ Operational) The Legislative Committee discussed initiatives and processes that will be reviewed by the Council Coordination Committee for potential work during the interim period pursuant to the Board of Directors priority filters. Work related to legislation approved by the Council Coordination Committee for introduction into the June 2025 legislative cycle, the new Division I periodic compliance review membership requirement, and potential work to develop legislative principles and/or processes to support the new Division I governance structure will be submitted to the Coordination Committee for review.

f. NCAA Division I Strategic Vision and Planning Committee.

- (1) **Request for Review of Division I Membership Requirements.** (Fairness/Well-Being/Operational) The Strategic Vision and Planning Committee received an update on the comprehensive review of membership requirements. Subject to Coordination Committee approval, the committee recommended that a focused review of Division I membership requirements be conducted.
- (2) Health and Safety Attestations. (Fairness/Well-Being/Operational) The committee determined the signatories for health and safety attestations to include an institution's president/chancellor, director of athletics and an athletics health care administrator. The signatories for the remaining core guarantees attestations will be the institution's president/chancellor and the director of athletics.
- 7. **Report from the NCAA Division I Student-Athlete Advisory Committee.** (Fairness/Well-Being/Operational) The council received a report from the Student-Athlete Advisory Committee related to the committee's charge to increase representation at the conference level and remain active in discussions surrounding the future of college athletics.
- 8. **Report from the NCAA Division I Committee on Academics.** The council received a report from the Committee on Academics that included the following informational items.
 - a. Development of the NCAA Division I Transfer Academic Progress Rates and the Graduation Passport. (Academics/Operational) The Committee on Academics continued its work on the academic impact of transferring and the operationalization of the Transfer Academic Progress Rate and the NCAA Division I Graduation Passport. These items will be used to inform future academic policy and/or legislative recommendations.
 - **b. Review of Baseball Legislation Referral.** (Academics) The Committee on Academics received and reviewed a referral from the comprehensive review of baseball legislation regarding good academic standing.
 - c. Review of Proposal No. 2024-66. (Academics/Fairness/Operational). The Committee on Academics reviewed and recommended changes to Proposal No. 2024-66 to further refine and specify the goal of the proposal. The committee recommended the proposal include an academic review in the first year of the process and specific academic benchmarks for conference invitation prior to an institution becoming an active Division I member.
- **9. Report of the November Council Meeting.** (Operational) The council approved the report of its November 7 meeting.
