



**REPORT OF THE
NCAA DIVISION I COUNCIL
JUNE 14-15, 2022, MEETING**

In an effort to connect NCAA Division I Council items to the NCAA pillars of academics, fairness and well-being, items included in this report have an identifying pillar. There is an additional pillar, operational, that is used to denote items that relate to maintaining a stable and efficient Division I.

KEY ITEMS.

- **Legislative Actions.** (Academics/Fairness/Well-Being/Operational) The Division I Council took the legislative actions listed below. The Council's legislative actions are detailed in Attachment A and voting results are available in Attachment B.

[Note: Standard review legislation (other than noncontroversial legislation) adopted by the Council is not final until the conclusion of the next NCAA Division I Board of Directors meeting on June 30.]

- a. **Adoption of Pending Proposals in the 2021-22 Legislative Cycle.** The Council adopted four proposals from the 2021-22 legislative cycle that were previously tabled. (See Attachment A for additional details.)
- b. **NCAA Division I Proposal No. 2019-90.** The Council defeated a motion to remove Proposal No. 2019-90 (Playing and Practice Seasons – Men's Soccer – Academic Year Playing and Practice Season Model) from the table for a vote.
- c. **Noncontroversial Legislation – Proposal No. 2022-15 Playing and Practice Seasons – Required Day Off – Civic Engagement – Exception and Policy Requirement.** At the recommendation of the NCAA Division I Student-Athlete Advisory Committee, the Council adopted noncontroversial legislation to establish an exception to the civic engagement legislation to permit a team participating in practice or competition during the segment of the playing season that concludes with the NCAA championship to engage in countable athletically related activities on the first Tuesday after the first Monday in November, provided student-athletes are given a day off from countable athletically related activities to participate in civic engagement activities and programming within 15 days before or after the first Tuesday after the first Monday in November. In addition, the institution is required to develop civic engagement policies, which must address opportunities available to student-athletes for civic engagement, through a collaborative process involving student-athletes, coaches and senior athletics department staff members to ensure student-athletes are provided adequate opportunities, resources and programming to participate in civic engagement activities.

ACTION ITEMS.

1. **Legislative Items.**

- **None.**

2. Nonlegislative Items.

a. Membership Reclassification Process Waivers. (Fairness/Operational)

- (1) **Recommendation.** That the Division I Board of Directors deny waiver submissions from five institutions requesting access to Division I championships and membership benefits before completing the reclassification process.
- (2) **Effective Date.** Immediate.
- (3) **Rationale.** At the recommendation of the NCAA Division I Strategic Vision and Planning Committee, the Council recommends that these waiver requests be denied. The Council expressed significant concerns about providing access to championships before the membership process is successfully completed, as doing so would in effect be changing the rules in the middle of the process and thus disadvantaging those institutions that have completed the process as established. The Council also noted that the NCAA Division I Transformation Committee is reviewing membership requirements, and that any changes to the reclassification process should be addressed legislatively rather than through waivers.
- (4) **Estimated Budget Impact.** None.
- (5) **Student-Athlete Impact.** Although the Council is sympathetic to the impact of the reclassification process on student-athletes at the impacted institutions, providing championships access to the institutions before the process is complete would impact championship participation opportunities for student-athletes from active Division I institutions.

b. Championships Budget. (Fairness/Well-Being/Operational)

- (1) **Recommendation.** That the Board of Directors review the NCAA budget and consider future adjustments to prioritize the funding of championships as a key function of the NCAA.
- (2) **Effective Date.** Immediate.
- (3) **Rationale.** At the recommendation of the NCAA Division I Competition Oversight Committee, the Council recommended a reevaluation of the NCAA budget to prioritize Division I championships in future funding decisions. The Competition Oversight Committee and its predecessors in the Division I governance structure have consistently encountered challenges in aligning championships operations with NCAA shared values due to budget

constraints. The Council agreed that the allocations to championships should reflect a more contemporary commitment to ensuring student-athletes and institutions alike are more fully supported while participating in the pinnacle of their athletics experience.

- (4) Estimated Budget Impact. To be determined based on the evaluation.
- (5) Student-Athlete Impact. Division I student-athletes would be the primary beneficiaries of postseason experiences that are funded to ensure access to championships, bracket integrity and quality of competition.

INFORMATIONAL ITEMS.

- 1. **NCAA Division I Transformation Committee Update.** (Fairness/Well-Being/Operational) The Council received a report on the work of the Transformation Committee, including an overview of membership survey data and status updates on transfers, decentralization and modernization, financial aid, and infractions concepts. - 2. **Gender Equity Update.** (Fairness/Well-Being/Operational) The Council received information on the ongoing gender equity review, including an update on the real-time audit and assessment that occurred during the 2022 NCAA Division I Men's and Women's Basketball Championships. Results from the audit will be presented to the NCAA Division I Men's and Women's Basketball Committees on June 30. Additional information will be provided to the membership and posted on [ncaa.org](#). The Council will receive a report during its July 20 meeting and a series of membership webinars are planned for July.
- 3. **NCAA Division I Council Working Group on Name, Image and Likeness Update.** (Fairness/Well-Being/Operational) The Council received an update on the work of the Council Working Group on Name, Image and Likeness, including updates from the NCAA enforcement and academic and membership affairs staff. The group will continue its work and will provide updates during future Council meetings.
- 4. **Reports from Council Committees.**
 - a. **NCAA Division I Men's Basketball Oversight Committee.** (Fairness/Well-Being/Operational) The Council received the following items as information:
 - 1) **NBA Pre-Draft Status Update.** The Men's Basketball Oversight Committee engaged in a discussion with Garth Glissman, vice president of NBA Basketball Operations, regarding the NBA Pre-Draft Process and noted the following highlights:

- a) Over the past three years, an average of 142 institutions and 30 Division I conferences had at least one player apply to receive feedback from the NBA's Undergraduate Advisory Committee (UAC).
- b) Since 2018, student-athletes seeking feedback from the UAC has steadily increased, while the number of undrafted underclassmen has declined.
 - i. The number of undrafted underclassmen has declined by 30% over the last two years.
 - ii. The number of undrafted freshman and sophomores is projected to be 10 or fewer in 2022.
- c) Among UAC applicants in 2022, 90% received feedback indicating they could go undrafted (75% whose feedback indicated every NBA team agreed they would go undrafted).
- d) Data suggest that the NCAA requirement for student-athletes to seek UAC feedback before declaring for the NBA Draft is helping connect players/families directly with the NBA about their professional readiness and rely less on guidance from outside sources.

The discussion also focused on NCAA student-athletes competing with noncollege players for an opportunity to be drafted. Although college basketball continues to be the primary pathway to the NBA, college student-athletes must increasingly compete with international players and players from nontraditional pathways (e.g., Overtime Elite and G-League) for spots in the NBA. Twenty-two percent of players selected in the past 10 NBA drafts never played college basketball (most played on a pro team outside the U.S. before entering the draft).

Following are among the key takeaways from the discussion:

- e) The pandemic, transfers, and the emergence of name, image and likeness opportunities have added complexity to the draft process and more options for student-athletes.
- f) Student-athletes testing the waters are increasingly disconnected from college coaches.

- g) Coaches must contend for influence with current and future student-athletes against individuals who are not regulated by NCAA rules (e.g., agents, other professional leagues).
- h) NIL may be more lucrative than non-NBA professional contracts and has incentivized some student-athletes to return to college.
- i) NIL has also made space more attractive to agents.
- j) More student-athletes are simultaneously in the transfer portal and testing the waters.
- k) The number of NBA Draft picks from noncollege pathways has increased.

2) **Education and Engagement Initiatives.** The Men's Basketball Oversight Committee received an update on efforts to educate men's basketball prospects and their families on the benefits of college basketball participation and rules/regulations. Educational sessions and/or modules occurred in conjunction with the 2019 College Basketball Academy, the USA Basketball Junior National Team, scholastic events in June, the NBPA Top 100 Camp, the NBA Academies, and nonscholastic events. It is most effective to deliver in-person education to potential student-athletes and their families to build relationships and promote engagement. In-person education can be supplemented with ongoing virtual educational modules.

3) **College Basketball Academy Update.** The Men's Basketball Oversight Committee reaffirmed its commitment to the College Basketball Academy, noting that the Transformation Committee work and recruiting calendar changes are not expected to impact the College Basketball Academy. An increasingly complex and competitive environment (e.g., agents, Transfer Portal, NIL, Overtime Elite, G-League Ignite) creates a need for the NCAA to have its own platform to share benefits of college basketball participation and provide opportunities to educate and engage with prospects and their families. Additional reasons to support the College Basketball Academy include:

- a) It reflects an investment in the sport that accounts for the largest revenue distribution to the membership.
- b) It helps ensure viability of the game and the future success of the NCAA tournament.

- c) Various lessons were learned from the 2019 College Basketball Academy and the Men's Basketball Oversight Committee recommended modifications for a future College Basketball Academy to attract more elite players and strengthen collaboration with NBA, NBPA and USA Basketball.
- d) Data gathered from 2019 indicated strong positive feedback on the education provided to participants and parents.

Regarding next steps, the Men's Basketball Oversight Committee charged the staff with determining the feasibility of conducting a college basketball academy for 2023 and beyond. The Men's Basketball Oversight Committee will continue tracking on the NCAA Division I Women's Basketball Oversight Committee's review of a potential women's basketball academy or similar event/initiative.

- 4) **Senior Minority Administrator Update (Proposal No. 2021-16).** The Men's Basketball Oversight Committee continued its review of the proposal it developed in collaboration with the Division I Women's Basketball Oversight Committee and the NCAA Minority Opportunities and Interests Committee to address the lack of ethnic minorities in Division I athletics leadership positions and to better reflect and serve increasingly diverse student-athlete populations. The Men's Basketball Oversight Committee previously referred review of the proposal to the Minority Opportunities and Interests Committee, which is best positioned to improve the concept to positively impact ethnic minority student-athletes and administrators and garner widespread support from the membership. The NCAA Division I Legislative Committee supported the referral. The Minority Opportunities and Interests Committee will discuss the referral during its July meeting, which will include Men's Basketball Oversight Committee members. The Men's Basketball Oversight Committee will receive regular updates from Minority Opportunities and Interests Committee on the timeline and progress on the concept.

- b. **Women's Basketball Oversight Committee.** (Fairness/Well-Being/Operational)
The Council received the following items as information:

- 1) **Gender Equity Issues.** The Women's Basketball Oversight Committee continues discussing recommendations from the Phase I Gender Equity Report, including a College Basketball Academy for girls' basketball and enhanced non-NCAA postseason opportunities for women's basketball student-athletes.

- 2) **Strategic Initiatives.** The Women's Basketball Oversight Committee also continues to review strategic initiatives, including championship growth, development and priorities, and positioning for impending broadcast rights opportunities. The committee also is exploring leadership development programming for women's basketball, which includes programming/education for student-athletes, coaches and administrators, the inaugural Champion Forum for women's basketball, and the inaugural Elite Student-Athlete Symposium for student-athletes who are likely to experience success in professional basketball.
- 3) **State of the Game.** The Women's Basketball Oversight Committee continues to collaborate with various women's basketball constituents regarding the state of the game and how it can be improved.

c. **Competition Oversight Committee.** (Fairness/Well-Being/Operational) The Council received the following items as information:

- 1) **Budget Priorities.** As part of its budget review (which included the recommendation to the Board of Directors in Action Item 2-b above), the Competition Oversight Committee revisited its primary focus areas used in guiding decisions (student-athlete experience; equity, diversity and inclusion; competitive fairness; student-athlete health and well-being; and fiscal planning) and added within them the following priorities to help determine the appropriate allocation of funding to support Division I championships.
 - a) Bracket integrity (unanimously identified as the most important priority);
 - b) Quality of competition;
 - c) Funding championships as fully as possible to reduce the financial burden on the membership;
 - d) Access and participation (e.g., field size, automatic qualification);
 - e) Championships format; and
 - f) Exposure/broadcast opportunities.
- 2) **Championships Seeding Pilot.** To reflect its stated priority on bracket integrity, the Competition Oversight Committee approved a one-year pilot for women's soccer and women's volleyball (which currently seed only 25% of the brackets) to assign seeds (1-8) to 50% of the bracket for the 2022

championships. The pilot will better achieve bracket integrity and enhance the student-athlete experience. The Division I membership and various sport committees have consistently asked for increased seeding to allow the bracket to reflect a true national championship rather than rely so heavily on geographic proximity for preliminary-round matchups. Conducting the pilot for these two fall sports will provide the data needed to make informed funding decisions for the allocation of funds for the 2023-24 year and beyond. The budget impact will be determined based on how many additional flights the increased seeding creates. Existing Division I championships allocations will fund the pilot. The committee will define bracketing principles to be applied in the pilot during its July meeting.

3) **Sport Committee Budget Items.** The Competition Oversight Committee reviewed various budget requests from sport committees for the coming year and discussed how best to accommodate them as well as needs that have arisen as a result of the gender equity review. A 3.9% inflationary increase will be assigned for Division I championship operating expenses to manage the various operational requests by sport. Requests that have a gender equity impact will be supported by funds set aside for that purpose. Accordingly, the following budget requests from sport committees were approved:

a) **Women's Bowling.**

- i. Increase field size to 17 and add one play-in match to accommodate increase in number of automatic qualifiers from eight to nine.
- ii. Increase the number of officials at regionals from one to two and increase the number of officials at the finals site from two to three.

b) **Field Hockey.**

- i. Move the two opening round games to the first and second round sites.
- ii. Require hosts to have video review for all rounds of the championship and add a video review umpire to all preliminary round games.

c) **Men's Soccer.**

- i. Increase squad size from 21 to 22 with corresponding increase to the travel party from 27 to 28.

- Matches current size for women's soccer.

- ii. Add a day of rest at final site (two days between semis and final).

d) Women's Soccer.

- Add a day of rest at final site (two days between semis and final).

d. NCAA Division I Football Oversight Committee. (Fairness/Well-Being/Operational) The Council received the following items as information:

1) Feedback for Transformation Committee. The Football Oversight Committee provided feedback as requested by the Transformation Committee on the following topics/concepts:

a) Recruiting Periods and Calendars. The Football Oversight Committee supports Model B but recommended an amendment to include quiet periods for both the Football Bowl Subdivision and the NCAA Football Championship Subdivision. Including quiet periods allows coaches more time to focus on current student-athletes by limiting off-campus recruiting activities and preserves prospective student-athletes' opportunities to visit campuses. Separate recruiting calendars are recommended for FBS and FCS due to the satisfaction with the current summer camps and clinics model and the differences in postseasons.

b) Recruiting-Person Days. The Football Oversight Committee notes the importance of determining the permissible number of coaches who may recruit off campus to determine the appropriate number of in-person recruiting days. The committee supports reducing the total number of evaluation days during the fall and supports reducing the number of evaluations per prospective student-athlete during the spring from two to one.

c) Financial Aid. The Football Oversight Committee discussed the concept that would focus national rules on the number of student-athletes participating in countable athletically related activities during the playing season and acknowledged that 110 participants, the current preseason participant limit, accounts for the number of

student-athletes needed for practice. The committee also discussed the possibility of FBS and FCS with having different numbers and did not reach consensus on whether to use one number or different numbers for each subdivision. Finally, the committee discussed an approach that would require a student-athlete to be a counter during an academic year only while receiving an athletics scholarship.

2) **Strategic Priorities.** The Football Oversight Committee continues its review of the appropriate governance of Division I football, as well as playing rules, with a continued emphasis on health and safety. The committee engaged with its NCAA Division I Football Oversight Committee Student-Athlete Connection Group about benefits provided to student-athletes, and the committee continues monitoring student-athlete transfer data and trends, including impacts on football's recruiting model, as well as the impact of recent changes to the playing season.

e. **NCAA Division I Student-Athlete Experience Committee.** (Fairness/Well-Being/Operational) The Council received the following item as information:

- **Volleyball proposals.** The Student-Athlete Experience Committee discussed two requests from the American Volleyball Coaches Association:
 - Approve a blanket waiver of the application of Proposal No. 2019-82 (Playing and Practice Seasons – Preseason Practice – Cross Country, Field Hockey, Soccer, Women's Volleyball and Men's Water Polo); and
 - Remove Proposal No. 2019-81 (Playing and Practice Seasons – Summer Athletics Activities – Women's Soccer and Women's Volleyball) from the table and vote on permitting summer access in women's volleyball and women's soccer.

The committee recommended (and the Council supported) that no action be taken on the requests. The committee noted the benefits for all volleyball programs to start on a uniform date. Although some programs may lose a small number of days of practice under the new legislation, this application was a known consequence, the proposal was under consideration for two years and it was adopted with unanimous support. Regarding potential consideration of Proposal No. 2019-81, the committee noted that issues related to when fall sports should begin preseason practice and whether additional sports should have the opportunity to engage in required summer athletics activities should be addressed through the work of the Transformation Committee with the support of the NCAA Division I Legislative Committee Modernization of the Rules Subcommittee.

f. **Strategic Vision and Planning Committee.** (Operational) The Council received the following items as information:

- 1) **NCAA Board of Governors Nondiscrimination Policy.** The Strategic Vision and Planning Committee engaged with the staff liaisons to the Board of Governors regarding the recent decision to discontinue the nondiscrimination questionnaire for championship hosts. The committee plans to draft a memo to the newly constituted Board of Governors (effective August 1, 2022) regarding the importance of the NCAA approach and advocacy efforts related to equity, diversity and inclusion, especially as it relates to championship events.
- 2) **Revenue Distribution.** The Strategic Vision and Planning Committee discussed the philosophical questions the Transformation Committee will need to address related to revenue distribution. Revenue distribution policies will need to be reviewed to, at the very least, address equity concerns. A broader philosophical review of Division I's approach to revenue distribution would be wise as the Transformation Committee continues its work. Accordingly, the following questions were posed for the Transformation Committee to consider as it reviews the issue:
 - a) Should a review of revenue distribution be limited to equity considerations or is a more comprehensive review appropriate?
 - b) Should sport-specific athletics performance continue to be a focus of the calculation, or should the focus be broader/different?
 - c) What behaviors should be incentivized or disincentivized at the campus and conference levels?
 - d) What is the appropriate timing and/or phasing-in process for changes to revenue distribution?

5. **Report of the May 18 Council Videoconference.** The Council approved the report of its May 18 Council videoconference.
