



**REPORT OF THE
NCAA DIVISION I COUNCIL
OCTOBER 4-5, 2022, MEETING**

In an effort to connect NCAA Division I Council items to the NCAA pillars of academics, fairness and well-being, items included in this report have an identifying pillar. There is an additional pillar, operational, that is used to denote items that relate to maintaining a stable and efficient Division I.

KEY ITEMS.

- 1. Legislative Actions.** (Academics/Fairness/Well-Being/Operational) The Division I Council took the legislative actions listed below. (See Attachment for voting results.)
 - a. Girls' College Basketball Academy.** The Division I Council adopted NCAA Division I Proposal No. 2022-25 (Amateurism and Recruiting – Women's Basketball – NCAA Girls' College Basketball Academy) as noncontroversial legislation in women's basketball, effective immediately, to establish a Girls' College Basketball Academy and associated regulations and exceptions, as specified. The recommendation derives from the NCAA Phase I Gender Equity Review Report, with a focus on ensuring gender equity in participation opportunities. The first academy for girls will occur in summer 2023.
 - b. Spring Notification-of-Transfer Window Dates -- Football.** The Council adopted Proposal No. 2022-23 (Recruiting and Academic Eligibility – Football – Notification of Transfer – Spring Undergraduate Notification of Transfer Window) as noncontroversial legislation in football, effective immediately, to move the spring notification-of-transfer window from May 1-15 to April 15-30. The change in the spring window allows coaches and student-athletes to have athletics participation conversations after spring football and before the start of summer athletics activities, allowing student-athletes time to enter the NCAA Transfer Portal, evaluate opportunities at other institutions and arrive at a new institution before beginning summer courses and athletics activities.
 - c. Postgraduate Notification-of-Transfer Deadline.** The Council adopted Proposal No. 2022-24 (Recruiting and Academic Eligibility – Notification of Transfer – Postgraduate Participation at Another Institution) as noncontroversial legislation, effective immediately, to amend the notification-of-transfer deadline for a student-athlete who will participate as a postgraduate student at another institution. For fall and winter sports, a postgraduate transfer student-athlete must provide written notification of transfer to the institution by May 1, or the last date of the undergraduate transfer window, whichever occurs later. For spring sports, a postgraduate transfer student-athlete must provide written notification of transfer to the institution by July 1, or the last date of the undergraduate transfer window, whichever occurs later.

2. Nonlegislative Action.

- **NCAA Division I Women's Basketball Postseason Event.** (Fairness/Well-Being/Operational) The Council approved the creation of a 32-team postseason tournament for women's basketball with the format, operation and personnel to mirror the construct currently being used for the Men's National Invitation Tournament. The recommendation derives from the NCAA Phase I Gender Equity Review Report, with a focus on ensuring gender equity in participation opportunities supported by the NCAA. The NCAA Division I Board of Directors Finance Committee must approve funding for the event before the establishment of the event is finalized.

3. Key Discussion Items.

- a. **Four-Year Undergraduate Transfer Waiver Process and Guidelines.** (Fairness/Well-Being/Operational) The Council discussed the transfer waiver framework and guidelines consistent with the charge from the NCAA Division I Board of Directors. The Council affirmed support for the following as part of the Council's review of the transfer waiver framework and guidelines to be used to evaluate waiver requests submitted for eligibility occurring during the 2023-24 academic year:
- 1) Maintain the current postgraduate transfer waiver framework pending the NCAA Division I Committee on Academics' broader review of postgraduate participation;
 - 2) Maintain the current Education-Impacting Disability (EID) guideline;
 - 3) Update the current guidelines to better account for a direct link between the physical and mental health assertions that were not addressed at the previous institution and necessitated the student-athlete's transfer;
 - 4) Establish a guideline(s) regarding exigent circumstances outside the student-athlete's control at a future meeting; and
 - 5) Preclude use of the No Participation Opportunity guideline for undergraduate student-athletes who have previously transferred from another four-year institution (e.g., 4-4-4 transfer), noting that this guideline does not align with the recently adopted student-athlete scholarship protections or the avenues for relief established by the Board of Directors.

The Council charged the NCAA Division I Council Coordination Committee with creating a panel to assist the Council with implementation of undergraduate four-year transfer waiver framework and guidelines.

- b. NCAA Division I Council Working Group on Name, Image and Likeness Update.** (Fairness/Well-Being/Operational) The Council received an update on the latest issues under discussion by the Council Working Group on Name, Image and Likeness. The Council provided feedback on the working group's initial report related to institutional involvement in student-athletes' NIL activities. The Council also discussed the working group's recommendation for a standard of review for alleged NCAA rules violations related to NIL activities. The working group will finalize its recommendations in anticipation of presenting the recommendations to the Board of Directors during its October 25-26 meeting.

ACTION ITEMS.

- None.

INFORMATIONAL ITEMS.

- 1. NCAA Division I Transformation Committee Update.** (Fairness/Well-Being/Operational) The Council received an update on the work of the Transformation Committee. Additional information and reports from Transformation Committee meetings are available [here](#).
- 2. Annual Review of Council Policies and Procedures.** (Operational) The Council reviewed and ratified the following changes to its policies and procedures made throughout the previous year:

 - a. Use of Alternates for Council Members and Non-Council Members Who Represent Football Bowl Subdivision Conferences on the NCAA Division I Football Oversight Committee.** A Football Bowl Subdivision conference may designate an alternate to participate in Football Oversight Committee meetings when its representative cannot attend due to extraordinary circumstances (e.g., family emergency, medical situation) or the representative has resigned from the committee and the replacement process is in progress. *(Note: The NCAA Division I Football Oversight Committee Administrative Committee reviewed the policy and recommended its approval by the Council.)*
 - b. Meeting Frequency and Meeting Materials.** The Council shall generally hold three in-person meetings each fiscal year. The meetings are to be conducted in October, January and June. The Council shall also hold videoconferences as determined by the Council chair. Meeting materials will be posted to the NCAA Committee Zone seven days before the date of a meeting and, for Council videoconferences, every effort will be made to avoid scheduling standing committee meetings during the seven days before a Council meeting. In addition, supplemental postings of meeting materials will not occur unless necessitated by extenuating

circumstances. The materials will highlight anticipated action items for ease of review.

- c. **Responsibilities of Council Chair and Vice Chair.** The Council chair may delegate the responsibility to lead the NCAA Division I Council Coordination Committee meetings to the vice chair.
- d. **Use of Alternatives for Council Members.** For the Conference Commissioners Association representatives, only a conference commissioner (as opposed to another conference staff member) from the same group of conferences may serve as an alternate for a Council representative of a conference group who is unable to attend a Council meeting.

3. Reports from Council Committees.

- a. **NCAA Division I Men's Basketball Oversight Committee.** The Council received the following as information:
 - 1) **Boys' College Basketball Academy.** (Well-Being/Operational) The Boys' College Basketball Academy will occur July 25-30, 2023. The Men's Basketball Oversight Committee will oversee logistics and operations for the event and will receive regular updates from NCAA men's basketball staff. The committee also will develop an assessment tool to measure the success of the academy.
 - 2) **Summer Basketball.** (Well-Being/Operational) The committee will seek Council Coordination Committee approval to form a working group that will study methods to enhance the relevancy of men's basketball in the summer.
 - 3) **Notification of Transfer Window.** (Fairness/Well-Being/Operational) The committee will continue to discuss its transfer window during an upcoming meeting to determine if an adjustment is appropriate. The committee expressed initial support for a May 1 deadline consistent with previous Men's Basketball Oversight Committee and National Association of Basketball Coaches feedback. The committee noted that the window would open in early March, which will be prior to the conclusion of the regular season and conference tournaments for some teams. The committee also discussed the possibility of a December window for midyear transfers and asked the NABC to gather feedback for further committee consideration.
 - 4) **NBA Draft.** (Well-Being/Operational) The committee noted that the NBA's age limit to enter the NBA Draft could change from 19 to 18 years old. The committee began discussing the impact of a potential change to the NBA Draft on current legislation, including but not limited to: Use of NCAA-

certified agents by elite seniors. (Effective if NBA Draft age limit is lowered to 18 years old.) Opportunity for NBA Draft Combine invitees to remain in NBA Draft and retain NCAA eligibility if not drafted. (Effective only if NBA/NBPA free agency rule is amended.) The committee directed staff to share the current application of rules with the NBA and the NBPA and will continue to discuss the topic at upcoming meetings.

- 5) **Multiple-Team Events (MTEs).** (Well-Being/Operational) Legislation governing men's basketball multiple-team events was changed in April 2020. As a result of COVID-19, numerous blanket waivers were approved for men's basketball multiple-team events during the 2020-21 and 2021-22 men's basketball seasons. Event operators provided feedback to NCAA staff requesting a "re-education" regarding the multiple-team event legislation for men's basketball stakeholders. Accordingly, the committee approved a multiple-team event re-education plan that will be implemented in 2023 for multiple-team event operators and schedulers, coaches, men's basketball conference contacts and compliance administrators.

- b. **NCAA Division I Women's Basketball Oversight Committee.** In addition to the actions cited in Key Items 1-a and 2 above, the Council received the following as information:

- 1) **Gender Equity Issues.** (Fairness/Well-Being/Operational) The committee continued discussing recommendations from the Phase I Gender Equity Report, including the application of gender equity to the NCAA's revenue-distribution program.
- 2) **Student-Athlete Engagement Group.** (Fairness/Well-Being/Operational) The committee reviewed enhancements to the engagement group related to the selection process and participation activities.
- 3) **Collaboration with the Division I Women's Basketball Committee.** (Fairness/Well-Being/Operational) The oversight committee noted the championship committee's continued discussion of an alternate weekend for the Women's Final Four and continued efforts to educate the women's basketball community about the selection process.
- 4) **Transfer Window for Women's Basketball.** (Fairness/Well-Being/Operational) The committee discussed the issue and asked its legislative subcommittee to develop models that are least disruptive to the regular season and the championship.

- c. **NCAA Division I Competition Oversight Committee.** The Council received the following as information:

- 1) **Transformation Committee Update/Discussion.** (Fairness/Well-Being/Operational) The committee was joined by Lynda Tealer, chair of the Transformation Committee's Championships Subgroup, to discuss efforts underway to enhance Division I championships. The committee reviewed the subgroup's guiding principles and noted a synergy with the committee's principles/priorities, which include bracket integrity, quality of competition, championship formats and access, and exposure and broadcast opportunities.
- 2) **Championship Field Size Increases.** (Fairness/Well-Being/Operational) The committee approved an increase to the number of teams that advance to the women's golf championships finals site, from 24 to 27, effective with the 2023 championships. The increase provides an additional 18 women's golf student-athletes with a championship finals experience and better aligns the percentage of teams advancing with that of men's golf. The committee also approved an increase to the number of teams that advance to the men's and women's cross country championships finals site, from 31 to 32 for each gender, effective with the 2023 championships. The field size for that championship has not expanded since 1998 and the sport has grown from 293 men's teams to 317, and 304 women's teams to 349. Also, adding one more team for each gender can be accommodated on the championship courses and aligns the field size with other team sports with brackets of 32, 64, etc.
- 3) **Tennis Championship Format Discussion.** (Fairness/Well-Being/Operational) The committee discussed a proposal from the NCAA Division I Men's and Women's Tennis Committee to move the singles and doubles portion of the tennis championships from the spring to the fall, effective in the 2024-25 academic year. The recommendation would modernize the tennis championships, clearly define the fall and spring seasons, and positively impact student-athlete health and safety by reducing the length of the current combined team and individual portion of the championships in the spring. The committee noted initial support for the proposal from the tennis community (ITA, USTA, coaches' survey). The committee will work with conference offices to review the proposal and seek more coaches' feedback to inform further committee discussions.
- 4) **Awards Discussion.** (Fairness/Well-Being/Operational) The committee discussed whether to award trophies to teams advancing to the final site, which would allow teams to celebrate in the moment of advancement. The committee generally supports this concept and asked for specific details of execution by sport that follow the main principles to: (1) award regional trophies on site in all sports with regionals/super regionals and a national championship trophy to the winner at the finals site; (2) all championships

would maintain champion and runner-up trophies; and (3) for sports with team standings based on a tally of individual performances, the top three places would be awarded. The committee agreed to review the details by sport at a future meeting before making a final determination.

d. **NCAA Division I Football Oversight Committee.** In addition to the action cited in Key Item 1-b above, the Council received the following as information:

- 1) **Comprehensive Recruiting Review Subgroup Update.** (Fairness/Well-Being/Operational) The Football Oversight Committee's Comprehensive Recruiting Review Subgroup provided an update on its work to review and revise its recommendations and its review of additional legislative changes to the football recruiting model. The subgroup will collaborate with conferences, including FBS representatives from the 365-Day College Football Calendar working group, to develop the football recruiting model moving forward. There will be additional opportunities to solicit membership feedback on a football recruiting model. Some minor adjustments to the current recruiting calendar that relate to the transfer windows to allow student-athletes and coaches adequate time to communicate before the 2022-23 windows open are likely to be recommended to the Council for action during its October 27 meeting.
- 2) **Role of Football in Division I.** (Fairness/Well-Being/Operational) The committee discussed the role of football in the Division I governance structure and noted that since its inception, the committee has worked to directly address issues with Division I football. The committee has provided leadership and flexibility while addressing key football issues (e.g., COVID-19, playing and practice seasons, etc.) to support both subdivisions in the best interests of the sport and football student-athletes. The committee will continue its communication efforts to promote conference/membership awareness of key issues and its work to appropriately incorporate additional perspectives in its work (e.g., conference commissioners/administrators, topical experts).

e. **NCAA Division I Legislative Committee.** The Council received the following as information:

- 1) **NCAA Division I Legislative Committee Modernization of the Rules Subcommittee Update.** The committee's Modernization of the Rules Subcommittee reviewed updated feedback from sport communities pertaining to personnel limits and recruiting calendars, recruiting person days and a uniform start date for recruiting activities. The subcommittee is on track to ask the Legislative Committee to recommend proposals in the

following areas to be introduced into the 2022-23 Council-governance legislative cycle during the Council's October 27 meeting:

- a) Increases to the countable coach limits based on removal of volunteer coach and graduate assistant coach designations.
- b) Possible additional adjustments to the countable coach limits based on sport-specific requests and supporting rationale.
- c) Modify official and unofficial visit legislation providing more flexibility to support prospective student-athletes and those accompanying prospects on visits to an institution's campus.
- d) Expand the opportunity for on-campus evaluations to all sports.

Based on a reevaluation of the overall concepts related to personnel and recruiting, information on possible changes to the governance structure, and specific feedback on recruiting calendars, recruiting person days and uniform start dates for recruiting, the subcommittee does not believe it is appropriate to propose comprehensive changes to recruiting calendars, recruiting person days and start dates at this time. The subcommittee will monitor ongoing developments (e.g., governance structure) and assess whether the modernization track should be used as avenue to advance sport-specific changes in these areas if requested by the specific sports. The subcommittee will continue to review current legislation based on the charge of the Transformation Committee to determine whether regulation is necessary in specific areas. The subcommittee will also continue to review other areas of legislation for opportunities to modernize it.

- 2) **Application of Proposal No. 2022-20.** (Fairness/Well-Being/Operational) The committee discussed how the newly adopted transfer legislation applies to four-year undergraduate transfers to determine whether any applications warrant further review. Discussion focused on several contexts related to implementation of the athletics aid accountability measures and the application of the notification of transfer windows. The committee will continue to examine these contexts, compile additional scenarios and determine if any warrant additional adjustments to the legislation and/or continued review.

f. **NCAA Division I Strategic Vision and Planning Committee.** The Council received the following as information:

- 1) **NCAA Committee on Competitive Safeguards and Medical Aspects of Sports Update.** (Well-Being/Operational) The committee reviewed and

provided feedback on a potential draft of health and safety priorities. The committee also considered a recommendation from CSMAS to remove the requirement that an institution shall submit its Concussion Safety Protocol to the Concussion Safety Protocol Committee each year. The committee recommends that the Council to discuss the recommendation at a future meeting, noting that the recommendation impacts an area of autonomy.

- 2) **United States Olympic and Paralympic Committee Sustainability Membership Category.** (Fairness/Well-Being/Operational) The committee continues to engage with the USOPC regarding a potential recommendation to establish a USOPC sustainability membership category that would provide sport-specific flexibility in low-sponsored Olympic sports. The committee noted that any recommendation would come in the next legislative cycle after the Transformation Committee has concluded its work.

- g. **NCAA Division I Student-Athlete Advisory Committee.** In addition to the action cited in Key Item 1-c above, the Council received the following as information:

- **Athletics Eligibility Model.** (Fairness/Well-Being/Operational) The Council discussed a five-year athletics eligibility model under consideration by the Student-Athlete Advisory Committee that would allow student-athletes to participate in five seasons of competition during a student-athlete's five-year period of eligibility. The Student-Athlete Advisory Committee noted this model may help student-athletes meet progress-toward-degree requirements and potentially allow for a student-athlete to complete multiple majors or degrees during their athletics eligibility. The Council noted a need for more data on the effect of the extra year of eligibility available to students through the COVID-19 waivers and impact on high school prospective student-athletes. In addition, the Council indicated a need for a comprehensive discussion about progress-toward-degree requirements and whether collegiate athletics participation should be primarily focused on the attainment of an undergraduate degree. The Student-Athlete Advisory Committee may request that the concept be introduced into the 2022-23 Council-Governance legislative cycle during the Council's October 27 meeting.

- h. **NCAA Division I Student-Athlete Experience Committee.** Per recommendations from the Student-Athlete Experience Committee, the Council took action and received information on the following items:

- 1) **Women's Beach Volleyball Dates of Competition.** (Fairness/Well-Being/Operational) The Council introduced legislation into the 2022-23 legislative cycle, to allow student-athletes in women's beach volleyball to

compete as individuals in up to four dates of competition during the nonchampionship segment of the playing season rather than counting fall dates as an institutional limit. The effective date of the proposal is August 1, 2023.

Rationale. Proposal No. 2021-28, adopted in May, modified the beach volleyball playing and practice season. The American Volleyball Coaches Association intended Proposal No. 2021-28 to also amend the limits on nonchampionship dates of competition to count like an individual sport. The recommended proposal, modeled after tennis, would allow student-athletes to compete in up to four pairs tournaments as individuals in the fall, rather than being limited by institutional dates of competition. This change would result in beach volleyball being treated as a “hybrid” in which the fall nonchampionship segment is based on individual dates and the spring championship segment is based on institutional dates. Allowing beach volleyball student-athletes to play in four individual pairs tournaments in the fall will provide a competitive experience that is similar in length and competition format to other sports. The proposal benefits both established beach volleyball teams with mostly beach-only student-athletes and institutions still growing their programs with minimal beach-only student-athletes.

- 2) **Standardized Delayed Enrollment Dates.** (Fairness/Well-Being/Operational) The Council introduced legislation into the 2022-23 legislative cycle to codify standardized delayed enrollment dates currently applied through the waiver process. A standard date (Oct. 1 for fall enrollees; March 1 for winter/spring enrollees) would be used to determine the end of a prospective student-athlete’s grace period under NCAA Division I Bylaw 12.8.3.2 (delayed enrollment – seasons of competition). The effective date of the proposal is August 1, 2023.

Rationale. Using a standard date is more flexible and consistent for all prospective student-athletes. This concept simplifies educational messaging and permits proactive guidance regarding when a prospective student-athlete should stop competing in order to avoid a delayed-enrollment condition, especially for international prospective student-athletes and prospective student-athletes who have not determined when they will enroll. Codifying existing waiver guidelines further promotes equitable application of delayed enrollment legislation.

- 3) **Softball Midyear Transfers.** The committee noted that it plans to recommend, during the Council’s October 27 videoconference, that the Council introduce legislation into the 2022-23 cycle to prohibit the immediate eligibility of softball student-athletes who transfer at midyear.

Existing legislation prevents midyear transfers from competing on two teams during the same academic year if the competition at the first school counts toward championship consideration. In baseball and softball, fall competition does not count toward championship consideration. Current legislation prohibits midyear transfers in baseball from competing in the spring, regardless of fall participation. Softball seeks the same application.

- 4. Report of the September 21 Council Videoconference.** The Council approved the report of its September 21 videoconference.
