NCAA DIVISION I ADMINISTRATIVE COMMITTEE
SEPTEMBER 17, 2025, VIDEOCONFERENCE**

KEY ITEM.

- **NCAA Division I Proposal No. 2025-26 Recruiting – Notification of Transfer – Football – Postgraduate and April 16-25 Undergraduate Windows.** The NCAA Division I Administrative Committee adopted [Proposal No. 2025-26](#) as emergency legislation, effective immediately, in football, to align the notification of transfer window for postgraduate student-athletes with the winter notification of transfer window for undergraduate student-athletes and to eliminate the April 16-25 undergraduate notification of transfer window. INFORMATIONAL ITEMS.

1. **Football Notification of Transfer Window -- Referral to NCAA Division I Football Oversight Committees.** The Administrative Committee referred the following items for further review and refinement by the Football Oversight Committees for consideration by the Administrative Committee during its October 7-8, 2025, meeting:
 - a. Timing and duration of the one winter notification of transfer window for undergraduate and postgraduate student-athletes;
 - b. Timing and duration of the head coach departure exception; and
 - c. Application of the winter notification of transfer window to differing institutional academic calendars.
2. **Additional Football Oversight Committees Recommendations.** During its October 7-8 meeting, the Administrative Committee will consider the recommendations from the Football Oversight Committees to modify the Football Bowl Subdivision recruiting calendar to extend the December dead period, to adjust the timing of the written offers of aid or settlement-related benefits before the signing date and apply the contact prohibition to signed settlement-related benefits agreements or financial aid agreements, whichever occurs first.
