

REPORT OF THE NCAA DIVISION I FOOTBALL OVERSIGHT COMMITTEE JANUARY 21, 2021, VIDEOCONFERENCE

ACTION ITEMS.

• NCAA Division I Council Vote on Proposal No. 2019-25 (Individual Associated with a Prospective Student-Athlete). The NCAA Football Oversight Committee requested that the Division I Council remove Proposal No. 2019-25 from the table and adopt it for FBS football. In the interim, the Football Oversight Committee recommended a blanket waiver to exempt sport-specific, noncoaching staff members in football who maintained contact with prospective student-athletes only while employed in the athletics department at a four-year institution. The Football Oversight Committee noted its support for Proposal No. 2019-25 before it was tabled in April 2020 as well as the virtual recruiting flexibility provided during the COVID-19 pandemic to permit sport-specific, noncoaching staff members to initiate virtual recruiting calls (e.g., telephone calls, video calls) to unsigned prospective student-athletes during the temporary recruiting dead period.

INFORMATIONAL ITEMS.

- Oversight Committee recommended a blanket waiver to permit an institution to initiate telephone calls at its discretion to any individual (or the individual's family members) beginning February 1 of the individual's junior year of high school through the conclusion of the COVID-19 recruiting dead period. The oversight committee noted the COVID-19 pandemic has had a particular impact on junior prospective student-athletes, who were unable to participate in camps and remain unable to participate in campus visits during the temporary recruiting dead period. Further, this blanket waiver would add those prospective student-athletes to the existing blanket waiver that permits an institutional coaching staff member to make telephone calls to prospective student-athletes (e.g., high school, two-year and four-year transfer student-athletes) at their discretion from May 11, 2020, through the conclusion of the COVID-19 recruiting dead period.
- 2. Review of the Football Oversight Committee's January 8 Report. The Football Oversight Committee reviewed and approved its January 8, 2021, videoconference report.
- 3. NCAA Division I Governance Update. Amanda Conklin, director of Division I governance, provided the Football Oversight Committee with a governance update involving the 2021 NCAA Convention, legislative proposals involving the one-time transfer exception and name, image and likeness, the infractions process and the creation of the NCAA Division I Board Infractions Process Committee. The update also noted the election of Football Oversight Committee chair Shane Lyons as the next chair of the Division I Council, effective June 2021.
- **4. NCAA Division I Football Student-Athlete Connection Group Update.** Ryan Cassidy provided the Football Oversight Committee with an update from the January 20

Student-Athlete Connection Group videoconference. The Student-Athlete Connection Group discussed recent agenda items from the Football Oversight Committee meetings, the status of legislative proposals involving the one-time transfer exception and name, image and likeness, student-athlete perspectives on the 2020-21 FBS and FCS regular seasons and transfer portal activity.

5. Issues Impacting COVID-19.

- Impact on Number of Participants for the 2021-22 Season. The Football Oversight Committee recommended a blanket waiver of the limit on number of participants legislation for the 2021-22 academic year to allow FBS and FCS programs to exclude student-athletes who return to the same institution for 2021-22 and would have exhausted eligibility during 2020-21 if not for COVID-19 relief (season of competition waiver or extension of eligibility) from the 110 student-athlete limit. The blanket waiver would apply to walk-on and scholarship student-athletes and may be applied at the institution's discretion.
- **6. Future Agenda Items.** The Football Oversight Committee discussed agenda items for future meetings, including a review of the recruiting model, spring practice and summer access. The Football Oversight Committee will review the spring practice legislation and discuss potential modifications at its next meeting.
