# REPORT OF THE NCAA DIVISION I FOOTBALL CHAMPIONSHIP SUBDIVISION OVERSIGHT COMMITTEE APRIL 14, 2025, VIDEOCONFERENCE

## **INFORMATIONAL ITEMS.**

- 1. Football Championship Subdivision Oversight Committee Legislative Priorities update.
  - a. **Transfer Windows and Related Topics Subgroup.** The committee received an update from the subgroup noting that the subgroup continues to pause its work due to the interrelationship between transfer windows, roster management, roster declaration and other elements of the football calendar (e.g., signing day, spring practice, summer activities, student-athlete discretionary time). Once recommendations from the Settlement Implementation Committee are available, the subgroup will have a clearer picture of what recommendations, if any, it may present to the NCAA Division I Football Bowl Committee (FBSOC) and FCSOC for consideration.
  - b. **FCS Maximum number of contests and first contest date.** In May, the committee anticipates requesting the Council introduce and adopt legislation in June 2025 via the expedited legislative process. The proposal would, beginning with the 2026 season, (1) Permit a maximum of 12 regular season contests; (2) Allow contests to begin no earlier than the Thursday 13 weeks prior to selection of the NCAA Division I Football Championship participants; and (3) Eliminate first contest date exceptions.
- 2. NCAA Football Rules Committee update. The committee received an update on proposed rules changes including the permissive use of coach-to-player helmet communication, injury timeouts, overtime timeouts, scrimmage kick formations and use of a "T" signal during kickoffs, among others. The proposed changes will be reviewed by the Playing Rules Oversight Panel at its April 16 meeting.
- 3. NCAA Division I Football Student-Athlete Connection Group update. The committee received an update on the March 16 FSACG videoconference, including engagement with the NCAA Division I Student-Athlete Advisory Committee about initiatives to increase student-athlete representation in Division I's future decision-making structure, the frequency and timing of notification of transfer windows and the head coach departure exception legislation. The FSACG's next videoconference is Sunday, April 27.
- **4. NCAA Division I Football Championship Committee update.** The FCSOC received an update on the work of the NCAA Division I Football Championship Committee.
- **5. NCAA legal issues update.** The committee received an update from the NCAA Office of Legal Affairs.
